BE IT ENACTED BY THE QUORUM COURT, COUNTY OF LOGAN, STATE OF ARKANSAS, AN ORDINANCE ENTITLED:

## "AN ORDINANCE AMENDING ORDINANCE 2025-15 BY AUTHORIZING THE PURCHASE OF JUROR MEALS"

WHEREAS, the Quorum Court of Logan County passed Ordinance 2025-15, authorizing the issuance and usage of purchase cards for the Logan County elected officials and his or her designee, and

WHEREAS, the Ordinance specifically excluded the purchase of meals from allowable expenditures with purchase cards, and

WHEREAS, the Quorum Court of Logan County hereby finds good cause to amend the above ordinance to allow the Circuit Clerk or her or his designee to use a county issued card to purchase meals for jurors.

#### NOW THEREFORE, BE IT ENACTED:

Section 1. The Quorum Court of Logan County hereby authorizes the use of a county issued card to purchase juror meals when necessary and at the discretion of the Logan County Circuit Clerk or her or his designee in cooperation with the presiding court. Ordinance 2025-15 is hereby amended accordingly and any and all other provisions related to the use and documentation of said cards shall apply as set forth in the above ordinance.

BE IT ENACTED BY THE QUORUM COURT, COUNTY OF LOGAN, STATE OF ARKANSAS, AN ORDINANCE ENTITLED:

"AN ORDINANCE AMENDING ORDINANCE 2009-42 BY ALLOWING LOGAN COUNTY EMPLOYEES TO DONATE UNUSED SICK LEAVE TO THE LOGAN COUNTY EMPLOYEE SICK LEAVE BANK"

NOW, THEREFORE BE IT ORDAINED:

**SECTION 1.** Ordinance 2009-42 created the Logan County Employee Sick Leave Bank and, in Section 3 of said Ordinance, the Quorum Court of Logan County authorized Logan County employees to donate unused annual leave and/or unused compensatory time to the employee sick leave bank for use under certain circumstances as set forth therein.

**SECTION 2.** The Quorum Court of Logan County hereby finds good cause to amend Ordinance 2009-42, Section 3 to allow Logan County employees the ability to donate unused annual sick leave to the Logan County Employee Sick Leave Bank, in addition to any unused annual leave and/or unused compensatory time. This policy shall also apply to any mention of the sick bank in any provision of the Logan County Personnel Policy. All other provisions related to the Logan County Employee Sick Leave Bank or Ordinance 2009-42, not in conflict herewith, shall remain in full force.

**SECTION 1.** Ordinance 2007-17 designated the Logan County Treasurer as the preparer of the tax books pursuant to A.C.A. § 26-28-102 and in compliance with Act 1218 of 2007. Pursuant to said provisions, the Quorum Court of this county may designate an appropriate county official to prepare the annual tax books.

**SECTION 2.** The Quorum Court of Logan County hereby acknowledges that the Logan County Collector, in accordance with Arkansas Law, has agreed to undertake the preparation of the tax books and hereby finds good cause to designate the Logan County Collector as preparer of the tax books in making the reports mandated by the above referenced laws and under the Rules of the Assessment Coordination Division of the Arkansas Department of Finance and Administration. Ordinance 2007-17, Section 4 is hereby amended accordingly. All other sections and provisions, not in conflict herewith, shall remain in full force
