ORDINANCE NO. 2025-

BE IT ENACTED BY THE QUORUM COURT, COUNTY OF LOGAN, STATE OF ARKANSAS, AN ORDINANCE ENTITLED:

"AN ORDINANCE APPROVING AND ADOPTING THE AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN THE COUNTY OF LOGAN AND THE CITY OF MAGAZINE REGARDING THE MAGAZINE POLICE DEPARTMENT"

WHEREAS, the Quorum Court adopted and approved an interlocal agreement between the County of Logan and the City of Magazine for law enforcement services, thereby creating the "Magazine Police Department" within the Logan County Sheriff's Office, and

WHEREAS, the agreement provided for the Magazine Police Chief and contemplated other parttime deputies within the Magazine Police Department, and

WHEREAS, the City of Magazine desires to create a new full-time deputy position within the Magazine Police Department, funded by the City of Magazine and subject to the terms of the amendment, and

WHEREAS, a copy of the proposed amendment to the interlocal agreement was provided to the County Clerk on the 31st day of July, 2025.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF LOGAN THAT:

Section 1: The Quorum Court hereby finds that the terms of the agreement, filed with the County Clerk, namely the "AMENDMENT TO THE LOGAN COUNTY/CITY OF MAGAZINE INTERLOCAL AGREEMENT", are acceptable and in proper form, as set forth in A.C.A. § 14-14-910.

Section 2: The Quorum Court finds good cause to approve the above-mentioned amendment to the interlocal agreement and finds that said agreement is a benefit to the County of Logan and authorizes and adopts said agreement.

AMENDMENT TO THE LOGAN COUNTY/CITY OF MAGAZINE INTERLOCAL AGREEMENT

THIS AMENDMENT is made pursuant to Arkansas Code Annotated 14-14-910 and 14-52-102, by and between the County of Logan, Arkansas (hereinafter referred to as the County), and the City of Magazine, Arkansas (hereinafter referred to as the City).

NOW, THEREFORE, that for the mutual obligations hereby created and the mutual benefits so derived, the parties agree as follows:

- (1) The County of Logan and the City of Magazine entered into an Interlocal Agreement on February 18, 2022, to serve the law enforcement needs for the City of Magazine. The terms of Interlocal Agreement are one (1) year beginning January 1st of each year and through December 31st of that same year and the agreement is automatically renewed for each successive year unless notice of termination is given by either party as set out herein. This Amendment to the Interlocal Agreement will be for the same terms and since this amendment will start after the first of the year, this Amendment will start on the date it is signed by the Magazine Mayor, County Judge, and County Sheriff and approved by the Magazine City Council and Logan County Quorum Court and will go through December 31, 2025, and will be automatically renewed afterwards as stated above.
- (2) The Interlocal Agreement is hereby amended to add a new full-time position. The City of Magazine agrees to pay for a full-time, patrol deputy-level Deputy Sheriff to serve as a patrol officer under the Magazine Police Chief/Sergeant. This position shall hereafter be called in this Agreement the "Magazine Deputy". The City shall provide sufficient revenues to the County, on a quarterly basis, whereby the salary, health insurance, retirement, workers' compensation, and other reasonably necessary personnel costs are funded for the Magazine Deputy. The salary will be in accordance with the Patrol Deputy pay scale of the Sheriff's Office in such a way that there

will be no salary advantage or disadvantage for the Magazine Deputy. If the County provides a pay increase to its Sheriff's Office Patrol Deputies, the City shall match the pay increase. The Magazine Deputy position shall be supervised within the Chain of Command of the Sheriff's Office and whose direct supervisor is the Magazine Sergeant. Since this position is a county employee position, the Magazine Deputy shall be subject to the Logan County Personnel Policy Manual and the Logan County Sheriff's Office Policy and Procedures Manual and will sign an acknowledgment of understanding for both manuals.

(3) If the Magazine Sergeant is unable to attend a City Council meeting, the Magazine Deputy will attend the meeting and update the City Council and Mayor of the Magazine Police Department's activities for the previous month.

IN WITNESS HERETO, Logan County, Arkansas, and the City of Magazine, Arkansas, have executed this document by their duly elected officers who are authorized to represent the respective parties hereto in assuring the rights and obligations set forth herein this _____ day of August, 2025.

LOGAN COUNTY/CITY OF MAGAZINE INTERLOCAL AGREEMENT

THIS AGREEMENT, is made pursuant to Arkansas Code Annotated 14-14-910 and 14-52-102, by and between the County of Logan, Arkansas (hereinafter referred to as the County), and the City of Magazine, Arkansas (hereinafter referred to as the City).

NOW, THEREFORE, that for the mutual obligations hereby created and the mutual benefits so derived, the parties agree as follows:

(1) It is the intent of the parties to create this Interlocal Agreement to serve the law enforcement needs for the City of Magazine. The terms of this agreement will be for one (1) year beginning January 1st of each year and through December 31st of that same year and will be automatically renewed for each successive year unless notice of termination is given by either party as set out herein. Since this contract will start after the first of the year, this contract will start on the date it is signed by the Magazine Mayor, County Judge, and County Sheriff and approved by the Magazine City Council and Logan County Quorum Court will go through December 31, 2022, and will be automatically renewed afterwards as stated above. The City and the County shall coordinate their efforts to provide for greater law enforcement protection for their citizens through the Interlocal Agreement. Either party may, by majority vote of its respective governing body, elect to modify or terminate this agreement. In order for this agreement to be modified, the governing bodies of both the City and the County must so indicate by a majority vote of their respective governing bodies. If the parties shall desire to terminate this agreement, the party or parties desiring to withdraw shall give the other party six (6) months written notification of their intent to withdraw. If either party wishes to terminate this agreement, the agreement will terminate at the end of the six (6) months-notice period. For a period within which this agreement shall exist, the governing bodies may amend the agreement as provided hereinafter in Paragraph 14.

- (2) In the event of the termination of this agreement, the parties shall each receive back their respective properties whether leased, rented, purchased or borrowed.
- (3) The area defined as the "City of Magazine" for purposes of this agreement shall be defined as the area within the city limits of Magazine, Arkansas, as set out in the current version of the City Map. It is further understood that, should the city limits of Magazine change, the area defined as Magazine shall simultaneously change to mirror the modified city limits. The Magazine area shall also include property owned by the City of Magazine which lies outside the city limits. The area defined as "County" for purposes of this agreement only shall be defined as all geographic areas within Logan County.
- (4) The personnel constituting the Magazine Police Department shall be under the direction, supervision, authority and control of the Sheriff of Logan County, Arkansas. The City shall, upon acceptance of this agreement, provide the funds and ordinances necessary to accomplish this agreement. In a like manner, the County, upon acceptance of this agreement, shall take all steps necessary for providing the funds and ordinances necessary for the enactment and enforcement of this agreement. Each party agrees to act in the utmost good faith and to take all steps necessary for providing the funds and ordinances necessary for the enforcement of the provisions and agreements contained herein.
- (5) The City agrees to pay for a full-time, Sergeant-level Deputy Sheriff to serve as the Magazine Police Chief and as the supervisor of the Magazine Police Department. This position shall hereafter be called in this Agreement the "Magazine Sergeant". The City shall provide sufficient revenues to the County, on a quarterly basis, whereby the salary, health insurance,

retirement, workers' compensation, and other reasonably necessary personnel costs are funded for the Magazine Sergeant. The salary will be in accordance with the Sergeant pay scale of the Sheriff's Office in such a way that there will be no salary advantage or disadvantage for the Magazine Sergeant. If the County provides a pay increase to its Sheriff's Office Sergeants, the City shall match the pay increase. The Magazine Sergeant position shall be supervised within the Chain of Command of the Sheriff's Office and whose direct supervisor is the Chief Deputy. Since this position is a county employee position, the Magazine Sergeant shall be subject to the Logan County Personnel Policy Manual and the Logan County Sheriff's Office Policy and Procedures Manual and will sign an acknowledgment of understanding for both manuals.

- (6) The Magazine Sergeant shall work directly with the Magazine City Mayor and the Magazine City Council in addressing the law enforcement needs of the City. The Magazine Sergeant will attend all City Council meetings to update the City Council and Mayor of the Magazine Police Department's activities for the previous month. If the Magazine Sergeant cannot attend the meeting, the Magazine Sergeant shall contact the Chief Deputy to have someone present.
- (7) The City also funds a part-time law enforcement position. This position will continue to be paid directly by the City but pursuant to this Agreement, this position shall become a part—time Deputy Sheriff and will be directly supervised by the Magazine Sergeant. This position shall also be supervised within the Chain of Command of the Sheriff's Office and shall be subject to the Logan County Sheriff's Office Policy and Procedures Manual and will sign an acknowledgment of understanding for the manual.
- (8) The composition of the Magazine Police Department, as to the number of personnel and their positions, will be approved on an annual basis by the Magazine City Council upon the advice and recommendation of the County Sheriff. The Sheriff shall make such recommendations

to the City Council on or before the first scheduled City Council meeting in October. Any new law enforcement officer positions added to the Magazine Police Department will become Deputy Sheriffs and will be directly supervised by the Magazine Sergeant. These positions will also be supervised within the Chain of Command of the Sheriff's Office. The members of the Magazine Police Department will continue to work out of the Magazine Police Department offices located within the Magazine City Hall.

- (9) When there is a vacancy within the Magazine Police Department, whether it be the Magazine Police Chief/Magazine Sergeant, or any positions within the Department, the Magazine Mayor and City Council will announce the position(s) and accept applications. The Mayor, City Council, and County Sheriff or his representative will then review the applications and choose which applicants to interview. Once the interview process is complete, the parties will discuss the applicant(s) and the City Council and Mayor will make their recommendation to the County Sheriff who will have final authority on who is hired for this position.
- (10) The City shall provide vehicles and equipment for the use of the Magazine Police Department. These vehicles and equipment shall remain property of the City. The County may also provide equipment for use by the Magazine Police Department and this equipment shall remain as property of the County. Uniform shirt and pants will be provided by the County and shall remain property of the County. The City shall provide other equipment including firearms, duty belt gear, bullet-resistant vest and carrier, radio, non-lethal weapons, coats, and other equipment.
- (11) The purchase of new vehicles will be considered by the City Council upon the advice and recommendation of the Sheriff or his representative. The use of these vehicles shall be for the Magazine Police Department. The City shall maintain all insurance costs as presently required by

the City. In the event of damage to any vehicles, the City Mayor shall be notified within three days of the damage. The City shall provide all revenues necessary for the repair and maintenance or replacement so required. The Magazine vehicles will be identified with Sheriff's Office graphics and will include "Magazine Police Department" on the sides and rear of the vehicle. The City shall obtain the gasoline for the City vehicles and provide general maintenance for the vehicles.

- (12) The members of the Magazine Police Department and their vehicles and equipment will be used in the area defined as the city limits of the City of Magazine unless an emergency or unusual circumstance requires their use away from the City. The Magazine officers must be requested by radio to leave the city limits unless the emergency is of such a nature (like an officer involved shooting or a large disaster) that time is of essence to assist at the scene. Any time a Magazine officer leaves the city limits to assist on a call, this shall be logged on the radio and once the need of assistance is complete, the Magazine officer will return to the City.
- (13) The revenues as presently derived from Magazine District Court fines shall continue to be given to the City and shall continue to be prosecuted in the same manner as was the case before this agreement. For example, should a misdemeanor citation be issued inside the corporate limits of the City, the City would retain all fines collected as a result thereof. The County in a like manner would retain all district court fines which resulted from arrests or citations within the County, but outside of the City limits.
- (14) This Agreement may be amended at any time by the majority vote of both parties. The party desiring to amend this agreement shall draft their proposed amendment and, after passage by their governing body, submit the proposed amendment to the other party, whereupon the party's governing body shall vote upon the proposed amendment. Should the amendment be

accepted by a majority of both parties, it will thereafter become a part and a parcel of this

Agreement. Should either party fail to approve a proposed amendment, it will have no force or

effect.

(15) There shall be an Interlocal Board created by the City and the County for the purpose

of effectuating this Agreement and coordinating the efforts necessary for carrying out this

Agreement. This Board shall consist of the Sheriff of the County, the Mayor of the City, and the

County Judge. The sole purpose of the Board shall be to carry out the purposes of the Agreement

and to coordinate the efforts of the parties that may arise from time to time. The Board shall meet

as needed and can be called as the need arises by the Mayor, the Sheriff, or the County Judge. The

Interlocal Board shall in no way be constructed to be a Civil Service Commission or Grievance

Committee and shall only serve for the effectuation and coordination of this Agreement.

(16) The various provisions and parts of this agreement are hereby declared to be severable

and if any section of part of a section, provision or part of a provision herein, is such holding shall

not invalidate or effect the remainder of this Agreement.

(17) This Agreement supersedes all previous agreement and amendments thereto that

relate to the Interlocal Agreement of Law Enforcement.

"AN ORDINANCE AMENDING ORDINANCE 2025-01 BY CREATING AND FUNDING POSTION NO. 19 AND BY DECREASING REVENUE AVAILABLE FOR APPROPRIATION AND APPROPRIATING SAME, COUNTY GENERAL FUND"

WHEREAS, the Logan County Quorum Court has approved and adopted the Amendment to the Logan County/City of Magazine Interlocal Agreement, which sets forth the terms of creating a full-time position within the Magazine Police Department, referred to as "Magazine Deputy" and funded quarterly from funds received from the City of Magazine.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF LOGAN THAT:

SECTION 1. Revenue available for appropriation is hereby decreased in the amount of \$28,780.02, County General Fund.

SECTION 2. Account Code 1000-0400-1001, Full-Time Salaries – **Position No. 19** – Magazine Deputy is hereby created and shall be funded for the remainder of 2025 in accordance with Section 3 and pursuant to the procedures set forth in the Logan County Personnel Policy and the criteria contemplated therein with a base annual salary of \$41,652.00, commensurate with a Logan County Full-Time Deputy Sheriff.

SECTION 3. Account Code 1000-0400-1001, Full-Time Salaries-Position No. 19 is hereby increased in the amount of \$20,826.00. Account Code 1000-0400-1006, Social Security Matching is hereby increased in the amount of \$1,440.84; Account Code 1000-0400-1007, Retirement Matching is hereby increased in the amount of \$3,190.62; Account Code 1000-0400-1009, Insurance is hereby increased in the amount of \$3,279.00; Account Code 1000-0400-1011, Unemployment Compensation is hereby increased in the amount of \$168.00, and Account Code 1000-0400-1010, Workers Compensation Insurance is hereby increased in the amount of \$330.96.

SECTION 4. The appropriations set forth herein are contingent on the approval of above-mentioned Amendment to the Logan County/City of Magazine Interlocal Agreement and approval of funding by the Magazine City Counsel. In the event that the City of Magazine fails to pass said Agreement, all sections herein shall be null and void.

"AN ORDINANCE AMENDING ORDINANCE NO. 2025-1, TO RECEIVE REIMBURSEMENT FUNDS AND APPROPRIATE THE SAME, AND FOR OTHER PURPOSES"

WHEREAS, Logan County has been awarded a grant to assist in the renovation of the steps for the Logan County Courthouse in Paris, Arkansas in the amount of \$21,153.00 and the same funds have been received by Logan County and should be appropriated to County Buildings Fund, Other Services and Charges.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF LOGAN COUNTY, ARKANSAS:

<u>Section 1</u>. The Quorum Court of Logan County hereby acknowledges the receipt of unanticipated funds in the amount of \$21,153.00 into County General Fund.
