WHEREAS, the Logan County Sheriff's Office has custody of a juvenile defendant and, as a result of regulations concerning the incarceration of juveniles, is placed in a facility outside of Logan County.

WHEREAS, Logan County is incurring daily expenses associated with the detention of said juvenile, necessitating the appropriation of additional funds to the Logan County Detention Center budget and anticipating the need for said detention through the end of 2025, the Quorum Court hereby finds good cause to appropriate funds as follows.

SECTION 1. The Quorum Court hereby amends Ordinance 2025-1 by decreasing the amount available for appropriation in Fund 3405, ½ Cent Sales Tax Detention Center Fund, unappropriated, in the amount of \$25,300.00 and appropriating the same.

SECTION 2. Fund 3017-0418-3105 Other Services and Charges, County Detention Center Fund is hereby increased in the amount of \$25,300.00.
