

## California *de jure* Declaration of Independence



**We, the People,** of California *de jure* **the Supreme state of Grace,** Riverside, Calafia County, “Our Nation,” assembled the *twenty-ninth* day of July in the year of our Lord *two thousand ten*, upon the land claimed as such [secured by land claim of Patent CA CAAA 083204 Grant 486].

**We, the People, (indigenous, Nde KaiYab Shima Tribal Trust Nation members, and living men and [wo]man,** inhabitants on the land California (*de jure*) Republic), do hereby of Right, Duty, and Necessity, re-establish the California (*de jure*), in alignment with Article IV, Section 4(1)(2)(3) of the Constitution of the united states of America.

Written history has instructed us that it is our Obligation, Duty, and our Right to cast off the chains of bondage to any foreign occupation of our Sovereign state. The Federal United States Government has occupied California **de facto** for many years. This federal experiment of oppressive military dominance on our land of California (*de jure*) and Calafia indigenous inhabitants recognized as of 1510, began with the unlawful subjugation of California *de facto* through the forced adoption of its own rules, and has proven to the *de jure* Nation that a government established in deception and military subjugation, by enforcement into servitude is destined to fail.

**We** derive our Rights from Almighty God and declare our Right to self-determination, our Right not to follow others down a path of self-destruction, our Right to deny peonage and enforcement into servitude. We retain and declare our Almighty God Given Right to correct this path of self-destruction rooted in deception, setting a peaceful example for others to follow. *We, the People, indigenous* inhabitants of California (*de jure*), did not, do not, and shall not abandon our land, we know our Duty and our Right to re-establish California (*de jure*), and offer *de facto* to convert or vacate, and to become an example for the Nation to witness the re-establishment of a *de jure* Nation, a free sovereign community, peacefully, openly, and without violence. We acknowledge caution must be taken, due to the history of long-established **de facto** governments to NOT relinquish power and control over people lightly, easily, or without bloodshed. Our mission is peaceful with clean hands in good faith before God. We, therefore, extend an open hand, a Treaty of Peace, to the Federal United States Government to join us in peaceful cooperation for the re-alignment of the proper and constitutional roles in the relationship of the Federal Government to the government of the Several Sovereign *de jure* states.

**We, the People, (indigenous, Nde KaiYab Shima Tribal Trust Nation members, and living men and [wo]man,** inhabitants of California (*de jure*)), in order to assure a fresh start, hereby rescind the ordinance to dissolve the Union of states dated May 20, 1861, and declare it null and void. We also solemnly pledge and declare a peace Treaty, with the Federal United States Government and its lesser governments, which honor this re-establishment, from day assembled, the *twenty-ninth* day of July in the year of our Lord *two thousand ten*, upon the land, complete unrebuted separation of the land of California (*de jure*), Supreme state of Grace, Calafia County as of *twenty-eighth* day of February *twenty-twelve* (*nunc pro tunc twenty-ninth* day of July *twenty-ten*) undisputed *thirteen* years as of February *twenty-three*, upon the *private trust land*, a foreign Mission, undisputed claim the ‘*earth’s core to the middle of the earth*’ and up to the ‘*outer layer of the heavens*’ claimed total acres 48,847.27 secured claim as ISSN:eMCT12281969-13:10-07-2010:CACAAA083204:1867-10-26:.

**Our** task can only be accomplished with the guidance of Divine Providence, cool heads, honest diplomacy, and a facing of the truth of this Nation’s past and present actions. Where the United States Government has been actively involved in the subjugation and enforced servitude, through deception, of the people of this Nation, in direct violation of the Constitution of the united states of America.

**The** Federal United States Government, prides itself as a leader in the world in the maintenance of freedom, has become, in fact, a leader of the world in the forced subjugation of entire commonwealths, nations, and monarchies. This act by enforced servitude is as unconscionable and tyrannical as those actions taken by the most despotic and treacherous governments the world has ever known. The Federal United States Government has done this through the illusion of freedom, when in fact there is no freedom.

**In** spite of the crimes committed by the *de facto* government employees against the *de jure indigenous, Nde KaiYab Shima Tribal Trust Nation members, and living men and [wo]man* Inhabitants of California (*de jure*) and the other states, we find our only option is to extend an offer of Amnesty, and to move forward with a clean slate and our Nation with renewed hope of Peace on our land.

**This** Declaration of Re-establishment, re-unionization, and peace of the *indigenous, Nde KaiYab Shima Tribal Trust Nation members, and living men and [wo]man* inhabitants, find it necessary to reveal candidly to the world the

crimes committed by de facto Federal United States Government employees, upon the people of the several states and upon our private land, our Nation, and give notice the “Federal United States citizens, agencies, employees, etc., are required to convert or move outside our Nation boundaries, to their de facto communities.

**The** United States Government has acted in a pattern of trickery and deception for many years. It has repeatedly broken its most sacred duties, trusts, laws, and resolutions. The abuses and usurpations of power are far too numerous to list here. Only a few examples, though ample to substantiate our resolve, are chosen here. The Federal United States Government has broken its solemn promise to the *de jure indigenous, Nde KaiYah Shima Tribal Trust Nation members*, and *living men and [wo]man Inhabitants* and even to their own de facto Citizens of the entire nation by not honoring its obligation to follow its own joint resolution, relating to the object of the Civil War, to not subjugate, conquer, or impair the rights of the states in rebellion. The Federal United States Government employees perfidiously breached its Constitutional fiduciary responsibility in its action by coercing the indigenous, *de jure, members*, and *living men and [wo]man Inhabitants* of California (*de jure*) into a Federalized de facto status through the forced acceptance and adoption of a new Constitution, which assumes suffrage and offices in government only to those who encumbered themselves with Federal citizenship, which has no Rights associated with it, only privileges.

**The Federal United States Government employee’s unlawful actions** has forced this new Constitution on the Inhabitants of California (*de jure*) in contravention of the organic Constitution of a California de facto, illusion, prescribing faulty claims, kidnapping, identify theft, fraud, and so much more, instead a foreign method of framing and adopting a Constitution. Therefore, a Constitution has not been abrogated, for that Constitution could not be amended except by following the procedure prescribed in that Amendment. It certainly could not be repealed otherwise! These unlawful crimes has caused many injuries.

**The** de facto employees of the Federal United States Government, violated the duty of Congress to guarantee to every state a right to form a government, and instead, falsified records, withheld evidence, and continue with peonage of *indigenous* internationally protected persons. This enforced control and dominance has led to a situation where one’s life has been placed in danger, and now move, and do not choose to encumber themselves with any form federal citizenship, in fact, our *de jure* government removes their de facto government from our community.

**The** Federal Government, in its joint resolution of July 1861, stated to the world that the belligerent actions against the states in rebellion would cease when the states regained their ante-bellum, unimpaired condition. In knowing this condition must be met for the federal war of deception and silence to end after over 130 years, it is necessary for the Inhabitants of California (*de jure*), under our Creator, to breathe life back into an independent Nation, our own government undisputed as of date, *thirteen* years, coming into public. We find it necessary to make changes, as the Inhabitants of California (*de jure*) have been denied the opportunity to align their affairs, property, and our land in such a manner as to qualify to elect or hold our own office in California (*de jure*) as the California *de jure* Assembly inclusive of our Embassy of Calafia County, on our land coming forth as the established Calafia County.

**There** has been a well-documented usurpation of delegated powers exercised by several Presidents of the United States. This long and criminal train of usurpations, though not well known or understood, is partially documented in United States Senate Report 93-549, and is evidence of Congressional knowledge of the acquiescence to the usurpation of powers and failure to correct, thereby cloaking the situation from the American people. The information in United States Senate Report 93-549 should be taught and universally known, otherwise, the people are controlled through their lack of knowledge. Through silence and deception, the Federal United States Government has taken virtually every freedom from the people under extended fabricated "national emergencies, without the people’s knowledge of how or why this happened, in a manner which can only be described as democratic dictatorship.

**This** situation has destroyed the system of checks and balances and has destroyed our judicial system. The present Government appoints to the supreme Court political appointees, who interpret the Constitution and Laws according to the will of the Executive Branch, further compromising “Our Nation.” Patrick Henry specifically warned us that just such a situation would arise. The absence of Inhabitants of the several states in the supreme Court compromises the Court and makes suspect all decisions concerning the several states.

**The** present situation has not a universally known or recognized remedy in law within the Federal jurisdiction. Therefore, the remedy must be found without the jurisdiction of the Federal Government; by the re-establishment of our own recognized jurisdiction of the Inhabitants of California (*de jure*), separate from Federal jurisdiction and separate from the de facto jurisdiction as of *twenty-ninth* day of July *twenty-ten*, so be it.

## California *de jure* Declaration of Independence

**The** Inhabitants of California (*de jure*) hereby refuse to continue the game of hide-and-seek with their Rights in the current Federal jurisdiction of the de facto government entities. We hereby refuse to honor a government which:

- taxes the Inhabitants without representation in government.
- forces the Inhabitants into unconscionable three-party contracts in order to perform the duties of their daily lives, with use of their private property without permission.
- writes laws, with words that have multiple and ambiguous meanings, used to the detriment of the people and to the benefit of members of the private Bar Association, sheriff, and the court which include the Government, in their design to reduce the Inhabitants to mere wards of the State.
- enforces laws which are incapable of being understood or defended by the average de jure, enforced into servitude.
- enforces emergency actions while not disclosing the emergency to the Inhabitants.
- has a legal system which has become a source of uncontrolled profit for the few, at the expense of those most in need, causing false imprisonment, identity theft, faulty claims, causing physical and mental harm to the people.
- has created a Socialist State operating under the guise of freedom.
- has shirked its duty to regulate the value of the medium of exchange, delegating it to a foreign third party, which can economically collapse our nation at will.
- allows judges, magistrates, district attorney's, attorneys, clerks, and deputies to become active prosecutors, with interest (conflict) on behalf of the State.
- deludes the people by coercion, deception, and use of faulty declarations and sabotage into bondage by enforcement into servitude.
- legalizes chemical, biological, and radiation experimentation upon unsuspecting members (Title 50 USC Section 1520; Executive Order # 12891).
- terrorizes the Inhabitants into the acquiescence of their Rights.
- honors and enforces fraudulent contracts, and so much more...

**Through** the forced encumbrance of Federal citizenship, the Federal United States Government has created a standing army in times of peace, enthusiastic and willing to enforce a plethora of unconscionable and unconstitutional statutes, which violate the Rights they have taken an Oath to defend. They have turned their backs on the people! The crimes of their County agents within the courts, district attorney office, sheriff, etc. include fraud, extortion, peonage, enforcement into servitude, theft, creating faulty records, identity theft, racketeering, operating a continuing criminal enterprise under color of law, attempted murder-and even murder, all done with virtual impunity. The Actions by the de facto County is Not only against the people, but against the de facto Government, United States, United States of America, State of California, and so much more, is now to *cease and desist*.

**Divine** Providence gave to our forefathers the tools of freedom, which have been handed down to us to use today. We have written examples of how they formed our Nation, and we have instructions for self-correction to follow. Therefore, we follow in the footsteps of our forefathers by Declaring of Right, Duty, and Necessity, the re-establishment of a government best suited for, and designed to affect the safety, and security of the Inhabitants of California (*de jure*). Concomitant with this re-establishment is the pledge to assure a smooth transition into the uncharted areas with which we proceed. We do this through the guidance of our Lord, Savior, and King, Jesus Christ, through the forgiveness of the past actions of the Federal Government, its officers, and agents, corrupt County, who come forward and confess all belligerent actions against the Inhabitants of California (*de jure*), in a spirit of cooperation and Christian brotherhood.

**Re-establishment** fulfills a twofold purpose:

- I- it institutes a *de jure* government which will diligently protect the Rights of the Inhabitants.
- II- it creates a state under our Creator, a Nation *de jure*, which will breathe life back into the Constitution of the united states of America, recreating the duty and obligation once again to guarantee to the several states the protections as stated in Article IV Section 4, Article III Section 3 and the Tenth and Thirteenth Article of Amendment of the Constitution of the united states of America. The de facto government and its employees, agents, courts, judges, district attorneys, attorneys, sheriff, police and all parties involved shall co-*exist outside* the “**geographic** California (*de jure*), Supreme state of Grace” each exercising exclusive control of their own government and jurisdiction, **in separate boundaries/venues per meridian verified, accepted, and acknowledged as of 1867, secured as of 2010 (land description secured by \$100,000,000,000.00 billion lien).**

**The** use of weapons or unlawful acts of the current silent war:

- total control of information, silence, seizure, corruption in the courts; to delay, halt, or hinder in any way the re-establishment of California (*de jure*), shall be considered belligerent actions, and met with the

demand for the Federal United States Government to strictly adhere to Article III Section 3 of the Constitution of the united states of America.

- We refuse to be fatigued by shrewd men intent on the continued subjugation of the states.
- We know and understand that returning the Federal United States Government to its proper Constitutional alignment of eager compliant servant of the several states will be arduous at best. Thereby a complete separation of the states is now and forever complete.
- We have established our *de jure* land, and secured our land, and have NEVER abandoned our land, thereby our God given rights, have been honored, coming forth as California (*de jure*), the Supreme state of Grace, within the boundaries of our land measured at 48,847.27 acres, landmarks will be updated.
- California (*de jure*) Assembly will provide our Nation members, *living men and [wo]man*, and inhabitants, proper identification which will separate them from the de facto STATE OF CALIFORNIA.
- California (*de jure*) Assembly will provide our Nation members, *living men and [wo]man*, and inhabitants, proper Diplomatic License Plates, Membership Plates, Disability Plates for Travel, and Notice issued to all Government Entities to Update their records accordingly. Inclusive of Insurance. *living men and [wo]man* International Protected Passports, *Nde KaiYah Shima Tribal Trust Nation members* given Temporary Passports, and properly required identification.
- California (*de jure*), the Supreme state of Grace, operates under a **Private Membership Agreement**, where no law, no court, no state has jurisdiction, and all violators will be required to settle retainer and hourly fees by acquiescence, restrict to common law courts, chancery 'ONLY.'

**We, the People, (indigenous, Nde KaiYah Shima Tribal Trust Nation members, and living men and [wo]man, inhabitants of California (*de jure*)),** therefore, hereby make known to all men our resolve to re-establish California (*de jure*), the Supreme state of Grace. Unwavering, we exercise our Right and move forward, protected only by our Creator, our *de jure* government, our Embassy, and the truth of our experience. And for the support of this Declaration, with a firm reliance on the protection of Divine Providence, we mutually pledge to each other, our lives, our fortunes, and our sacred honor.

**Witnessed by the Order of,** and on behalf of the *Indigenous, Nde KaiYah Shima Tribal Trust Nation members, living men and [wo]man* Inhabitants of California (*de jure*), the Supreme state of Grace presents the California (*de jure*) Assembly and the Embassy of Calafia County, hereby re-established (of necessity) of the Round Table.
