Values:




Old Value System, where respect was earned on an institutional basis, and was deemed Mutual:

In the "age group kinships" (a group related by common characteristics, like age), for instance, every member of the kinship is accountable to the other. Each kinship group is also accountable to other kinship groups in the society, and ultimately all groups are accountable to the leadership of the community. This makes

each group "SOCIALLY RESPONSIBLE".

New Age Value System, an individualistic system:
