#### DISCUSSION OF AGENDA

the condition that is to be two units and all planning documents are to be submitted to planning for review within ninety days and that all work is to be permitted: Mayor Koci stated that this is a yes or no vote, yes that you agree with the BZA, and no that you disagree.

Ordinance No. 001-24: Contract with Hall Public Safety: City Manager Mallis stated that this is to outfit the two 2023 Ford Explorers that Council authorized to purchase for the Police Department. He also stated that it would take about six months to fully equip the vehicles because they are busy with work.

Ordinance No. 002-24: Amending Section 1957.11: City Manager Mallis stated this is to prohibit specific uses for parking on City-owned properties, prohibiting construction equipment, boats, and RVs. He also stated that we currently do not have anything stating this in the ordinance right now.

Ordinance No. 003-24: Contract with Fifth Asset, Inc.d/b/a Debtbook: Mrs. Howland stated that this is for software to help the Finance Department to better track and report debt and leases by saving time and reducing errors. She also stated that this is a three-year agreement and that if we decide not to use the software, we can cancel at any time with a thirty-day notice.

Mayor Koci stated that we reviewed the Boards and Commissions a couple of years ago and put them on a cycle where every month, we look and see if there are any vacancies or reappointments. #### 5. PRESENTATION

a. Presentation of the Auditor of State Award with Distinction by Katheryn M Semo from the Ohio Auditor of State's office

#### 6. REPORTS

- a. City Manager Mallis reported on the following:
  - Congratulated Mrs. Howland and the Finance Department for the State Award of Distinction and he stated the following: When the snow does exceed two inches, a parking ban goes into effect, and it is primarily for the safety purposes of pedestrians, motor vehicle drivers, and snowplow operators.
  - There will be a Public Meeting on Wednesday, January 24th, at 6:00 p.m. at the Ellenwood Community Center. This is to discuss the expansion of the Bedford Commons. The City was awarded a substantial grant that is going to contribute to the majority of that project.
  - Late last year, the Police Department was out canvassing the City and identifying all streetlight outages. There was a substantial amount that we reported to First Energy, and they did respond quickly.
  - The Cleveland Metroparks notified us that they started their deer culling operations in the Bedford Reservation, which will continue until mid-March. Any culling areas will be properly blocked off, and signage will also be up stating that the park is closed during that time.
  - We did get estimates for one of the roadways; resurfacing Solon Rd will be a substantial project in the future. it is a county road. According to the County Engineer's office, it is considered a low-rated road. We are outlining a plan to move forward with getting the road resurfaced; the challenge is that to do it the right way, the road needs to be concrete, given the amount of traffic on Solon Rd. If we use asphalt, the road will start to buckle, so we want to ensure that it is done correctly. The project will be approximately \$3 Million. We've had some positive discussions with the County as to what they would contribute, and we are going to be looking at finding sources to apply to cover the cost.
  - We will be looking at the City's sewer on Solon Rd., but the important thing is that there is a large City of Cleveland Waterline from the 1900s that runs down Solon Rd. and addressing those before we resurface Solon Rd.
  - We were contacted by Cuyahoga County that the County Fiscal Office Appraisers are in town and that they will be working on the reappraisal process of properties;

this may last until the middle of February. If you have any concerns, call the Police department.

b. Finance Director Howland had no report this evening.

- Church of the Nazarene has a new pastor Mr. Yarbrough. She welcomed him and his family to the City.
- The residents were reminded not to feed the deer.

#### Councilman Salvi reported the following:

- Congratulated Mrs. Howland and the Finance Department on their award.
- Thanked the residents of Ward 2 for electing him and giving him the opportunity to be here.
- He has a list of concerns from the residents that will take some time to address, and they will be on the internet or in a ward letter that will be put out.
- Expressed his condolences to the Ballantine's family and friends for their loss.
- Residents would like more traffic enforcement, including around Bedford High School.
- A meeting will be arranged with the residents on Darlington Rd. Helper Dr. and anyone is welcome to attend to express in detail some of the problems of trespassing and drug use around the high school.

#### 9. HEARING OF CITIZENS

Sabrina Future, 15 Charles St., Bedford, OH: stated the following:

- She appreciates the new business over by Zaks Supermarket.
- Asked Councilman Salvi about the meeting he is planning for the students and that she is interested it what is going on with the youth.
- Asked about the status of the demolition of the veterinarian building, if there was any grant money to help with it, and if they have gone out to see it.
- Is there anything that the City can do to temporarily secure the building so that nobody goes in it.

City Manager Mallis stated the following:

- Notices were sent out that it was condemned, and he was not aware of any grant money to proceed with the demolition and that they had gone out to see it.
- The City can't address it without taking the proper steps. He stated that, ultimately, it will come down but that he can't promise it just yet. Also, we will take the appropriate steps to ensure that we legally assess those costs because the City would have to put money upfront to take it down. He stated that the cost is between \$20,000.00 to \$25,000.00, and if we were to do it right now, the City would have to assess the property, and the City would not receive any grant dollars to demolish it.
- That the City would look into securing the building if necessary.

#### Jeff Dubber, 134 Harriman St., Bedford, OH: stated the following:

• Stated that the payment for the water bill takes four days to be submitted to the city when it is paid online.

Mrs. Howland asked if he was paying through his bank or on the website, and Mr. Dubber replied through his bank.

Mrs. Howland also stated that is why it takes four days, but there are programs out there that allow it to be transported quickly.

#### Ms. Lachowski, 745 Archer Rd., Bedford, OH: stated the following:

- Asked if there is a possibility that the bill can be sent electronically or made available
  electronically so whether you physically received it in the mail or not you could pay it
  online.
- Mrs. Howland stated that kind of system has been present in the City before, and when it
  comes to the Water Department, many of those decisions are not hers to make; it is someone
  else's, but it is something to look into again.
