#### A. Sanborn updates: Daniel

- 1. Received pilot tiles- these are available if anyone wants access; We have until March 8 to respond with comments; Received 73K grant (3DEP program) from USGS to go from partial to complete county flight at Q1 (910 sq mi), who will provide feedback as well; we expect to have full area of interest by July, and the review process will be open until December; Lidar derivatives 1 ft contours, culverts with measurements to be delivered.
- 2. Submitting bid to USGS 3DHP program (elevation based hydrography)- add request to budget
- 3. What other derivatives?- storm drains & inlets not part of deliverables; agreement is that Sanborn will update changes (not full county)- builds on Eagle View and Pictometry.
- 4. 2023 Urban Core Imagery and updated Planimetrics imagery hard drive received yesterday- will send out once this is reviewed
- 5. Service will be added to agol/portal
