

ORDINANCE NO. 2024-02-15
(Order and Notice of May 4, 2024 Election)
(Council Member Places 3, 4, and 5)

AN ORDINANCE OF THE CITY OF ALVORD, TEXAS, CALLING FOR AN ELECTION TO BE HELD ON MAY 4, 2024 TO ELECT CITY COUNCIL MEMBERS FOR PLACES 3, 4 AND 5; PROVIDING FOR EARLY VOTING; PROVIDING FOR AN ORDER AND NOTICE OF THE ELECTION; AND PROVIDING FOR OTHER MATTERS RELATING TO THE ELECTION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALVORD, WISE COUNTY, TEXAS:

SECTION 1. The Mayor of the City of Alvord, Texas, with the concurrence of the City Council, orders an election to be held on May 4, 2024, for the purpose of electing a City Council Member for Places 3, 4 and 5. All of the elected Council Members will serve two-year terms.

SECTION 2. The polling place in the City of Alvord for this election is as follows:

Alvord, TX 76225

SECTION 3. The polls on May 4, 2024 shall be open from 7:00 a.m. until 7:00 p.m.

SECTION 4. Said election shall be conducted in accordance with the Texas Election Code and only registered qualified voters of the City of Alvord will be entitled to vote.

SECTION 5. Early voting by personal appearance shall be available at Alvord City Hall, 215 W. Elm Street, Alvord, Texas on the following dates and during the hours shown:

Tuesday, April 30, 2024	7:00 a.m. – 7:00 p.m.

Applications for ballot by mail shall be requested from and mailed to the Wise County Elections Office, 200 South Trinity, P. O. Box 1597, Decatur, TX 76234. Applications for ballots by mail must be received no later than the close of business on Tuesday, April 23, 2024.

SECTION 6. Candidates must adhere to the filing deadlines accordingly. Candidate packets are available in the City Secretary's office. The candidate filing deadlines for the General Election for a City Council Member for Places 3, 4 and 5 are as follows:

Wednesday, January 17, 2024 through Friday, February 16, 2024

Candidates must file in the City Secretary's office located at 215 West Elm Street, Alvord, Texas.

SECTION 7. The City Secretary is hereby authorized and directed to publish and/or post, in the time and manner prescribed by law, all notices required to be so published and/or posted in connection with the conduct of this election.

SECTION 8. All ordinances and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict and the provisions of this Ordinance shall be and remain controlling as to the matters ordered herein.
