## Sewer Jetting In Progress

Sewer jetting began on Monday, December 5.

The sanitary sewer main cleaning process uses high-pressure water jetting in the sewer mains that may push water out of your residential plumbing floor traps and private plumbing fixtures. This happens most commonly when there is a problem with a home's plumbing vent. It will be most evident by the appearance of clean water ponding on the floor around floor drains or water levels rising inside of toilet bowls.

To prevent this please pour tap water down all basement floor drains or rarely used sinks, tubs, or toilets to ensure that you do not have a dry sewer trap.



## Holiday Recycling Day

The annual holiday recycling drop off day will be held on Tuesday, December 27 from 2-5 pm in the DPW parking lot.

Items accepted include:

- Yard waste
- Recycling
- Electronics (TV and monitor fees must be paid in advance)
- Scrap metal
- Plastic bags
- Light bulbs
- Ink cartridges
- Eyeglasses
- Cell phones
- Paper, for shredding

## Property Tax Bills Mailed

Property tax bills have been mailed. The first property tax installment is due January 31, 2023. Property tax payments can be paid via US mail, dropped in the drop box outside Village Hall, or in Village Hall during normal business hours.

Please note, Village Hall will be closed December 23, 26, 30, and January 2 in observance of holidays. You may use the Village Hall drop box to pay your tax bill if Village offices are closed.

If you are utilizing the installment plan,

property tax payments are due January 31, March 31, and May 31, 2023.

## Property Tax Facts

The Village has eight taxing jurisdictions, each of which submit their tax levy to the Village. The Village does not determine tax levies for jurisdictions other than the Village. Your tax bill will vary based on the county and school district in which you reside, as well as your property's assessed value.

Assessed values are established by the independent assessor and are established through the reassessment, open book, and board of review process in the spring and summer of each year.

The Village collects all property taxes. Approximately 23 cents of each dollar is for Village services. The remaining 77 cents per dollar is distributed to the other taxing jurisdictions.

Voter approved referendums impact property tax bills and can vary between school districts in the Village.

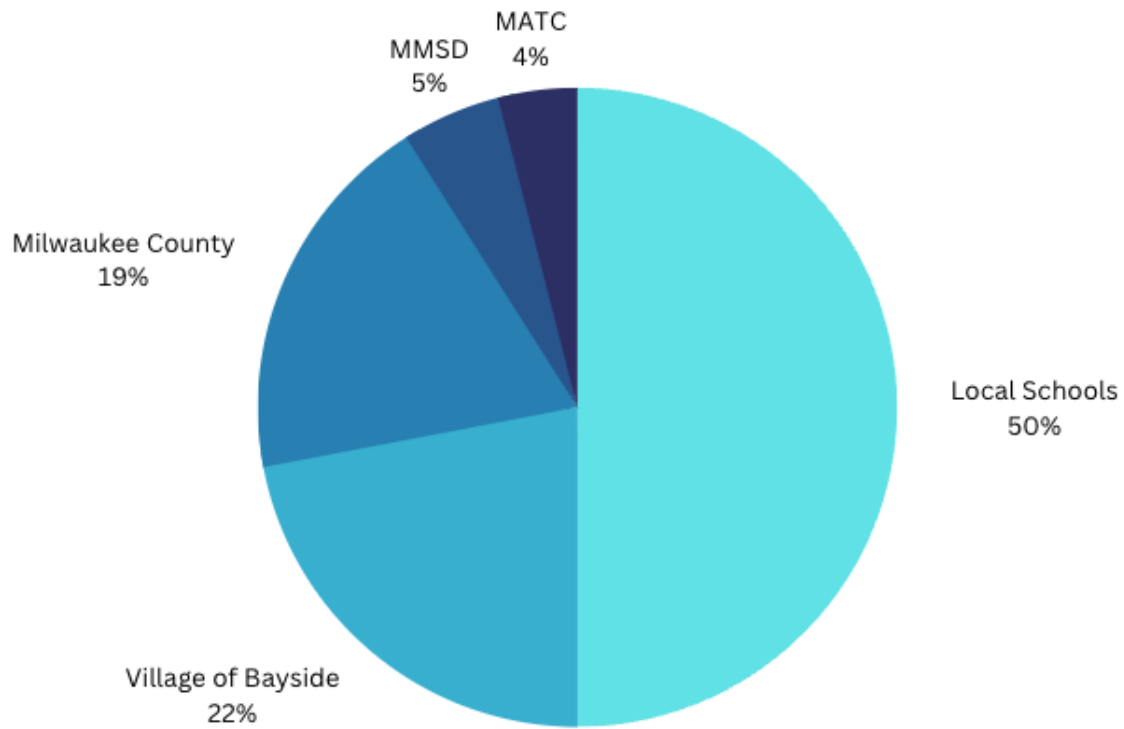

## Breaking Down the Tax Bill

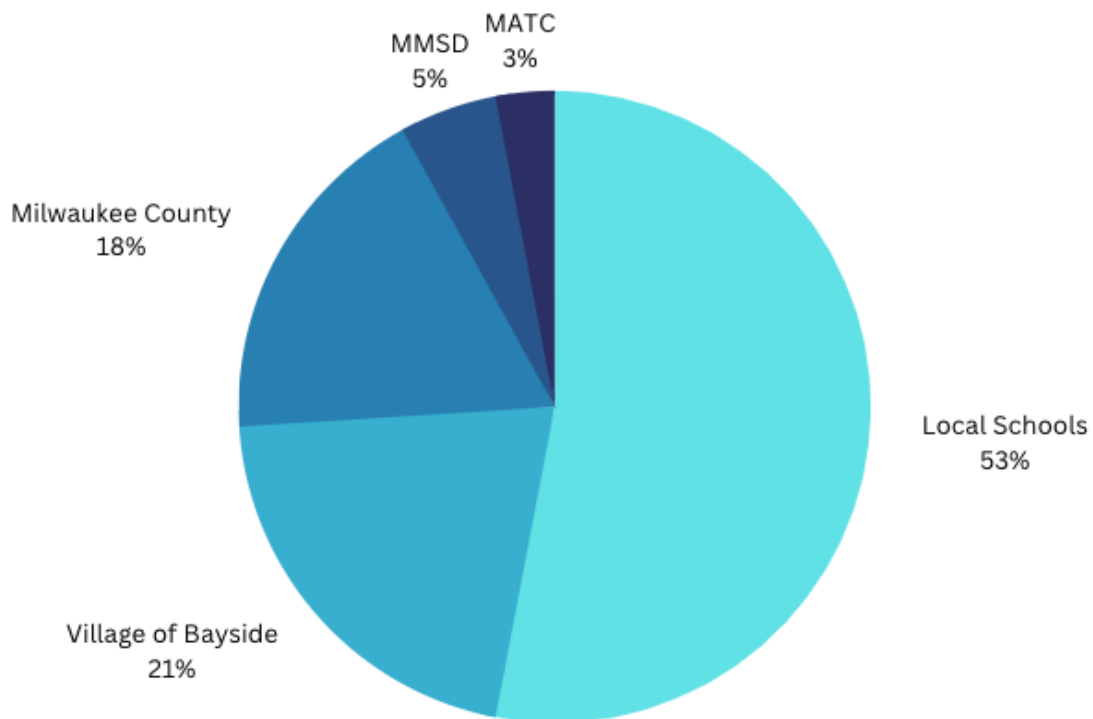
Each December, residents receive a tax bill addressed from the Village of Bayside. While the property tax bill says "Village of Bayside" on the envelope, it really should also say "Milwaukee or Ozaukee County", "Fox Point/Bayside School District or Maple Dale/Indian Hills School District", "Nicolet High School", "Milwaukee Area Technical College", and "Milwaukee Metropolitan Sewerage District". On average, the Village receives \$0.23 of each tax dollar collected. Below is breakdown by School District and County as to how the property tax dollar is allocated.

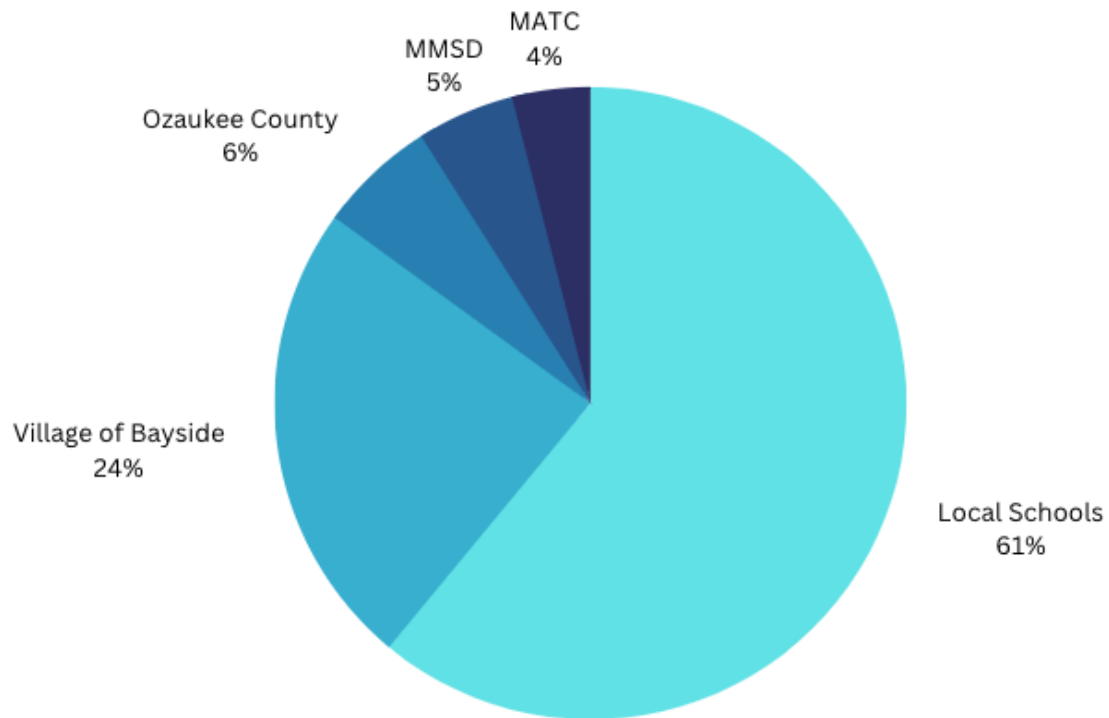
# Milwaukee County Maple Dale-Indian Hill Schools

## Mill Rates and Assessments

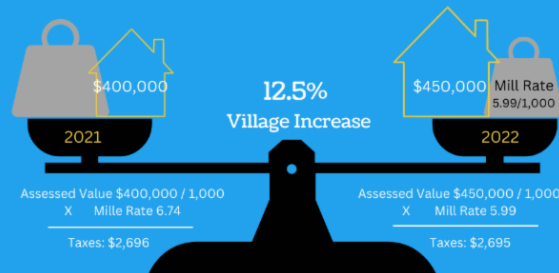


# What's A Mill Rate?

The Mill Rate is calculated by dividing the total taxes needed by the total assessment value of the community. An increase in assessed value does not equate to an increase in your taxes.

$$\text{MILL RATE} = \frac{\text{Total Taxes Needed}}{\text{Total Assessed Value}}$$

It is a simple mathematical fact, if taxes stay the same and assessed values increase, the mill rate will fall, and your taxes will stay about the same.

## **Mill Rates**

What is a mill rate? The mill rate is the amount of property tax a property owner pays per \$1,000 in valuation. How is the mill rate calculated? The visual shows that even with an increase in your assessment, the mill rate will adjust accordingly.

## **Misconceptions**

One common misconception that an increased assessment will automatically lead to a tax increase. Overall, the Village of Bayside experienced increases in assessed value in 2022. However, revaluations are revenue neutral. In other words, an increase in total property value does not necessarily mean that the Village of Bayside and/or other taxing jurisdictions will collect more tax dollars. Property assessments are used to determine each owner's share of the total tax burden. Therefore, some owner's shares will increase, some will decrease, and some will stay about the same depending on how their assessment changed in relation to the average increase of 16%.

## **Example**

For example, when tax levies remain constant, a property valued at \$400,000 in 2021 with a tax rate of \$6.74/\$1,000 would be nearly the same as a home valued at \$450,000 in 2022 with a tax rate of \$5.99/\$1,000.

The 2022 tax rate will be available in December after each of the different taxing authorities (Milwaukee County, Village of Bayside, Nicolet/Maple Dale-Indian Hill/Fox Point-Bayside School Districts, MATC, and MMSD) have established their respective tax levies.



## **OneNorth "Building C"**

Architectural plans for the proposed new North Shore Library within the OneNorth development "Building C" were formally reviewed by the Architectural Review Committee on Monday, November 14. The Committee recommended the project to the Plan Commission.

Additional plans and technical review for the proposed Building C occurred at the Plan Commission meeting on Wednesday,



November 30.

The project was recommended by the Plan Commission to be discussed by the Village Board at the December 15 meeting.

- Request signature confirmation.
- Ask your carrier to place packages out of view of the street.
