But it's kind of like a cut-and-dry scenario. I stay on the corner, and it's a unique situation because my door is on the side of the house and close to the sidewalk. The fence was for security, so I could let my pets in and out without obstructing or worrying about the public. I have everything planned out for what I want to do. I will have it go along the sidewalk from my walk path to the back to get to my garage, which will technically be the space that would be outside of the fence. But, where I would like to put it would be inside. I would just be on my walk path to

the back and close it up.

Mrs. Glaiser: Can we just make the suggestion? We looked at it, and we understand your plight, but you are right on the corner, and so is your garage.

Mrs. Hulett: Would you be able to diagonalize the fence from the corner of the garage to the sidewalk line?

Mrs. Glaiser: To make up a forty-five-degree angle? Just so someone is walking, you could see them when you're backing out of the garage.

Mrs. Hulett: Have an angle there; that way, you'd have a better line of sight to the street and to pedestrians.
