Present: Council Members: Mayor Stan Koci, Donald Saunders, Sandy Spinks, Walter Genutis, Marilyn Zolata and Paula Mizsak. Absent: Greg Pozar. Also Present: Clerk of Council Lorree Villers. Administration: City Manager Michael Mallis, Finance Director Frank Gambosi and Law Director John Montello. Residents: Victor Fluharty, Heather Rhoades and Larry and Laura Zolata.

Kenny Yuko presented a proclamation to Mayor Koci and Sandy Spinks for their re-elections and Greg Pozar and Marilyn Zolata for their ending terms.

Mayor Koci began discussion of the Regular Council Meeting agenda.

ORDINANCE NO. 9547-17 BEING AN ORDINANCE AMENDING ORDINANCE NO. 9422-16 CONCERNING SECTION 913.03 "RATE REDUCTION FOR SENIOR CITIZENS AND THE PERMANENTLY DISABLED" OF THE CODIFIED ORDINANCES OF THE CITY OF BEDFORD AS RELATED TO SEWER RATES AND DECLARING AN EMERGENCY

Mr. Gambosi explained that is was necessary to increase sewer service charges commencing February 1, 2018 to cover the projected costs of operating, maintaining and improving its sewer system, including, without limitation, paying debt service charges on its bonds and notes issued for improvements to the sewer system.

ORDINANCE NO. 9548-17 AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH ARICK'S ENVIRONMENTAL MANAGEMENT SERIVCE, INC. FOR ASBESTOS ABATEMENT AT ELLENWOOD RECREATION CENTER AND DECLARING AN EMERGENCY

Mr. Mallis explained the Ellenwood Recreation Center was in need of asbestos abatement to expand use of the facility. Arick's Environmental Management Service, Inc. was lowest and best quote at \$25,000.

ORDINANCE NO. 9549-17 AN ORDINANCE AMENDING ORDINANCE NO. 9464-17, PASSED JANUARY 3, 2017 PROVIDING COMPENSATION FOR THE CLERK OF COURT AND DECLARING AN EMERGENCY

Mr. Mallis and Mr. Gambosi explained the State of Ohio mandates a five percent (5%) raise to Clerk of Municipal Courts to coincide with the raises provided to the Judiciary and in consideration of the outstanding efforts of the Clerk in regards to efficiency and economics of administration of the Court. The compensation for the Bedford Clerk of Court, Mr. Day would be effective with the pay period beginning January 1, 2018. The amount of \$112,327.50, 60% to be paid by the City of Bedford and 40% to be paid by the County of Cuyahoga. Mr. Genutis noted the increases over the past few years and was not in favor of another increase.

ORDINANCE NO. 9550-17 AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A LEASE – PURCHASE AGREEMENT ("PURCHASE") WITH HUNTINGTON PUBLIC CAPITAL CORPORATION ("HUNTINGTON") TO FINANCE THE PURCHASE OF A PITNEY BOWES SEND PRO P SERIES POSTAGE MACHINE SYSTEM AND A RELAY 3000 INSERTING SYSTEM AND DECLARING AN EMERGENCY

Mr. Gambosi explained the new postage machine and a new folding machine for the efficient operation of the City used by all departments. He decided it was best to purchase the systems through Huntington as the most economical method of financing. The City would pay principal and interest in the amount of \$20,526.84 to Huntington.

ORDINANCE NO. 9551-17 AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR A NEW POSTAGE MACHINE AND AN EQUIPMENT AND SOFTWARE MAINTENANCE AGREEMENT FROM PITNEY BOWES AND DECLARING AN EMERGENCY

Mr. Gambosi explained the City was in need of a new Send Pro P Series System postage meter. The cost was \$7,615.94 for a new postage machine and services, a \$117.00 a month for leasing the postage meter and an annual maintenance fee of \$834.08 from Pitney Bowes.

ORDINANCE NO. 9552-17 AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR A NEW FOLDING MACHINE FROM PITNEY BOWES AND DECLARING AN EMERGENCY

Mr. Gambosi explained the City was in need of a new Relay 3000 Inserting/folding machine. This equipment would be purchased from Pitney Bowes in the amount of \$11,701.05 which included maintenance.

RESOLUTION NO. 2519-17 A RESOLUTION COMMENDING MARILYN B. ZOLATA FOR SERVING THE CITY OF BEDFORD AS COUNCILWOMAN REPRESENTING WARD 3 AND DECLARING AN EMERGENCY

Councilwoman Zolata served Ward 3 and the community as a whole as Councilwoman with dedication and distinction since January 1, 1992. With many years of service she has been marked by exemplary dedication to the best interest of the community as she has worked constantly for the betterment of its economic, cultural and aesthetic development and she has earned the admiration and high regard of those with whom she has come into contact and the affection of her fellow public servants. The City wished to publicly express its sincere appreciation and thanks to Councilwoman Zolata for her many contributions to the community and highly commend her for the manner in which she has carried out her responsibilities and duties as a member of City Council.

RESOLUTION NO. 2520-17 A RESOLUTION AUTHORIZING THE CITY TO HOLD ITS CEREMONIAL ORGANIZATIONAL MEETING ON JANUARY 3, 2018 AND DECLARING AN EMERGENCY

It was understood the City Charter stated on the second day of January following a regular Municipal election Council shall meet for the purpose of organization. Due to Monday, January 1, 2018 and Tuesday, January 2, 2018 falls on the New Year's holiday and City Hall would be closed, Council would hold its Organizational Meeting on January 3, 2018 at 7:00 p.m. to allow more anticipated public involvement and the convenience of council family members in consideration of the meeting time and the extended holiday.

Motion to accept the recommendation of the December 5, 2017 Planning Commission - Amereo Real Estate Company, 2727 N. Central Avenue, Phoenix, AZ is requesting to use the structure located at 19000 Rockside Road as an interior self-storage, U-Haul Truck & Trailer share and retail sales (§1938.03 (f))

Mr. Mallis explained previous discussions had taken place between the Administration and Council of a few different options the parcel could be utilized for; however, nothing had been decided on. The Commission understood the contents stored on the property would be moved to the new location within a reasonable time of 12-18 months. U-Haul would have to contact the renters of the 212 storage units that needed relocated which would take some time to accomplish. It was understood there would not be two U-Haul locations within the Bedford City limits.

Motion to accept the recommendation of the December 5, 2017 Planning Commission - Young Custom Homes & Remodel, 362 City Road 1302 Polk, OH is seeking to reconstruct a 20' x 40' open carport to replace the carport that was damaged beyond repair at Slate Run Apartments located at 450 Turney Road (§1305.09)

Mr. Mallis explained the current carport was damaged beyond repair and needed to be replaced.

Motion to accept the recommendation of the December 5, 2017 Planning Commission - Byron Greene, 660 Columbus Road is requesting a variance to build a  $30^{\circ}$  x  $40^{\circ}$  pole barn garage (§1913.07)

Mr. Mallis explained the property owner had a large parcel and the structure would not be an issue on the edge of the City limits. The applicant had several vehicles he wished to put under roof plus the structure would not be very visible from the street. Mr. Genutis noted he supported the applicant's request at the December 5, 2017 Planning Commission meeting.

Motion to accept the recommendation of the December 5, 2017 Planning Commission - Marie Harris, 18646 Alexander Road, Walton Hills is seeking a Day Care & Learning Center located at 776 Broadway Avenue (§1937.03 (c)) (PC failed)

Mr. Mallis listed the several safety concerns the Commission had with this request plus the applicant was not in attendance at the meeting for questions. At the Planning Commission meeting the Commission reviewed the request and had several concerns mostly being safety concerns for the children. The ages of the children would be 2 ½ to 12 years of age and because the location had no parking available on the

property the children would be unloaded on Broadway Avenue or in the abutting parking lot. The strip mall would be busy with shoppers, visitors at the business in the rear of the building and people eating at the restaurant. Another concern was that the location did not have a yard for the children to play. The Commission was not in favor of the day care because of safety issues.

Motion to accept the recommendation of the December 5, 2017 Planning Commission - Charles J. Siracusa, 32560 Wintergreen Drive, Solon is seeking approval for prospective tenant Katie Dailey to open a boutique in the downtown Historic District for retail sales of hair wigs located at 718 Broadway Avenue (§1944.03)

Mr. Mallis explained the applicant wished to sell hair wigs, hair extensions and he was not sure of hair products. He said Mr. Siracusa's tenants seemed to stay for a long period of time. The wigs would be for cancer patients, those with alopecia or hair loss. The applicant would not be cutting hair, applying fake nails or salon type services. The business would be "retail sales" only not a beauty parlor or nail services. Mr. Mallis said Mr. Siracusa was well aware of salon certifications and requirements. It was determined the sign application would be submitted to the Historical Preservation Board for approval which Mr. Siracusa was fully aware of.

Motion to accept the recommendation of the December 12, 2017 Planning Commission - Pruitt Construction, Inc. 3851 Wadsworth Road, Norton, Ohio representing owner Dick Marcellino of Motorcars Acura/Volvo Arm Performance Group, LLC is proposing a major renovation of the existing Volvo Showroom to include an new 528 square foot addition located at 18123 Rockside Road (§1305.09) (Special PC)

Mr. Mallis explained Volvo was interested in building a 528 square foot addition and renovations at cost of \$800,000.

Richard Novak, 1252 Broadway Avenue, thanked Mrs. Zolata for her service to Ward 3 and the community and everyone loved her.

Frank Spiker, 20 William Street, echoed the same as Mr. Novak. He's known her since the 1970's. He thanked the Zolata family for everything they had done for the community.

Mrs. Zolata wished Mr. Fluharty and Ms. Rhoades the very best in their new council positions. She added that Donald Grossenbaugh and Dan Pocek were her mentors.
