Present: Paul Stoyanov, Pruitt Construction, Inc.

Mr. Stoyanov, previously sworn in, explained this request was for approximately a three-quarter paved area on the south-east corner of Motorcars Acura property. The dealership was to the west with another inventory lot to the south that faces Broadway and to the east were residential homes with a 35 foot buffer with a fifteen foot elevation difference to minimize the impact of the parking area to the houses. Other than temporary noise made during construction there would be no additional noise after the lot was completed. The project required minor grading, no pole lights and arranged a paved area to avoid any stream setbacks and flood zones. He appreciated consideration and requested approval so the dealership could proceed.

Chairman Briggs asked if this was inventory of new cars. Mr. Stoyanov replied, the area was strictly inventory and would not be used for customer use or display of vehicles. Mr. Powers asked what "stack parking" meant per the document. Mr. Stoyanov explained there would be three cars deep (end to end) in the center aisle. An employee would have to move one car to get access to the center vehicle.

Mr. Beverly clarified the area would be for inventory only. Mr. Stoyanov explained shown on the documents submitted there was going to be a car wash located in this area and customers would not have access to the area. Mr. Beverly stated for the record he received approval from the City's Engineer for the project. (See attached)
