-The taxpayer Mr. Christopher Griffin moved into the City of Bedford On April 1, 2018

-Mr. Griffin Earned \$50,000 and worked in two different Cities, he earned in Cleveland \$10,000 and earned \$40,000 while working in Maple Heights according to his W-2 wages.

-Also, noted on his W-2, was that the company Mr. Boss withheld courtesy tax and paid the City of Bedford the amount of \$375.00 ($\$50,000 * .0075$)

-The W-2 wage earnings of \$10,000 were earned only as a resident of Bedford after April 1, 2018 –December 31, 2018.

December 7, 2018

-The W-2 wage earnings in the amount of \$40,000 were earned in Maple Heights and were earned throughout all of 2018.

-We will use the Maple Heights W-2, to also post, the courtesy tax withheld in the amount of \$375.00.

-Mr. Griffin received a 1099Misc form from "My Business Company", the earnings were in the amount of \$5000 –noted as nonemployee compensation, and this was earned only as a resident of Bedford (4/1/2018-12/31/2018).

-Mr. Griffin was lucky in 2018, and received a W-2G from the Rocksino located in North field Village, in the amount of \$1500 and this was earned as a resident of Bedford.

-Mr. Griffin also ran a small business and filed a Schedule C called "Your Business" he showed a net gain of \$1000 for the whole year in 2018. This business was located in Garfield Heights and he paid that city \$20.00 in Net profits taxes on the \$1000 income.

-Mr. Griffin had a rental property and he had a Schedule E, this was located in Cleveland, and he made a \$5000 net profit from this rental property throughout the year 2018.

-Mr. Griffin also was a recipient of a K-1 form for income earned from the business, called the "Oil Baron" and received \$500 in 2018, earned after April 1, 2018.

Mr. Griffin paid estimated payments in 2018, in the amount of \$74.30, to the City of Bedford.
