I want to mention why this is a loan fund. This program provides principal forgiveness, so they classify it as a loan, but in essence, it's a grant. Grants as we all know are way better than loans because you don't have to pay that money back so what we're looking at is one of our projects at the Wastewater Treatment Facility that we've been talking about needing an upgrade is the headworks, which is at the top and it collects all the rags and everything else that stops the debris from going into the system. This is geared towards that project so again thank you for having a special meeting. This legislation will be included in our overall application, and we can check that box as a requirement.

Mr. Montello said we should mention they have NFA study fees that they're trying to apply for just for the record correct?

City Manager Mallis said that also is included in there are the fees associated and part of the fees that are associated with the NFA study that we're currently working through.
