Bedford City Council met in a Work Session at Bedford City Hall on Monday, October 3, 2022, at 5:30 p.m.

She said that she did notice that on Cresswell Ave. it took so long to get them to retain that and that Dominion marked the zone and that there might be some digging going on and asked if City Manager Mallis could reiterate that a little bit more. City Manager Mallis said that we don't know the exact timelines but that Dominion is doing their main gas line replacement project on Archer. Once that's completed the next area they're looking at is Cresswell Ave. but we don't know when that will take place. We don't have a timeline or anything like that, but I will say that we don't permit them to start a new project until the current one is buttoned up. But it appears their next area of focus is Cresswell Ave. Councilwoman Spinks said that the residents were a little concerned seeing all the blue markers on there because it just got repaved. I got a couple of calls that the car haulers are going down Grand and Willard. I just wanted to thank a couple of residents that got out and picked up the trash while I was gone for a couple of weeks. I was kind of concerned, and I was worried that the trash was going to be really bad when I got back. I just want to thank those people, and everybody that gets out not just in my ward that but gets out and picks up trash and helps the City that's always a nice thing.

Councilman Genutis said I'd like to say, Councilwoman Spinks, as you pointed out, that there's not as much trash, and I think that people are indeed going out and picking it up, and I know in my ward, it's pretty well picked up. I think it's a wonderful thing also, I noticed that along Solon Road, which belongs to the City, that stretch is usually pretty trashy, but it's pretty cleaned up now, and I really appreciate it. The City is indeed the one responsible for doing that. For a point of clarity for my no-vote on Ordinance No. 10,015-22, I certainly am not opposed to the City lowering the water race; in fact, really, I'm grateful that the City is tweaking its numbers and sharpening its pencils, and realize that a great rate increase was not necessarily so. I do appreciate that, but I did place the no vote because philosophically, as I've mentioned before, I'm against the City charging a minimum water rate when absolutely no water is used by the customers. I don't believe that that's correct people should be charged for water if they don't get any, and furthermore, our ordinance says that a minimum monthly water service charge shall be paid by each and every customer supplied with water. But that's not the case because many people are charged this fee without being supplied water in fact, the water is shut off, so I just wanted to clarify it. Mayor Koci said your "no" vote was against the suspension.

Some people don't know this is there are a lot of people that do a lot of work for this organization, the Jewish people that get all this done there's only one major other major Holocaust Memorial, and that's in Washington DC. They just passed through the House of Representatives to bring another one to here in Bedford Heights, and now it has to go in front of the Senate, and they pass it, then it has to go on to Joe Biden's desk, and of course, he'll sign it. Then we will have the second Memorial here in Bedford Heights throughout the whole country, so that's an important monument, and Ohio has recognized it as a landmark for the State of Ohio, and if you ever get a chance, go in the cemetery and see this amazing all the names that are on the wall from the Holocaust. A couple of Senator's were the along with a few other dignitaries and some of the Mayors from other cities. He asked do you know if our signals are included in this and will it also include the one that sits off of the other tracks as opposed to just Norfolk itself. City Manager Mallis said I'm not aware that I can look into it, but we have not been notified of any of that work, or if they've received any of the funds, but I can check. Councilman Saunders said that we should make sure that we don't get skipped because everything deals with the railroad we seem to get skipped ever since Conrails disbanded. He asked City Manager Mallis if he can give an update on what's happening with the water line and Harriman and Ennis? City Manager Mallis replied that we're going to be doing is determining if that's going to take place they won't both take place this year most likely it would be one or the other. The odds are it's going to get pushed into spring. We haven't had that meeting yet with the contractor what we're looking to do is button up Broadway first. We had our punch list on Broadway last week and completed that with the contractor. Now we're going to be meeting to discuss the water lines going through the winter. It's, not something that will be completed before the winter. It's not like we can jump in there in the middle of October and have that done by November or December. It's going to be quite a long project even just for one of them, so it's most likely going to get pushed into next year, but we'll know that in the next week or so. Councilman Saunders said that the school buses and everything else is affected by that both of those projects. I don't know if anybody is paying attention to the Bedford City School District facilities project that's upcoming, but they're having a meeting this Wednesday. Most people don't realize the State of Ohio has mandated certain school policies with building classrooms, and if your buildings were built before 1970 it's cheaper to replace them than rehab them. The state will only give you money if you build new, so if you go to rehab them, you have to bring it up to the standard, so the school system has formed a Facilities Committee. So but be aware of the fact that there are going be a lot of upset people. Depending on where and how the schools get rebuilt they will probably all have to be refilled because all our buildings are full and they don't meet the current design standards that the state is mandating. Theirs a lot of school districts that have already started and Bedford is now getting underway on seeing what will be

City Manager Mallis said this is for our agreement with the Ohio EPA. We are working through a Non-Feasible Alternative Study for our sewer system in the Wastewater Treatment Plant. Earlier this year, we authorized purchasing and installing various flow monitors at several locations throughout Bedford. The Ohio EPA had requested that we have additional temporary flow monitors installed at additional locations; although questionable, we are working with the EPA. Previously City Council had authorized that insulation we want to have installed during the rainy seasons to gather the most accurate data during those heavy rain events. As far as what our system needs, we further designed the system through the Non Feasible Alternative Study. This ordinance will allow the engineers to put together the information with the additional meters we passed at the last meeting. The initial one was for six or eight that we had installed, and we passed legislation for those to be included in this study; now that the Ohio EPA wants more, and this ordinance authorizes them to conduct the studies

## 9. HEARING OF CITIZENS

Heather Rhodes, 241 Center Rd., Bedford, OH said City Manager Mallis for your coaching and the rest of Council with the exception of Don Saunders. First, it has been my honor and pleasure to reside in the City of Bedford several years ago, I made a commitment that my company would donate ten thousand dollars a year to the City of Bedford provided that I was informed as to what the city needed in terms of money. It's been two years, and I have not yet been to be as informed as of what the city needed despite several requests to both my Council Member and many more requests to the City Manager. I can only assume that they are so busy with their jobs that they're unable to take the time to spend a half hour to accept ten thousand dollars for the benefit of the city that I have committed to giving to the city that I love and have lived in for the past 21 years. Despite this, I would like to express to the parties mentioned I'm not angry. I am just a little disappointed for the purposes of making up lost time and money, there is twenty thousand dollars worth of donations in these envelopes. Before I hand over these donations I have a few points of concern that I would like to discuss. My first question is I would like to know how much the Bedford Auto Mile donates to the City of Bedford annually. City Manager Mallis said they don't give an annual donation; it's been an open policy. If there was something that was needed specifically, I will say last year they did make a donation to Bedford was either \$50,000 or \$60,000 last year, and then I believe they donated some portion to the Veteran City. Mrs. Rhoades said it fluctuates for 30 years, and am I correct that you put on an annual free catered breakfast to the Auto Mile to thank them for their charitable donations, and it's served here in City Hall in this very room? That the mayor and all of the Auto Mile owners are invited, and City employees are encouraged to come to thank them for their generosity. My company and I don't want a breakfast, we don't want a plaque, we don't even want a public thank you. But my company and I would like is a short meeting once a year in my office, which is a half block away from here so that someone can discuss with me how that donation money could be used. Ladies and gentlemen, I truly cannot express my profound disappointment, but I have to literally chase down people to throw free money at them. I find it crass and distasteful to have to make a public display of my generosity. Those who know me know that I find my philanthropy here in Bedford to be an intensely private matter, but I will not be ignored in my efforts to help support the City I love. Next year I expect at least one member of this government to make an appointment with me at my office so that we can discreetly discuss how my earmarked domain donation may best be used to improve the City of Bedford so that I can be assured that will be used in accordance with mine and my company's values, or we can expect a repeat of this fiasco next year. The second thing I need to address is that Councilman Don Saunders will cease to apply to residents in and around the City of Bedford that the only reason that I adopted my two youngest children is for a stipend that by Ohio State law I must

proportions. My question is if something God forbid should happen you know that a disaster that magnitude would happen here in Bedford Northeast Ohio the electrical grid crashes and we have another supply chain problem or whatever does the City of Bedford have a well-thoughtout plan put in place that they can implement immediately if indeed something like that should occur? City Manager Mallis said that I can elaborate on that so I could get into a couple of the items we do I mean on a small level as far as something like that we would obviously be partnering and working directly with the County Emergency Management office. On a smaller scale if we had a mass outage here of some level for instance thinking of a disaster let's say electrical and you know we have a number of our facilities that are equipped with generators. We have a relationship with the Red Cross where we could actually and we have in the past for instance with bad storms you hear of power outages. Our concerns are about seniors not being able to heat their homes, whereas if we can transport them to the Ellenwood Center where we would have the Red Cross station there. I will say I in 20 some years we've done that maybe five or six times no ones ever showed up or no one's ever asked to get transported. A lot of times people just don't like to leave their home, but on a small scale we do have plans in place for things like that. We will rely heavily on a major event of that nature we will rely on Emergency Management and you know our team here when something specifically happening in Bedford, obviously is the Fire Chief, Police Chief, myself, and obviously Mayor Koci, that we have in place as far as where we're at. We heavily rely on Cuyahoga County, Chiefs Associations and things like that. There's a number of items that we've talked regularly not just because something that might have happened in another part of the country, we've talked about regular training not only school shootings God forbid, but we do training with all of our staff for any type of event. Here we do training with our staff that may happen at if it's at the Service Department or Recreation Center, where do you go, what are the lockdown procedures all of that we do it. It's done regularly through our staff that are trained in situations like that within our Police Department it's one of you know not to keep going on and on, but we all say we have some of the greatest staff, and we have truly great people here and within police and fire. Their training you know we rely on and hopefully we never have to depend on that.
