BUDGET HEARING MUNICIPAL COURT

City Manager Mallis said that he has been working with Mr. Day for nine years now, that the Municipal Court and the City are good friends, and that they are a resource for the City. He also said that Mr. Day was one of the first to help handle the closing of the University Hospital. He said that Mr. Day gets creative in helping with the costs of the building.

Mr. Day said it is amazing how well the court works with the City. He said that Judge Melling thinks it is wonderful how well the City works with the courts. He said that Mr. Downing's term ends on December 31, 2023, and he will reach out to Council soon. He also said that the court's caseload has increased. City Manager Mallis said they are seeing many non-profits paying for someone's utility bill.
