DISCUSSION OF AGENDA

Ordinance No. 009-23 City Manager Mallis: We have been working with Liberty Development and the site is tricky, so laying it out and trying to find business to go into those spots. Drew from Liberty Development: Liberty Development was just awarded Lakeshore Electric this past week. Lakeshore Electric is a fifteen hundred square foot building, and they want to grow. Industrial buildings are our main supply chain, we start moving this spring. City Manager Mallis: attracting new business is important but keeping business here is important as well. Drew: We are a building and hold type, we build to suit. There is no constant traffic. City Manager Mallis: Sooner or later they will be going to the Planning Commission. We have been working with the Land Bank for the purchase agreement. The other way to go about it is that we can work up some quotes and get reimbursed for and state it in the purchase agreement to have that language in there. Drew: everyone who is working on the project has all of the information on the project. City Manager Mallis: This is a very good project. Councilman Genutis: Everyone will be very happy with what is going on down there.

Ordinance No. 008-23: City Manager Mallis: We have a local company and a new company going in down there.

Ordinance No. 10,048-23: City Manager Mallis: We amended it and to put in on Second reading.

Resolution No. 2597-23: Mrs. Howland: This is in regards to moving over with RITA and adopting their rules and regulations to administer the taxes.

Ordinance No. 004-23: City Manager Mallis: To outfit the vehicles and that the City has worked with Hall. They come out to outfit the vehicles.

Ordinance No. 005-23: City Manager Mallis: This is to share a Building Commissioner with the City of Brooklyn. If getting the right person for the position, they would be City of Bedford employee and that the City will bill for the time with the City of Brooklyn. We will continue to use Safe Built for the industrial inspection. The City of Brooklyn did pass legislation on it at their meeting last night.

6. REPORTS

a. City Manager

City Manager Mallis said that the renovations to the pool house started last week and that they're moving along very quickly. He said that a lot of the demolition has taken place, and they're going to be doing some underground plumbing and electrical work. He said that the goal is for the project to be completed in time for the pool season this summer. He said that we'll continue to provide Council with weekly updates as we progress. He said that, as a reminder the majority of this project was funded through Grant dollars, and a portion of it was funded through or by the City's ARPA Allocations. He said in regard to Parks and Recreation Department that a full booklet is being mailed out to all the residents, that will detail all of the upcoming winter and spring programs that the department is going to be putting together. He said that there are going to be a number of open positions and that some are already posted on our City's website and social media accounts. He said that there is a position that is currently being advertised within the Building Department, and we anticipate some positions will be made available in our Public Works Department, so please keep watching for those advertisements. He said that if anyone is interested, apply to open positions. He said that as of today, we are advertising for lateral transfers for the Police Department there is one opening in the Police Department, and we anticipate multiple openings later this year due to retirements. He said that the Cleveland Metro Parks recently communicated with the City that they're going to be commencing their Deer Management Program, and that is going to be taking place in the Bedford Reservation beginning today and running through March 16th. He said that the hours will vary and that the park will be closed, and signage will be posted. He said this is a reminder that this is their annual Deer Management Program. He said that the City has been working with a contractor as well as Cuyahoga County officials regarding Union Street, specifically Union Street bridge, and that it has been a topic at some meetings that bridge and that Councilman Saunders had referenced that it's not a bridge, but it is in need of replacement. He said that it is going to be a major

challenge and that initially they projected that job to take place and be completed within one calendar year. He said that will not happen and that they're actually looking at other options to move all of the utilities, which are in the roadway, into a separate utility bridge. He said that it will most likely extend this project to a two-year project when the actual bridge portion of the works being completed that roadway will be closed. He said that they're looking at this project to take place from 2024 through 2025, but no agreements have been made. He said that the contractor actually needs approvals from the City in regard to right-of-way access as well as some utility approvals. He said that the City has not granted that yet as there's some questions and concerns, and we'll continue to update the public when an agreement is made, and when we have a better timeline for that project. He said that there have been a number of questions regarding streetlights, our auxiliary officers did a full assessment and a patrol of the community late last year, and they compiled the list, all of which were submitted to the Illuminating Company. He said that they have worked to start repairing some of those, and in case you're wondering if any of the lights near your home or business were included in that list, you can contact my office, and we can answer that question for you.

b. Law Director

Mr. Montello had no report this evening.

c. Finance Director

Mrs. Howland said that the City has joined the Regional Income Tax Agency and to remind everyone to start filing their 2022 taxes with the Regional Income Tax Agency known as Rita starting February 1st of this year.

d. Council Reports

Councilwoman Spinks notified City Manager Mallis that yesterday two gentlemen were knocking on doors and ringing doorbells asking to see residents' electric and water bills. She said that she had talked to you, so I just wanted you to touch base on that. She said that she wanted to let our seniors know that if you don't know someone, you have the right not to answer your door and that you can deny them your

water bill. She said that is personal information and everybody needs to be registered if they're going door-to-door, especially with yesterday being a holiday. She said to be on alert because there are scammers out there, so you should never allow them to come into your home. City Manager Mallis said anyone soliciting has to apply for a solicitor's permit through the Police Department. He said that if someone does come to your door you can ask them to see their identity and that he doesn't know if any permits are out now, but he will check that and advise the Police Department to watch for any solicitors and speak with them if we do identify.

Councilman Smith: Happy New Year. I was going to touch on the light situation. As far as light being identified of the poll lights being identified in the city. I would like to say, if do if there is something in your neighborhood or on your street and the lights are out, please feel contact the city. If in my work, please contact me. They have begun to work on these things, and I see that I've seen several in my Ward that they have fixed. Oh, thanks a lot for the work. And please thank those Hillary police and the police department for doing their due diligence.

Councilman Asbury had no report this evening.

Councilman Saunders: Since Mike brought it up the Union Street Viaduct. And it is a viaduct, not a bridge, It is a stone bridge that's completely filled with dirt. Each one of those arches is filled with dirt, and it's an actual paved roadway over the dirt. That's why the utilities are such a factor because the utilities go through the dirt also. So, it will be replaced with a bridge. So, the old stone viaduct, which a lot of people think is historic, will no longer be there, which then brings up the topic. Have we gotten confirmed that when ODOT replaces it with a bridge that we can get a stamped sandstone concrete put in? So at least it has some remnants of what it used to look like?

widening of the sidewalks as well as stamps stone veneer. They did commit to that. We have the ability to choose at the time between a couple of different options, and we're not there yet.

Councilman Saunders: Okay. Well, I'm sure they're still working on the plans because this is a unique situation, because everybody just assumes it's a bridge where you just take it off and replace it. But it's not. They're going to have significant earthwork. That they have to remove from the structure and the utilities are going to be the biggest headache in the whole ordeal there. At least it looks like it's going to go after both Broadway and Northfield Road Bridge. Originally it was scheduled for this year, I think it was, and we would have had one hell of a headache with everything under construction at the same time. But yeah, I said right from the beginning when they said, Oh, we can do it in a year. No you won't. I worked on that bridge years ago when I worked at the county engineer's office. So in any case, let's hope we can get a final product that at least restores some look to the area. My usual comment in January is, of course, parking on the streets when it snows. We just had a snow. And of course, people don't use any common sense. They park the car out in the street, crack at dawn and come home at night. And if they're lucky, they take it in. That affects our plow, driving the street, cleaning, and everything else during this time period, I would assume we're getting it. I don't know if our trucks call them in when they go by them. Hopefully that's the case because eventually, hopefully, some of these people will learn. We're not other communities where you can park your car in the street 24/7 and forget about it. We have difficulties on some of our streets because they're narrow. We're on the residential streets and when you're parked on the street you can't get round it and the piles are big on the aprons it is very difficult to swing the get out of your driveway. If you're backing out also, because most of our driveways are only eight foot by nine foot wide. So, you don't have to swing around. You have to take both lanes for it. So please be courteous and try not to park across from someone's apron also. And in the winter, it's even more critical.

and handicapped as far as transportation. And that was due to a grant that we received that is now covering 50% of every trip that we provide. So, it just thought that was important to identify as what we had stated would happen is indeed happening and got to give credit to the Parks and Recreation Department. And I'm working on that grant, which also subsidizes our meals to our senior department, as well as all of our programs that we are now providing. That grant covers 50% of that. So, we're offering more at less cost.

So, I didn't know if there was a strategic plan laid out to attract businesses. Bigger businesses up in the North feel the Roxy area. That Plaza has been dormant for a while. I did see trucks up there and I'm just wondering, I'm hoping that there is some type of what our tax dollars and the taxes steadily going up.

So, what we did years ago, we had reached out, we worked with actually a private consultant. We did a study for that area. It was at that time and there was some debate, you know, there was one public meeting. There was a debate that we should go after more retail. We've worked out what other communities did and identified in city council, approved a mixed use development, so all the zoning there had changed. And by changing that zoning, it facilitated the construction. The purchase and construction of the new Mazda site. There is another dealership that has purchased the 11 acres at Bartlett and Rock side. So, there's going to be construction, we believe, taking place this year. That's their hope. The company that purchased the Wal-Mart facility, there is a distribution company in there. So, a lot of that wouldn't have taken place. What is happening on the opposite side? I don't want to say there was litigation, but there were some active debates between two property owners of Walmart, Target, so the former Target footprint and then all of those little stores we had, I believe there were three separate businesses that wanted to go into those stores. They could not go into those stores because it because it wouldn't pass the building code, because the edge of that strip was on the target parcel and the owner of the target parcel, they needed to work through some things. I can say that as of the end of last November, that has been worked out. So, we anticipate some things are going to be happening. There is in regard to that, some of those spots failing. You know, we one of the things that we've strived and stressed about is it's not so much about development, but it's been about redevelopment. And I think the city has been really good in areas of, you know, we talk about at the end of Harrison, it was an abandoned building there for I think it was abandoned for 23 years. And creatively our staff were able to obtain the property, tear the property down. We sold it and obviously a business bought it and has moved over there. The same thing has happened for the YMCA. That's redevelopment. How do we look at a piece and, you know, make something happen out of that? Although the company has not moved in there yet. An engineering firm has acquired that. They're actually investing almost \$700,000. So, there's going to be upwards of 25 people, professionals there that will help towards that tax base. So, I think it's a lot of, you know, while we do work and I think this the item that was passed this evening for Tinkers Creek Commerce Park, that was a lot of heavy lifting. And we talk about that after the fact. But, you know, we're not Bedford is, as you know, in a dense community. We don't have acres and acres and acres to attract. So, you know, that was our big area where how can we facilitate movement? The reason nothing's happened is that property was being listed at 100 to \$125,000 an acre, and it was appraised for \$50,000. City Manager Mallis: [00:51:58] Nothing would ever go there.

And now we're finally seeing that.

Ms. Cloud: So, my concern is there will be a bunch of firms. Well, I don't know if it will be a bunch of firms and businesses in there, but nothing that would attract foot traffic and, you know, people going in there to shop. So, I don't know if that's part of the layout. I'm hoping it is that there's some businesses that are actually retail that will go in there so far so families can shop, you know, people can eat and dine or whatever, because I just know that A.B. left so now we have to travel so much further now to get those types of services.

City Manager Mallis: I understand that that property that is under contract, someone's going through their due diligence, another type of retail operation. I can tell you that we are we do actively try to bring in restaurants. Those are the hot topics and even work out ways that we can assist our downtown district. A few years ago, we actually provided, I believe it was a storefront program to it to assist some of those local businesses and some of them, you know, I remember 15 years ago I was talking to some or maybe it was 20 years ago, I don't know. And they were upset that, you know, there were a couple of businesses leaving and at the time they were nine all shoes and Romeos. And I'm like, well, you know, 85 years old, these okay to retire. And we've seen some of that take goes to a train shop. The gentleman he's retired and that was you know we didn't want to see that leave the same thing went for the music shop. I mean I took my guitar lessons there when I was five years old. So, we're seeing some of that. I think it's our goal to, yeah, we need to be out there to one that we can help facilitate. If individuals bring something to the table through planning, if there's any programs that we can provide. I know we have recently shared some thoughts with the county who used to offer grant and storefront dollars for new businesses or existing to replace signage and facade. They know they cut all that. So, we don't have the luxury. Of like some entitlement cities get like, you know, not picking on them but you know, your Lakewood's, your Euclid's, your Cleveland Heights, and there's over a certain population, they get CDBG money every year and they can do with it as they may. And that's why those cities have their own maybe storefront or we're going to offer our own small business grant bed for because we're small like all the other small communities. We have to apply for grant dollars, and it's got to be used specifically for that. So, you see a lot of cities. This past year we applied for funds to make necessary repairs for the downtown,

like the train depot and things like that. And I would recommend it if you had it. State of the city that's posted online. Take a look at that. There's a project that is going to be taking place later this year to expand the Commons, to which I believe will not only attract, you know, residents to that area, but visitors and all year long. And I think it'll further create an anchor for the downtown and businesses that want to be there to increase that foot traffic. And we're basically taking the whole back side of that and doubling the size of Bedford Commons with a water feature, things that we could do in the wintertime. So, you know, there are things that that are happening.

So, my last question along the lines of attracting businesses are there and I don't know how this works with the cities, but does have partnerships around partnerships with places like Jumpstart and Cozy and Urban League and the Small Business Development Center on a business, all the candy shops. And I don't ever remember ever coming up as want to have to do my own research and come up here to City Hall. I didn't know if that was partnership or conversation.

City Manager Mallis: We work with them. We obviously work through there's different programs too, through the county and through JobsOhio, things like that as well.

Ms. Cloud: I just want to know, is there if we wanted to just know more about what was going to be happening as far as the economic development, is there any way the citizens, the residents can find out or we just need to attend the meetings?

City Manager Mallis: So, when they pass it an emergency And John, if you want to jump in, all of our legislation states that when city council suspends the rules, for instance, like the development ordinance, and we're trying to sell that and enter into a contract with the developer so they can start their due diligence and hopefully see new construction when something's passed on emergency, it's suspending the rules. If we did not do that, it would go the three readings and then after the third reading it still does not go into effect that it is legally bound to wait an additional 30 days so, items just to expedite business and that's why it's passed.
