a. City Manager

City Manager: I want to give a shout-out to our Parks and Recreation Department. They were just recently awarded a \$15,000 grant through a division of Cuyahoga County that will go towards additional programming, both sports and other programs, at the Ellenwood facility. So I just wanted to give them credit. They've been doing a great job down there as well. As, you know, a couple of months ago, we sent a mailer out from the Parks and Recreation Department, the booklet for the upcoming programs and classes. We also sent out a Good Neighbor guide, and it's something that we've put together over the years and, you know, frequent questions that come up. Helpful phone numbers. Anyone that does not or did not receive a copy let us know. We have some here. Thanks to the staff that works to put that together. Just a quick update on the Pool House renovation project; we are on pace to have that completed in the middle/end of May prior to the swimming season. So that is going according to schedule. We've also hired a new building commissioner, and that person will be looking to start towards the end of March. It's a position that has been hard to fill all across northeast Ohio due to certifications. The City of Brooklyn was in a similar position as we were, and we put our heads together and found a way to basically consolidate, and hire an individual that is going to assist in those managerial duties for both cities. And one, we got an outstanding candidate, which is he's going to fit in great, and so will be it'll be a cost savings to both the City of Bedford and the City of Brooklyn. So I have to give a quick shout-out to former Mayor Gallagher; we spoke with her and came up with this plan prior to her leaving to go to be a member of our county executive Ronan's cabinet. And then Mayor Van Kirk, who took over for Katie, was on board, led the plan, and we were able to get a great candidate. And lastly, I just want to talk about it, and I know Councilman asked a question. The last meeting in February was about the rails, and safety. Do we have a plan? And yes, we have a plan. And, you know, both our police and fire chiefs, as well as the Office of

Emergency Management, and how we would respond to that. But what I did want to add since the last meeting with the Northeast Ohio Association of Mayors, and City Managers Association obviously has been talking about this topic. We've actually, as an association, drafted correspondence that went to the Federal Rail Administration, but it was also sent to Senator Brown and Senator Vance. There was a congregation of some mayors that were in D.C. last week. They did provide a copy of that letter to not only the senators, as mentioned, but to others throughout Ohio to talk about, obviously, our concerns, You know, some things that we would like to see. At the very least, we think that communities should be notified. When these rail lines are carrying toxic, toxic materials to our communities. What are those materials? How often are they coming through all of that? I can tell you that on March 1st, they acted very, very quickly. And I have to give credit to Senator J.D. Vance, Senator Sherrod Brown. They did introduce a bipartisan partisan bill, and it would tighten the federal oversight of the rail lines, specifically when it deals with hazardous material shipping. That act that's going to be discussed in Columbus over the next couple of months is the Railway Safety Act of 2023. And as I said, it was co-sponsored by both senators. That bill, there's a lot to it. And I'm not going to touch on every single piece, but it will introduce a number of safety requirements for the trains. There are other requirements that are in there. And the last thing is actually something that I'm very excited to see, but it touches on the requirements of train length, train weight, the route analysis of all of the routes, and speed restrictions. And then the last item that they touched on is eliminating the blocked crossings from train delays and train stoppages. I hope that this gets streamlined and passed. We rely on the Office of Emergency Management and then Mutual Aid as well as our obviously our fire and police. But it is good to see that some of these concerns are getting pushed through this bipartisan bill, and hopefully, it does get passed. One of the benefits of working with the Mayors and Managers Association is that you bounce ideas off of one another. And when there's an issue like this that happens to ensure that we can work together and, you know, just one of us sending correspondence to Columbus for our senators, you want to hope it makes a difference. But when you have all of the mayors and city managers from northeast Ohio sending that correspondence, it carries a lot more weight. Hopefully, things get pushed through pretty quickly.

Mayor Koci: And that can't happen quickly enough because Norfolk Southern had

It was a big help, and that will be going up again in November this year and save the date. The fifth annual Chocolate Walk will be on Saturday, May 13th. The lanes that are down on Maple Dale are Spectrum's lines I know it looks bad. We've been looking at it for about a month or so now. We have contacted them and trying to get them to clean up this mess. Spectrum, I guess, is the easiest to deal with. But we're going to pursue that and try and get that cleaned up. The Good Neighbor Guide, Mike, if I can get a handful of those for some residents that haven't gotten them.

Councilman Saunders: First, I want to thank Mike for pursuing the railroad fiasco that's been going on in the state here. And actually, it's not just our state; it's others, too. It's good to see that action is starting to be taken. I'm worried that a lot of what the state is proposing in this new bill, which I read a lot of it myself, is going to get trumped by the federal government because, technically, the rails are the responsibility of the federal government. And whether you can regulate them to any

degree is still questionable. But it's good to see some action because then the railroads know that they're being watched. So I'm glad to hear that they're looking at the actual length of the trains because these trains are getting so long that you can sit at a crossing for 15 minutes because there are around 200 cars on some of these trains. In any case, here recently, there have been a lot more people who have been putting their rubbish out on Friday, at least in my ward, it seems like, especially along Northfield Road. We need to somehow inform these people that you can't put your trash out until the day before a rubbish day. And since rubbish days are either Tuesday or Wednesday, that means Monday or Tuesday, not late Friday or Saturday, because animals get into it and everything else.

Councilwoman Spinks: I've gotten about seven calls this weekend about the speeding on Greencroft. And, of course, what's happened, is that the cars are speeding so fast that they lose control. We've had a couple of residents that had cars go up in their tree lawn or their lawn. And the bad part about that, is then when that happens, and it happens in the middle of the night, you get up, you hear it, and then you get up, you have no license plate. So what are you going to do? Are you going to call the police? Why are you going to call the police? I mean, they're going to see the words, but they're in your yard. But what are they going to do? But what's worse is this little lady that takes such good care of her yard now has these huge ruts, and she's responsible now for fixing that. And it's happening more and more. This morning when I was out doing my routes on my way to go teach in Shaker, I must have picked up three bags of liquor bottles; I'm thinking, okay if they're throwing these out their windows. So what does this mean? They're drinking and driving. Any after you clean all that. Well, I'm. Why I'm there. Here comes that. I'm standing right in front of these big, huge signs, which thank you, Mike, for making sure they're all over the place of no trucks. It's big. You can't miss it. Here comes this big 18-wheeler that went in the Mercedes side lot on Greencroft, which is a dead-end street. And I'm out there pointing to the What are they going to do? Mike, the big trucks again; I took pictures, of the company and stuff I will send them to you. I was not here at the Council Meeting regarding the discussion of backyard chickens, and it was on our work session tonight. First, as a resident, let me say that I'm a farm girl. I'm very proud, loved being raised on a farm, and I have a love for animals. I have a big spot for chickens. I like them. They're farm animals. But now I'm speaking as a Council Member that I have only received two

emails from people wanting chickens. I have asked several people in my Ward. Most of them were like, no, because we've already had so many problems with the deer. You know, people feed the deer, and we have rules against that. My feeling about it is, they are farm animals. And most of our lots here are small; they're not really big. I'm on several different boards, and I'm a very proud board member of NOCA (Northeast Ohio City Council Association). We have weekly meetings, and I was talking to the Garfield Mayor, and they are having trouble with people getting the permits to have the chickens. They're just getting the chickens, and they're just putting them in their backyard. We are a city of over 13,000, and I believe everybody has the right, whether they want something or not. Everybody has the right to decide. Chickens have personalities, and they know they're not like a dog. They don't bark; they don't bite, but they do like to scratch, they will fight with each other, and they do get stressed out. Chicken poop is good fertilizer, but it's also full of parasites and contamination. There are other creatures that love chicken feed, so there's more that goes into it than just putting a couple of chickens out in the backyard or building a coop. In my opinion, our Building Department is already stressed, and we are getting another building commissioner, but we're going to share him. So who's going to enforce this if we can't keep people from driving drunk and going into someone's lawn, possibly hitting their house, mattresses out that aren't covered, and then they stay out for weeks, our trash cans out for weeks, people parking in their lawn, people not taking care of their house, going to court, and then they're given this and that. And that's another thing. Where's all this going to go? Again, this is just my opinion. As a resident, I think farm animals belong on a farm where they can have plenty of space and be healthy.

City Manager Mallis: They installed the first sign The second sign when it was installed, we got to get a pole that is stronger to reinforce it because that solar piece, there's also a battery behind that. City Manager Mallis: We received a tax abatement application from Cleveland Tank and Supply. They are the company that is planning to relocate from Cleveland to Bedford with their employees, ultimately increasing their employees. Over the next few years, over 60, they fabricate tanks for school buses, fire departments, both diesel gasoline tanks as well as hydraulic tanks. There will be constructing a roughly 60,000-square-foot facility in Tinkers Creek Commerce Park, and they applied for a ten-year, 70% tax abatement. So those are my thoughts.
