District. We hold our Mayor's Meetings along with our Clergy Meetings monthly, so thank you for this opportunity as well. Our Superintendent is at another Council Meeting tonight, so she asked me to fill in. But just a couple of quick things about what we're doing with the school district. One of the main things we do and will be pulling a ballot in November for our facilities. And one of the great things about this ballot is that we haven't had a ballot on the agenda for over ten years now. We never had a bond, and we have always been financially fiscal, which is great. Another thing we are looking at are building new buildings. We have several buildings that need to be improved, so we've had several monthly Facilities Meetings as we have a lot of great things. Academically, in our high school, we're still moving forward trajectory with our graduation rate. We have our one plan that's connected to the Ohio ODE's Connected One Plan. So we're really moving in the right direction. There are a lot of great things going on at the high school, and I really appreciate Mayor Koci's and the City of Bedford's support of our schools.

Mayor Koci: I just want to make a remark that I was with Superintendent Johnson at a Rotary Club, and she invited four students from the high school to attend. I had a chance to meet these kids, and there are some great kids at the high school; the kids there want a good education. As these four kids, when they were telling me what they do and all the activities that are in just listening to all the things they do, these are good kids, and that needs to be brought out more often, I think.

Mr. Vawter: We have several different buckets, if you will, of students and what capacity they serve in. So we have some students who are in the trajectory or the bucket of going into education. So we have future educators of tomorrow, and they're taking classes specifically to groom them to be teachers. I don't have the specific numbers, but a majority percentage of our students are teachers, classify and certified, have graduated from before high school who are serving, and who are employees as teachers or security officers, custodians, or secretaries. We have a lot of people who graduated from high school coming back to serve in that capacity. Another area that the mayor is talking about is we have students who are in there are in the Fine Arts program, students who are in our CTE program, and they're students who are saying, hey, I just come to school every day. One of the things we are doing, which I think is awesome, is that we are currently in a consortium, Bedford, Shaker Heights, Cleveland Heights, Warrensville, and Maple, and we share the cosmetology

and other career technical education programs. Well, what the school district is doing under Dr. Johnson's leadership, we would have our own city where our kids will not have to travel to Cleveland Heights, Shaker Heights, Warrensville Maple. We will have those city or career technical education programs right here in our school, in our district. Our kids won't have to travel. You know, our way on a bus from here to Cleveland is not to take you out; it is not going down one list in a row. But we will have those programs right here back in our high school and middle school for our kids being a product of Beverly Hills School district. I went to Care Elementary, Heskett Middle School before going to high school, and I remember taking woodshop in middle school; I remember we had our hallway, and in that hall, we had home economics auto mechanic. In fact, we had two auto mechanics, and we still have all the tech, but we had auto mechanics and a body shop. We also had drafting, engineering, and cosmetology. We cut hair, did massages, and had Home Economics, where you learn how to sew and cook. All those programs that we had, we began to outsource those things, and we share them with our surrounding districts. And there's nothing wrong with that. We're not disrespecting or downgrading our other colleagues in our surrounding districts, but Bedford is unique. We are a trendsetter and a leader. And so we're bringing those programs back to our school and our district. And we want to attract those students, those parents, those community members into our schools, because that's what we did when we went to Bedford. So a lot of those programs, construction, woodshop, auto tech, body tech, body tech, things like that, we will have at the high school moving forward.

a. City Manager

City Manager Mallis: A couple of items really quickly. First, just wanted to congratulate Sergeant Kempski and Eagle Scout Armstrong. Both of those recognitions are very much deserved. I want to commend all of the first responders, our Fire Department, and the individuals involved in yesterday's incident in Oakwood Village. You know, obviously a tragic accident. And our staff was right there to help both Police Department and Fire Department, as well as many others; that is what they're trained to do. All those classes and the training they undergo show in situations

like that. I just wanted to commend the Bedford Fire and all the other Fire Departments involved. The Fire Department just completed a grant application for \$1 Million through FEMA to replace our ladder truck. You have to start these projects now; the ladder truck is probably three and a half years out if we ordered it today. Our ladder truck is a 1992, and these are north of 1.5, probably closer to \$1.8 million. But we're starting that process, and we did submit that application. The \$1 Million request was the max that we could have. If we could go for more, we would, but we did go for the max. Also, there was a recent announcement by the Board of Elections; if you recall, last year, typically, one of the locations is at the Ellenwood Center for voting. Last year during the Special Election in the summertime events, Ellenwood was not a location, and that was an agreed decision by the Board of Elections as well as the City of Bedford, just because of the amount of activity taking place at Ellenwood during the summer with all the children in the camps. And obviously, when you throw in voting, there's a lot of traffic, and it just made sense not to have that at Ellenwood, and it is coming back this year. So Ellenwood will be a voting location. So for those voting in person, check the Board of Elections to see if your precincts are to report there. None of the others will change. I also wanted to talk about Sergeant Kempski, and I know that Mayor Koci mentioned it as well as Police Chief Stemple, but I have to commend our entire department, especially our Detective Unit. Over the last few weeks, we've had some unfortunate incidents that, you know, their expertise, the leadership over in that department, working with them day in and day out, we were able to make an arrest for a suspect that was traced to Georgia. And our staff was able to, obviously, with the assistance of a number of different agencies, identify and apprehend that individual. Secondly, I wanted to touch on and to thank City Council for supporting our initiative of installing flat cameras. A few meetings ago actually might have been a little longer. It might have been in earlier in January, the City Council authorized the administration to install 16 Flock Cameras north of \$40,000. We installed these obviously for investigations, and these cameras are at the entrances of town in various locations and their license plate reading cameras. Last week, there was an incident in Maple Heights involving a shooting. Our detectives and our officers worked through the newly installed Flock Camera at the corner of Turney and Lee. We identified that vehicle through that newly installed camera, which is now operational, and provided that information to Maple Heights. And they were able to make an arrest. So, you know, within one week of those cameras being up and running, they've already proved to be valuable. So I appreciate City Council's support

on that initiative and that expenditure. It's just another tool, another resource that we can use to address unfortunate situations. But, you know, hats off to both our Fire Department and our Police Department; it's been a busy beginning of the year, but they're handling it in stride and doing a great job.

b. Law Director

Mr. Montello: Congratulations to Sergeant Kempski and Eagle Scout Armstrong, and I would urge you to support the School Levy this November.

c. Finance Director

Mrs. Howland: Congratulations to Sergeant Kempski on his promotion. I also want to congratulate Joshua Armstrong for his Eagle Scout designation. I just wanted to make sure everyone was aware that the Civil Service Border Commission is advertising for a police officer because of this now new opening from Kaminsky's promotion. And at that, the application deadline is March 3rd. So if you know of anyone that's been in police work for at least two years, they can go ahead and apply before that date.

d. Council Reports

Councilman Fluharty: Congratulations to Sergeant Kempski. and also City Manager Mallis the Group Homes over on Pinecrest, the cars are flying down the street again. It's regarding the new one that came in there. I've been getting some calls from them up there.

City Manager Mallis: The one home that we're familiar with?

Councilman Fluharty: Yeah, you might need to stop over there and tell them that when they get off work, don't fly through the neighborhood.

Councilman Smith: Welcome to everyone. Welcome, Mr. Vawter. Congratulations to Sergeant Kempski and to Eagle Scout Armstrong. As City Manager Mallis touched on the cameras that we currently installed, as you can see, they are really helping us and our City. As City Manager Mallis said, within a week of those going up, this incident happened right away, and Maple Heights was able to make an arrest. So, again, the cameras are working. Some people in the City thought that we were doing this to

track them, but no, they are doing their job. And also, I'd like to mention that the Ward Meetings will begin this spring. I'm looking forward to that and those people that I have not met. I will get a chance to meet them, and they can meet me and see who I am.

Councilman Saunders: First, I want to thank the schools for bringing back the programs that were there back when I was a kid. Not everybody is bound for college, and this way, they are getting training, which people don't realize, but you can make a good living in some of these programs, and you don't have to necessarily go to college. It's good to see that the school system prepares our youth for a possible alternative rather than college. I know the state pushed for the newer facilities because of the new classroom requirements and all that. I've been involved with the Planning Committee, which, by the way, we have another meeting Thursday at Columbus Road School. But I hope the people will actually support the new buildings. The school system hasn't had a levy in many, many, many years. The school system financially is sound and it's probably one of the soundest school systems in the entire Northeast Ohio area. So let's show our support by supporting it in November and we can continue working forward as the school system deserves. I also want to thank our new sergeant and the police department. I'm sure he will do a good job. Filling police vacancies these days is very tough, as you can tell in a lot of communities that are all short-staffed because of it. I'm glad to see the youth are still involved in activities like Eagle Scouts; it's very tough to get to be an Eagle Scout. And as was mentioned by Mayor Koci most Eagle Scouts go on to bigger and better things to the point where they usually make something really good at themselves. I have a question for City Manager Mallis; over the last couple of weeks, I've got some concerns from some residents about if the City has an action plan set up within the City or with the surrounding communities in case something of this nature does happen so that we don't end up with the fiasco that happened out east.

City Manager Mallis: We have a plan between our Safety Forces, Fire Chief, and Police Chief. We discuss various situations. Hopefully, that never happens with our neighboring communities as well. I'm not going to speculate on comparing that situation to here. The obvious item would be a much different impact because of how dense we are, and how rural the area is in that community. But one of the other things we would also rely highly on is the County Emergency Management in regards to

that. I mean, we have scenarios in place for many incidents regarding securing a site, rerouting traffic, and notifying the public, all of which we do have in place.

Councilman Saunders: I'm glad to hear there's something there, because when you look at this train that derailed, it actually went through our west side suburbs, went through the City and Cleveland, and it went through most of the east side suburbs to the north. And thank God it went off the tracks in a more rural area. That's not to say it didn't create massive havoc where it did, but it could have been a heck of a lot worse. And like I said, we do have a main layout of Norfolk Southern through town, and their trains are getting longer and longer. And if what they're saying is true, that the longer they get, the worse they are. I'm glad we do have that somewhat in place here, which brings you to the north or Wheeling line. I think Wheeling needs to go out and do a walk inspection on some of the rails because they are starting to come apart. But any train derailment can become a hazard no matter what it is, so if we could get a hold of Wheeling and tell them that some of their rails are starting to show deterioration, it would be good.

Councilwoman Spinks: I'd also like to congratulate Sergeant Kempski. I sound like a broken record. Everybody's congratulated, but it's really important for you and Eagle Scout. Joshua Armstrong, also of the First Ward Meeting, will be Ward's One and Three on April 24th from seven o'clock to nine o'clock. The other ones will follow, so we will get those dates out. Also, the Bedford Historical Society's Reverse Raffle is going to be on March 18th. Tickets are on sale right now; you can get them at the Historical Society, at the gift shop. It's going to be at Elmwood Rec Center. The doors open at 5:00 p.m., and dinner is at 6:00 p.m. The grand prize will be \$1,000 this year. So if you haven't gotten your tickets, you can get them, and we are also selling tables. Also, City Manager Mallis, I know I sent this to you a couple of times this week, but the big car haulers have been coming down Willard over the past week. They are also coming down side streets again; that's really getting out of control. I've been getting quite a few residents calling about their parking again. I've sent you a couple of pictures and stuff at the end of Grand on both sides, which blocks people from being able to come in. That's not good. And I turned in the stuff about people parking, and once again, it's getting out of hand. It looks really bad. I've tried to have little cards that I keep in my car and put on doors asking them to please no parking on the lawn. One car got stuck in their lawn, tried to get it out, and they ended up hitting a

The gas line replacement on Cresswell, it's been going on for about six months now, and the residents are really happy. They're starting to go door to door to put the new meters on and stuff. I'm glad to see that at least some of those bad sidewalks over there will be replaced because of that. I've had a couple of residents ask me if we are going to be doing a sidewalk program this year.

City Manager Mallis: It's yet to be determined. We want to see where we end up with the Broadway project first. If so, we'll announce where that may be. We may actually if there are some funds, we may look at replacing certain blocks along Broadway. But we're not sure yet.

Councilwoman Spinks: Okay. Because when I get out and walk and stuff, that's one of the things that a lot of my older seniors do; this is a walkable city, and there's some of the tree line trees have pushed the sidewalks up. And I worry about the residents there in wheelchairs or on walkers who get out and walk. I'm just hoping that we may be able to do something about that later on. Happy Fat Tuesday not too many people here celebrate that for Ash Wednesday. And just like a big shout out to all of the residents, family, and friends who helped me celebrate my birthday, it was a really nice day. I received tons and tons of calls, texts, and emails from residents; it was heartfelt that they remembered my wonderful husband. That makes every day special. It's like every day is a birthday. and their children. -People who want to get back to Nature, get back to the garden, and get back to the land. I think those are lofty ideals.

More and more people are realizing our health is determined by our food. Sadly, our society, and particularly the lower classes, can never advance given the diets their circumstances cause them to eat.

It's not about the price of eggs but the quality of our food. Any of us know the goodness of a sun-ripened, homegrown tomato, and eggs are no different. In either case, the cost should really be measured by the cost of healthcare instead. Before, COVID, the cost of healthcare was approx. \$9,600 for every man, woman, and child in this country.

That's more than food, rent, and clothing.

In the 1960's only 4% of the entire population experienced chronic disease. Today half of all children 18 and under are suffering from chronic disease or some other condition, allergic to the food, or the environment. We are in a grave health crisis that is currently bankrupting society. It has been said that we will not even have a physically-able workforce in the foreseeable future.

A large body of published, peer-reviewed scientific research shows that pesticide exposure in unborn and growing children is linked to numerous health concerns we are seeing in our children today.

That's just the pesticides. The second concern is the diminished nutritional value of the food itself due to the depleted soils from conventional farming methods. Our genetic code calls for some 60-90 minerals and nutrients for our bodies to function properly. Kids today, due to our modern food system, simply don't have the minerals in their bodies to perform properly. They are having trouble learning and paying attention, comprehending great thoughts, and holding them. And this is across the entire population.

City Manager Mallis: This ordinance authorizes us to pay ODOT for the Broadway resurfacing project. This project is roughly \$3.9 million, actually closer to \$4 million. We did previously negotiate our percentage to 15%. Ultimately, after the redesigns, our total cost that we're looking at is \$1,296 billion, which is what this authorization is for. We are covering this through a couple of different areas. One, we're utilizing our second allocation. We only get to our second allocation of ARPA dollars, which is roughly \$650,000. We also have \$400,000 of our annual road program for this year that will get allocated. And then we've also encumbered some funds from last year, cost savings from last year's road program that will also go towards this. So in total, we'll be able to fund our percentage of this and or that can then make final plans to move forward with this project. But overall, actually, really quick. I'm sorry, Mayor. I do want to add, we have not had a pre-construction meeting. None of that has taken place yet. We don't have timelines or anything. Once that is done, we will provide notice as soon as possible to the public for going to start. And the Maple Heights side, are we starting at Broadway to Forbes any detours and anything like that we will share that information when it becomes available.

City Manager Mallis: But as we're working through the Pool House project, all the interior walls have been demolished. We've televised the main sewer that goes through the facility. It actually runs underneath the Pump Station. Multiple areas of that line have failed, and it needs to be addressed. It makes sense to replace that line because it runs under the building. We can piece make some repairs at three locations. Our recommendation is to replace the entire line now, while all of that is opened up because they do need to cut the floor within the interior of the building. Instead of something happening 10, or 15 years down the road where another area fails, we're now tearing up a building that has already been finished. So it's our recommendation that we make these repairs. The contractor is on-site, and we're looking to do an emergency repair because we still want to stay on schedule so we can open that facility up for the summer pool season.
