- \$9,110 increase in the economic development budget due to pay increase for the Economic Development Director.

7. REPORTS

a. City Manager Mallis: I just want to touch on something that has been in the media over the last few months and some steps that we've been taking in regards to the uptick in auto thefts. There have been many throughout the communities in Northeast Ohio as well as neighboring counties. We have been actively patrolling throughout the evening hours as well as daytime hours, and weekends, all along the Auto Mile, Broadway Ave., and Rockside Rd. Our officers have been doing a tremendous job communicating with their colleagues in other cities as well, who are facing some of the same challenges. The recent installation of the five flock cameras are also helping provide a deterrent. But we also need to keep in mind to lock your vehicles in the evenings. I want to give a shout-out to Sarah Lloyd in our Police Department, she took the initiative of contacting Kia, USAA, and Hyundai Corporation, and we did receive 160 wheel locks at no cost, and those are being made available to Bedford residents. If you go on our website or the Police Department or the City of Bedford's social media pages, there are details on how you can stop up here and get one of those for free if you own one of those vehicles. They are Kia and Hyundai-specific vehicles. We always say one, theft is too many, and we want to make sure that, you know, we're out and not to do that in our town. I want to mention that our new Building Commissioner will be starting next Monday the 27th. Just a friendly reminder to let individuals know we are sending out grass notices. And what we do is utilize our water department billing to determine it's our best way of identifying specifically those vacant houses, and empty houses that a bank may own. Those properties with zero to minimal water usage will receive a letter. Now, I understand that we do have

individuals that live in homes by themselves. We do have some seniors that use very little water that may receive the letter you're not in trouble. You're probably already taking care of your property. But this is the best way that we've seen works to try to get those notices out ahead of time. So those will be going out in the next 30 days as the grass will start growing. And I also want to mention and give credit again to the Police Department, specifically our night shift, for working on some of those qualities of life issues, our parking violations, the evening, parking on the street parking, parking on the lawns. We are on pace to more than double the number of parking citations that we've issued in the previous year. I think we're over 320,349 issued so far. Obviously, you know, we do. We wish we didn't have to do that, but our officers are out there, and they are issuing citations.

d. Council Reports

Mayor Koci: Before we get into the council reports, I just want to make a statement that in our work session, we took an informal poll on whether we want to pursue changing our animal ordinance. And with a 5 to 2 vote, we decided we do not want to change that ordinance. So we will not be allowing chickens in the City of Bedford at this point.

Councilman Asbury: The chipper service will be starting in April, so get your twigs and limbs all tidied up and ready. This has been a really bad year. Also, on April 17th to the 21st, and on April 24th to the 28th at the Service Department, a computer roundup and hazardous waste disposal. More information to come at the next meeting, but get your things ready for that and go on to the City's web page and get more information on what is acceptable. Mike, I haven't been down there this weekend, was there any change in the Spectrum lines on Maple Dale? City Manager Mallis: No, I do not believe those were removed yet; we'll reach out to them as well. I shared that it wasn't First Energies, and they're unable to touch Spectrum's lines even though they're on their own poles. I'll double-check again in the morning, and if they are, we'll follow up again.

Councilman Saunders: Do we have a date for when they are going to start the water repair placement on Ennis and Harriman?

City Manager Mallis: No, we reached out to Fabrizi, and we requested a pre-con for that. And at that point, we'll give that a proceed. They have all the materials, all of that was acquired throughout the winter. So as soon as I get that meeting, I will provide an update for you. One of the reasons why we didn't start sooner was that bypass with the freezing weather; wouldn't work. So, in the next couple of months, we'll start. Councilwoman Spinks: We had the Bedford Historical Society reverse a raffle this weekend, and I want to say thank you to everybody that donated and showed up and help. The next big event that's coming up will be our membership dinner on Thursday, May 4th, in Oakwood's Rec Center. On Cresswell, Dominion is finally done with the gas line replacements. Mrs. Howland: This ordinance is mainly the re-appropriation of grants and projects. In the General Fund, there is a movement of funds between personnel and other within the Building Department, Engineering Department, and Tax Department. I cannot make those movements of money without Council's approval. There is an increase in liability insurance. We need to budget for \$30,000, and a \$70,000 increase for I.T. services and for a firewall that's needed for City Hall. In the Community Development fund, we need to reappropriate the CDSG funds we received to replace the pool roof. The SEAL Fund we're appropriating carryover funds from the SEAL Drug LEF and Byrne Grants in the amount of \$181,000 and a \$253,000 increase for SEALE since they receive an ARPA Grant. In the Grants Fund, there are various grants and donations for the police and fire department up to \$60,000 that is being reappropriated. The Recreation Department received two grants this year, one for just under \$60,000 and another one for \$15,000. And we need to appropriate NOPEC Grant funds received last year and this year. In Fund 214, there's an increase for the SAFER grant. This grant is paying for two additional fire paramedics for our city for the next three years. In Fund 217, we're increasing the pool's renovation to \$500,000 and \$640,000 for the Broadway Avenue Roadway Improvement Project. In the Capital Projects Fund, \$265,000 is already approved for the pool house renovation, a \$677,000 increase for the Broadway Avenue Roadway Improvement, and \$90,000 for the purchase of the 890 Broadway that was just approved last meeting. For the Water Fund, we recently approved the Lincoln Water Waterline Project Engineering for \$78,500, so we are appropriating for that, and then for the Wastewater Fund, we are increasing the \$90,000 already budgeted for the purchase of the Rovver Basic System that was just approved. And then finally, in the SEAL Unforfeited Fund, appropriating \$1,166,000 for the year 2020 to 2023 unforfeited funds.

City Manager Mallis: The city has been a member of the OML Pool since 1983. They have been in operation since the late eighties. There's a large pool of municipalities that put in, and obviously, in order to get reduced costs, we did budget; we were on a three-year cycle. Our contract was three years annually. It was roughly \$220,000. This insurance covers facilities, equipment, staff, and a wide range of items. Obviously, the cost increased, and the new quote came in. A lot of that was based on disasters that had happened, flooding incidents, and obviously, replacement costs have gone up. Our costs did go up approximately \$30,000 each year for the next three years. But what that is primarily linked to is it has taken the OML Pool, has identified all of our facilities, Municipal Court, Wastewater Service, Ellenwood, all of that. And they previously had a value, a replacement value on it at approximately \$50 million. At the

City Manager Mallis: In 2021 Council authorized the purchase of the chassis and plow for a new salt truck. Obviously, we are amending this, we have still not received that. We were recently contacted by the company that received the statement, and they provided us with an updated cost, and we will be receiving a 2023 instead of a 2021. The old total was \$66, 941.11, and there was a new quote that is provided. We're going to be getting into the next ordinance as well. If we chose to only pursue one of these salt trucks, which the next ordinance talks about the 2022 that we ordered and still haven't received. If we backed out on one of those, the increase to a single truck, chassis, and equipment would go from \$66,000 upwards to \$90,000, almost a \$24,000 increase by agreeing to continue to move forward. And we are next in line to get these things outfitted by agreeing to amend this ordinance along with the next ordinance, which reflects our purchase of the chassis, plow spreader, and all of that for the next truck of 2022. We would see a total increase for both of those be \$34,807.75. We did just receive the actual vehicle for this piece; it is a 2023. We expect the next one to be here later this year, which would also be a 2023. We were told that if it wasn't available, they would provide a 2024; these are state numbers, and they have gone up. There have been delays due to the supply chain. These were budgeted for minus the increase that both of these ordinances combined would equate to.
