Ordinance No. 039-23: Contract with Plug Hug: City Manager Mallis: This piece of equipment is for the Water Department, and this does all of the work, and it will also help to get more hydrates repainted.

• DISCUSSION OF Air BNB

City Manager Mallis: we put together a simple application and shared it with Police and Fire Departments in case of any issues. There would be an annual building and fire inspection, and the rental fees would be \$150. I would like it to go Three Readings during the summer meetings. This would go into effect in January 2024. This would be for the short-term Air BNB and prohibit a commercial Air BNB.

7. REPORTS

a. City Manager

City Manager Mallis: We do have a water line replacement project underway on Harriman and Ennis. They will last approximately 90 days. Contractors should be on Ennis by the middle of May. What we do ask is that there will be no parking on those streets during that time. And it's an inconvenience, we understand, but a necessary improvement. I do want to mention that the City anticipates the County Council will be voting in the coming weeks on two grants; one is a CDSG grant of \$50,000 that we hope to be awarded for land acquisition. As well as a CDBG grant, which will fund \$150,000 of improvements to the Commons, the train depot, the public restrooms, and

the electrical upgrades that will need to take place with the expansion of the Commons that will be getting underway later this year. d. Council Reports

Councilwoman Spinks: I had to say goodbye to Mr. Lynch; he used to work in the Building Department for many, many years. I have developed a really close relationship with him through the Church of Nazarene, and through Dave and his brother Joe Lynch, who passed away last year, I was able to start a free basketball camp. They taught the kids not only how to play basketball but also how to be a good team player, how to be a good person, and to learn to defeat and learn from it. The sportsmanship that the kids learned from those two guys. I am not going to have a basketball camp; I am going to have a team-building camp that will be announced. It will be at Greencroft Park for Bedford kids only, not our school district for kids, and not just Ward One. It'll be a week-long thing, and the kids will have to register with the Recreation Department. Greencroft with the culvert.

City Manager Mallis: The base of the culvert that runs underneath Greencroft is failing. We also identified a void in the curb where it was substantial. Our plan today was to dig that area and fill it. When we did dig that, we identified a water leak. It actually was coming from Dominion Line, which was odd. They did come out on-site, and it was a Dominion drip box. The repair was made, and that's what caused the eroding. It did go under a portion of the roadway. That repair was made, and we then worked to backfill that to ensure the safety of the road and the top portion. We are going to look to figure out the best approach to address the repair to the base of that culvert. Most likely that could be a liner but we will we'll know that in the coming weeks.

Councilwoman Spinks: Do we have a timeline for it?

City Manager Mallis: No, not on that.

Councilwoman Spinks: The one good thing about it is that it stops people from speeding down, but lets the residents know to be patient. Dominion has completed their work on Cresswell, Mike, I think that they're done, and it looks nice. Friday, May 12th will be our speaker series for the Bedford Historical Society. The Speaker Series will be on Walker China which is free but, we do accept donations. That's at the Old Church at 7 p.m. next Friday. Also, the Historical Society will be open for the Chocolate Walk the day before Mother's Day so make sure you come to our gift shop, Ms. Schroeder has stockpiled our gift shop with a lot of stuff that a lot of mothers would love to have. I want to brag about the Bedford High School class of 2023; yesterday everybody set up their booths of colleges that they have been accepted to, and I could not believe how many of our graduates are going to college to be educators. It's very heartwarming to see that there were a lot of students going to nursing school, but that a lot are going into the educational field. Councilman Asbury: Mr. Commander, congratulations on your new position, and good luck. Sincerely, Bedford Graduate, 1983. As was already mentioned, we do have an issue on the ballot tomorrow. Ward two is still at the high school, according to the Board of Elections, and four and five are voting at Glendale. Okay. If you do see them, you can call the non-emergency number (440)232-1234three, and the police will come out and check. At this point in time, nobody is licensed to solicit in the City of Bedford. Do not feel obligated to open the door to these people. They can be pushy and rude. I'll say it again. Back in January, a gentleman came around from a cable company, and my wife said, "No, thank you." He didn't like that answer, I guess, and he fraudulently started an account in her name. And next thing you know, we have a box of equipment from this company, and we're getting a bill. It took almost three months, multiple phone calls and visits to finally hopefully get this situation. City Manager Mallis, do we have a time frame on Broadway?

City Manager Mallis: No, we reached out to ODOT following our most recent payment. We authorized the additional 50,000. So they did receive that, and we asked when the pre-con is scheduled, and they have not scheduled it yet. They did award the project to Shelley. But, you know, a couple of weeks ago, they had indicated that they

Ms. Henry: Give you an idea of Buckeye relief is what they call level one cultivator. We operate a 60,000-square-foot building with 25,000 square feet of area where we grow medical marijuana plants. And that's in Eastlake, Ohio. We also in that facility have a processing operation where we turn the oil extracted from those plants into other products like tinctures, capsules, edibles, and vape cartridges. And we have a dispensary, I think we had mentioned we have one in Cleveland Heights and one in Columbus. We are an Ohio-owned and operated company. We don't operate in any other state. We are here to provide medical marijuana to the patients of Ohio, and we don't have aspirations to go anywhere else. But we'd be more than happy to answer any questions that might have.

Member of the audience: What zone is that building on exactly?

Mayor Koci: It will be in Ward 2 along Rockside Road.

Member of the audience: What zone is it?

City Manager Mallis: That is a Mixed Use District, and when it was established, this use is a conditional use, which meant they had to go in front of the Planning Commission first and then ultimately here at City Council.

Member of the audience: What other areas of the area are now basically specific areas where that kind of retail will be allowed?

City Manager Mallis: The medical marijuana as of right now only permitted in the Mixed Use District.

Councilwoman Spinks: This was part of our work session, how Ms. Henry explained it to us is that you can't just walk in there and buy gummies or whatever.

Ms. Henry: The general public is not allowed to enter a medical marijuana dispensary. To come into a dispensary, you have to be a registered patient, which means you have one of 25 conditions that are approved by the state of Ohio to qualify for medical marijuana. You've taken your medical records to a recommending physician. So in

Ohio, a physician has to choose to become a recommending physician. They have to take 2 hours of training on medical marijuana. They register, and they can start seeing patients. They certify you. Then you get a card from the state of Ohio, and you have to come to the dispensary and present that card. We only allow patients, and they can bring one visitor with them to the dispensary. And that visitor is not allowed to leave the lobby. They can't enter the actual retail area of the dispensary. The point of the visitor is really we're dealing with sick patients. They might need some help from a family member to get into the dispensary to get out of their car. They might have questions, and they want to meet Buckeye-related dispensaries operated by a pharmacist, and so they might want to meet with their family member, with the pharmacist to talk about their condition and the type of products that might help them. But it's not open to the general public. Everyone can't walk in and just peruse the dispensary and learn more about medical marijuana. They have to have a card. They have to be a registered patient. Then they're tracked every one of their purchases and tracked in the state or system, which is the same system that tracks any type of opioid that's purchased, any type of pharmaceutical purchase. Distressed or so physicians can see everything that was purchased in a dispensary and they can see everything that patients have purchased. So when a patient goes to see their physician, their physician knows that medical marijuana patient and everything they've bought, that it's very secure. You won't see the children from the community running into a dispensary.

Representative of Buckeye Relief: Within a day between one and 200 people come into the building.

Ms. Henry: Ohio has 160,000 registered patients today.

Member of the audience: Now when they take that does that, they can be influenced. Do you know what I'm saying? Like, I like to go down there like back in the day, as long as you get that. I don't know about this new medical care because it affects the brain.

City Manager Mallis: It's more of a side effect. And then, you know, the medical effect that you're after, especially when you're mixing it with CBD or CBD gummites or other minor cannabinoids.

Representative from Buckeye Relief: It can lessen what they call psychoactive effects, like making you feel impaired but there is still THC in there, and that's the component that can make you feel high. But a lot of these patients are using the medications; they get those therapeutic effects at much lower doses than what keeps them from being nonfunctional. So while it is a side effect, it's usually a side effect that's seen in much bigger doses of medical effects that you need can really be achieved in much, much smaller doses.

Member of the audience: So they're allowed to drive cars.

Representative from Buckeye Relief: We anticipate there'll be somewhere between 25 and 30 jobs.

Representative from Buckeye Relief: And that's probably a direct effect that the secondary tertiary effect will be. And I think someone else mentioned just putting some kind of life into that business center. I think you're going to see more think you're just going to have more traffic currently. You guys can speak with better granularity, but the dispensaries that are the closest you have, Garfield Heights, Cleveland Heights you've got will never be like that. With that, you certainly have not got a lot of close-by spots that are this close to probably the major and we get the time it takes to get into people.

Representative from Buckeye Relief: It's very nice to see a lot of increased traffic. So that's going to be what your staff is going to be and not to make some joke that more snacks and pizzas and whatever else we are going to be part of.

Ms. Henry: Changes over there. Yeah.

Member of the audience: If it was legalized in the state, would your facility be selling retail?

Ms. Henry: It really depends on how we survive. Right now there is an initiative that is planning to be on the November ballot under that initiative. Medical marijuana

dispensaries automatically become adult use. But there is something that says if the community does not want an adult-use dispensary, the community can choose not to have that dispensary become adult-use. And so it really depends on how this passes and what the community decides.

Member of the audience: Is that from the community or is that something from Council decides?

Ms. Henry: There's a process that is outlined in that particular initiative where that if the city decided not to have it, I'm not sure the council I'm not sure who would make that decision, but then it could be voted on. If the community decides they wanted to, they could override that decision, or if they decide if the council decided they didn't have to a process to override that. But it depends on if adults use passes and what passes. I'm just looking at what is probably going to be on the November ballot. But there are other things that could also happen. Hard question to answer. I'm sorry.
