GIS PRESENTATION

City Manager Mallis: The City had an in house GIS and in 2021 the City went with a more proactive and a more strategic approach.

Mr. Francis: This was generated for EPA reasons. The services are for storm water and sewer and that they are still working on maps and that they are around 40% done with uploading the maps. With the system we are able to give GPD what we have and export them. We are able to document what was done and that this is for those who will be here after us, and that it is an asset management program.

John S.: A portion of this is up on the City's website.

City Manager Mallis: Any resident or insurance company has access to this on the City's website.

7. REPORTS

a. City Manager

City Manager Mallis: We have the Memorial Day parade to be taking place later this month on the 29th. That will start at 1015 prompt and it will begin at City Hall, and we will make our way to the square for a ceremony and then ultimately to the cemetery. So again, that event starts at 10:15 a.m. I also want to mention that the month of June is free permit month through the Building Department, and we will be waiving all of the permit fees for residential building projects, exterior only, and for owner-occupied homes. So if you're looking to get something done schedule in June, you still need to get a permit, and your contractors still need to be registered. I also want to mention that we do have this coming Wednesday, the second pre-construction meeting for Broadway with ODOT. And the contractor for the project is Shelley that is scheduled this week. We'll be participating in that pre-construction meeting, at which point we will then get all of the details as far as the start date and location. Are they starting at the Oakwood Bedford border, or are they starting at the Bedford Maple border? We'll get all of those details, and once we have that information, we'll be putting that out on our website, and social media, and sharing it, obviously at the public meetings. I also want to mention we posted on our website and social media about the Be the Beat Program. The Fire Department is going to be offering, and it's

So if you're interested, check that out. Be the Beat Program. Every second counts when you're dealing with cardiac arrest. And lastly, I just want to mention that the city officially closed on the first transaction in Tinkers Creek Commerce Park, Cleveland Tank and Supply acquired approximately five acres. And we are now reviewing their plans to start construction, and we hope to be moving dirt within the next 30 to 45 days.

Mayor Koci: The CPR that the fire department is doing. They just did a session for our church. And I just encourage everybody to go out. It's all hands, no mouth-to-mouth. It's strictly a quick, immediate help if somebody has a heart attack. And it was very, very simple to learn. A lot of people hesitated when they had to do mouth-to-mouth. Chest compressions are vitally important. And Stephanie over at the fire department did a great job teaching us the other night. So I would encourage anybody and everybody to get over there, learn it, and tell them thank you.

b. Law Director

Law Director Montello: I just want to publicly congratulate Mr. Papa for winning the Municipal Judge Seat. He will be the next Municipal Judge for the next six years. Judge Melling is retiring, and his last day will be December 31st. We will miss him and congratulate Judge Papa.

weekend, which of course, with prom, was a drag strip down several of the side streets. I was talking to City Manager Mallis if the speed signs catch the cars speeding going both ways. Because if it doesn't, then right now, it's just got on with there coming off of Broadway, going down Grand. He is going to check into that to see. It's really dangerous. This weekend there were some young kids on Thames that thought it would be really fun to pound on people's doors and windows at around 9:30 - 10:00 at night. That's not cool because there are people that are recovering from something or are sick, or they work the third shift, or sleeping, and they may be gun owners. Parents, please tell your kids, that it's unsafe.

Councilman Genutis: First, I'd like to say that Saturday was the Chocolate Walk in downtown Bedford, and the Bedford Downtown Alliance did a great job. I don't know what would bring hundreds of people onto the street on a Saturday in downtown Bedford, but the chocolate did it. And I think the interesting thing about it for me was it gave me an opportunity to go into all these businesses that I would never have gone into and see what they have there and whatnot. Everyone's doing a really good job keeping their yards up along with the litter and the trash. There are some yards that aren't cut but just patience because the City of Bedford is on top of the grass cutting. Tinkers Creek Commerce Park, I don't know if anyone knows about that on the other side of Shawnee that has been empty forever. Councilman Saunders: Well, we don't want it to some degree this year because with Northfield Road Bridge starting in a few months and Broadway being torn up most of the summer, we don't need another main route cut-off for the time being. So that's good to hear. So of course, with our proposed plans and everything that is going on, Metroparks but Bedford Falls and so forth, we want to make sure that we have the walk ability from a lot of the different neighborhoods and that that will work out really well. City Manager Mallis: Years ago the City acquired approximately nine acres, which was the former Taylor Chair site, and six of those acres are adjacent to Viaduct Park. It was initially planned to be residential townhomes. As Councilman Genutis had mentioned, there were a number of home builders interested since the city acquired it. They were interested in building approximately 10 to 12 homes and purchasing the property from the city. We held off on that. You know, we've we long talked about one of our assets in Bedford is the park system, and how do we expand that connection to the park system? And through our discussions with the Metroparks, we came to an agreement to where the city will be donating it. This agreement states the

city will gift six acres at Taylor and Willis that runs along Tinker's Creek and in return, the Cleveland Metropark's intent to construct what is referred to as a Four Seasons facility. It can be used in winter months, summer months heated, and it's a reserved space for the public. The city will have access to that space and that facility for 24 dates throughout the year for events, for presentations. If it's ward meetings, state of the City, senior club events, or anything that we choose with the idea of expanding our programming through Parks and Recreation to use that. We did request that they include an addendum in the agreement of a similar facility to put a comparison of what they intend to construct in that facility that they are comparing it to a four-season facility in the Geauga Park District, which is at Holbrook Hollows in Bainbridge. So for those of you that are interested, if you take a look at that, the hope is and the goal of this agreement is that they'll be constructing that the first two years will be basically clearing of the land, removing invasive species, new plantings, new trails, some improvements along those lines. And then ultimately the parks will be working to secure grant funding to build this facility. We do have a clause in there that if a facility is not built by the end of 2030, the Metroparks will agree to pay us the current value of that property, which is valued at \$311,000. So if that doesn't happen and it is not the intent for that not to happen, I fully believe we'll be seeing that facility constructed soon. But we do have protection there. The way it is Bedford does get recouped for the value of that land. The other thing that is important is outlined in the agreement. The parks for years supporting our project of connecting the downtown district to the Bedford Reservation with a pedestrian trail that we talk about down Willis, which will then go through Viaduct Park and construct the bridge over by the Falls. So the park is completely behind that initiative, and that is also outlined in this agreement. I think it's a this is a win-win for both. I think we expand that area and provide a space that can be enjoyed by everybody, everybody in Bedford and visitors. Not that homes wouldn't be nice there, but, you know, a small number of people can enjoy that space. We want something that our entire community can enjoy.

I don't believe any of these possibilities are warranted as a compromise could and should be made to the members that oppose this issue. I ask. Move forward in the discussion and write the risks that you believe the issue poses into the law as conditions. And to
