City Manager Mallis stated the following:

- The City received five bid proposals to replace the two boilers for the Municipal Complex and held a bid opening on Friday, July 27th.
- ABC piping was the lowest, most responsive bid at \$165,000.
- The companies that came out indicated that these high-efficiency boilers have reached the end of their life expectancy.
- Our engineers put together the specs and did this bid.
- There is a 90-day turnaround time to complete the project, so we would like to get that started sooner rather than later, and there is over \$50,000 that we do still have available from a grant for energy upgrades that will go to offset this. We want to cover the remaining balance with other energy financing options available through NOPEC.

- The Bureau Workers of Compensation offers Safety Grants to communities for equipment that will obviously reduce the risk to staff members.
- Typically, when we are installing or removing signage throughout the city is done manually with a sledgehammer, and to get them out, the poles are pulled out. This hydraulic piece of equipment actually pounds them in.
- The cost is \$15,190.20 for this piece of equipment, and we were awarded a grant of \$11,392.65 to cover the majority of this piece of equipment. We can cover the remaining funds with money already in our current budget.
