- The senior health and wellness fair that's going to be held on October 18th.
- The children's fall fest is scheduled for this Saturday, October 7th down on the Commons and will begin at 10:00.
- We went live last week with the new entry exam for patrol officers. We are working through the National Testing Network, and that application will be live through October 30th.
- We did have some discussions with First Energy and Spectrum over the last couple of weeks. First Energy is not permitted to touch anything that Spectrum owns, so it's a coordinating issue
- Broadway is moving along, and we did bring up a number of concerns with ODOT that are centered around parking in the Historic District traffic pattern up on the Hill. They harped on Parkway as well as the traffic pattern change at West Grace. The reason some of those traffic patterns have changed on West Grace is that it all centered around the width of those lanes, and it didn't meet the requirements of state rules, which is why it got shrunk. We're working through that and there are other ideas that we think would improve the traffic pattern. But that is why it was changed. It wasn't the city's decision to let's tweak the traffic pattern.

- So you will see changes on certain roads, especially in the future when they do Northfield Road because that's a state road also. So it is the law in the state, and the city has to adhere to it.

- The budget appropriation ordinance is actually a budget adjustment relating to budget numbers, not actual expenditures. They're related to actual expenditures that have already been approved by Council in the General Fund.
- In Fund 200 the Community Development Fund there was an increase of \$150,000 for the receipt of a Community Development Block Grant for the Bedford Commons train depot electrical painting
- In Fund 113 the various grants related to Fire Police recreation, the Bureau Workers Comp awarded a pole pounder for the Service Department. The Council already approved the expenditure of 15,000, the grants covering 11,000 of that
- Appropriating the funds from a donation received to allow for electrical boxes in the city
- To repair the City Hall boilers Capital Projects Fund for \$123,000, just a little over that we are working on getting some funding for that as well
- The Waste Water Fund for \$43,000 for Sanitary Sewer Repairs

- We have the ability to apply for \$150,000 in community development block grant funds through Cuyahoga County. They are federal funds.
- Bedford a non-entitlement community, which means entitlement communities over a certain population, get hundreds and hundreds of thousands of dollars every year to use how they feel is needed throughout the community. We have to apply for those funds because we're at 13,000; we fall under
- The max is \$150,000 a year. And our county administers that program.
- They are now allowing these funds to be used to acquire cruisers, which will help offset our budget.
- Our intent is to purchase two, possibly three, depending on what types of vehicles are available.
- This grant is due at the end of the month, so we're a little bit up on the timeline.
- The funds have to be spent, and you have to receive what you're using the funds for by September of next year.
- We're undecided if we'll be able to seek out a third vehicle or if we will be only
 purchasing two if we're successful; pretty confident we'll be successful

9. HEARING OF CITIZENS

Tony Ramos, a Representative from NOPEC: stated the following:

- We restarted our Electric Aggregation Program
- Our re-enrollment process is completed, and we're happy to report that we've recovered about 80% of the customers that we returned last summer
- The city has almost 3,800 residents participating in the Electric Aggregation Program and almost 2,400 residents participating in the Gas Program. That is close to 6,200 residents that are participating.
- Informing business owners about our Pace and Step Lending Programs, Building Energy Audits, and some of the other items that NOPEC provides to member community businesses at no cost

<u>Calvin, Bedford, OH:</u> inquired about the Bedford Recreational Skate Park and informed the City that the equipment is falling apart. He also stated that he and his friends enjoy going to the Skate Park and that they do not want to see it get torn down.
