DISCUSSION OF CITY WIDE STREET LIGHTING

City Manager Mallis: Tanko Lighting Company came to the city in 2020, and they are looking to take ownership of the street lights. First Energy charges the city when the lights are on or off. To replace the lights with LED along with the heads would be \$1.5 Million. Based on Tanko's calculations, the usage would be \$250,000.00 over a 10-year period. Tanko's initial estimate did not include all of the lights. The City wants to do a feasibility study. Tanko offers two options, and the City would go with Option 2, which includes both bridges. Tanko has been around for 20 years, and they are all over the country, and they are also in Ohio. Mrs. Howland and I need to look over the budget, but this is one way that we can move forward with moving to LED lights throughout the City.

City Manager: This agreement is for a gift to the Cleveland Metroparks for approximately six acres of land adjacent to Viaduct Park that the city currently owns. We have been discussing this with the Parks District for well over a year. In this agreement, the parks plan to develop the property and expand Viaduct Park in the next 12 to 24 months. They'll be removing the invasive species, putting in new plantings, and extending the trails. They will be constructing what is referred to as a Four Seasons Facility that could be rented by the public year-round. The City will have access to that facility 24 times in a calendar year for events, and programs offered through Parks and Recreation, Board meetings, and the State of the City. I think it'll be another asset to the community, especially along Tinker's Creek. There is a clawback to protect the city; the parks have until 2030 to construct that facility. In the event that it is not constructed in that timeframe, they will pay Bedford the current value of that land, which is approximately \$311,000. Also outlined in that agreement, the Cleveland Metroparks fully supports the city's efforts to extend what we refer to as the Connector Project, that is, the pedestrian bike and hike trail from the Commons through Viaduct Park with the construction of a bridge over Tinkers Creek connecting to Egbert Road Trail.

third and fourth phases are near Gilbert and going up to the Forbes intersection. The fifth phase is a complete overlay, and that will not take that long. Phase one is going to be 60 days, and we'll keep everyone updated as we receive information. It will be on the city's website and on social media. I read that a number of municipalities in northeast Ohio are seeing a rash of car break-ins, not Bedford, but it is happening. This is what we refer to as a crime of opportunity. This is kind of just a friendly reminder not to leave valuables in your car, and don't leave your car unlocked. We will be conducting a bid opening this Friday for the Lincoln Waterline project, and then we will review those bids; then, we will make a recommendation at the June 25th Council meeting to hopefully move forward with that project. I know it's been a challenge in that part of the City with Harriman getting torn up at Washington Court, but these are much-needed improvements and will definitely be worthwhile. The waterline at Harriman is from 1915, so it has served its purpose. This is a reminder that Wednesday is the start of the Summer Concert Series. So there'll be a concert in the park every couple of weeks. The concerts and performers are listed on the city's website, and you can also follow Parks and Recreation on social media as well. That will start this Wednesday from 7 to 9. Lastly, I just want to commend the Fire Department and the Service Department for finding the gasoline leak that was identified in our sewer system last week. The leak was located at one of the pumps at the Sunoco gas station on the corner of Northfield Rd. and Taft Ave. I know staff members were out until 8 p.m. talking to some residents and trying to locate where it was actually coming from.

We had two F-16s fly over; that was kind of neat. Thank you to Bedford firefighter medics Stephanie Balochko and Joe Sisak; they gave the training on Saturday at Ellenwood. It was hands-on training and a little bit of AED. If you have a chance, get a hold of our firefighters, and they will set something up for you, whether it's a business. If you have a family, you can get together with a decent number of people. I believe they said the two of them can take up to 16 at a time per class, and they do offer the Certified CPR and First Aid course. This one was not certified it was just a hands-only thing. But they do offer the certified course, which is free. But I believe they said you have to pay \$17 for the card, the certification card from the American Heart Association. So if anybody's interested, please get ahold of our firefighters. They do a fantastic job. The chipper service is this week, so if you didn't get on the list for June, call the Service Department to get on the list for July. The chipper service starts on July 3rd to July 7th. Once again, the pool is scheduled to tentatively open on June 20th.

everybody is going to try to cut around. I think that would be a good idea to do because it will back things up all over the place. So if we nip it now, it will help. Are we going to put at least a few no-parking signs up on the dead-end stretch of Logan, where the temporary water main is? Because not only does Kimble have a hard time, but so do the delivery trucks, because somebody always parks right there on the corner. And with all the holes that were cut to put in the valves in order to shut off and turn on the Ennis water main, having cars parked in that first big stretch and the dead-end stretch of Logan virtually shuts the street down at times. So if we could look into that, it would be much appreciated. And then my big announcement is I will not be running for reelection in November. So I figured today was a good day to make that announcement because it gives anyone who wants to run two months to get their petitions together and signed and filed so that they can run for the election. The diagnosis of stenosis of the spine is what's causing the balance issue. The doctor says I'm going to be going through treatment for the next couple of months on that, so I'm not going to have time to run for reelection. So and if by chance that doesn't work, I feel that I wouldn't be able to do the job in full capability that someone else might be able to do because getting around is limited, though I do get around pretty well to some degree. I told everybody at the beginning of the year I would let everybody know in June, and it is now June, so this will be my last year on Council, 26 years is a good run. So I wish whoever gets the position a lot of luck. This is a more trying job than some people think. You get a lot of phone calls, a lot of concerns, you have to iron out disputes, and you have to know something about public works, and you have to be able to make sure things are going in the right direction.

As you know, it's happened about twice in the past ten years. It has a propensity to come into my basement, raw sewage, and lots of water.

City Manager Mallis: That definitely is on our regular maintenance to ensure that there are backups and things like that. I will reach out to you sometime this week as far as a potential clean-out there.
