#### DISCUSSION OF AGENDA

There were no corrections to the minutes.

Ordinance No. 056-23: Enacting Chapter 1967 Establishing Regulations for Short-Term Rentals, Bed and Breakfast Inns, and AIRBNBS: City Manager Mallis stated that we looked at other communities and this is to create a contract to notify the owner.

Ordinance No. 057-23: Declaring 34 Nordham Dr. a nuisance: City Manager Mallis stated that the neighbors were interested in buying it, but there are back taxes that are owed.

Ordinance No.060-23: Rate Reduction: Mrs. Howland stated that there is an increase in the household income threshold.

Ordinance No. 061-23: Sewer Rates and Ordinance No. 062-23: Water Rates: Mrs. Howland stated that the city is proposing a freeze on an increase this year. City Manager Mallis stated that they will eventually have to pay more but that we don't know when.

Resolution No. 2604-23: Reimbursement to Water Fund for WWTP Headworks Upgrade: Mrs. Howland stated that this is a reimbursement for the WWTP Fund and that the payments will start in 2025

Resolution No. 2605-23: Accepting the Amounts and Rates: Mrs. Howland stated that the rates are the same as they are now.

Ordinance No. 073-23: Contract with Markertek: City Manager Mallis stated that this is for upgrades to the audio system down at the Commons and that it is also funded through the CDBG Grant from the County.

### 7. REPORTS

a. City Manager Mallis

City Manager Mallis stated the following:

- Welcomed Mr. Temple to the Bedford Police Department
- Broadway Repaving Project began the resurfacing for Franklin to Flora, and once that is completed, they will be moving on to phases three and four
- The City provided a notice to proceed for the contractor to perform the waterline project on Lincoln Blvd. Work will begin on that project on September 11th
- The City provided a notice that Cleveland Water would be coming back out to raise the casting up. They have ninety days to finish the project
- The City purchases water from the City of Cleveland and reselling it, so we can dictate that there will be a loss in the system, especially for a system that is over 100 years old
- The City is working with NOACA on the connectivity study to connect the Metro Parks with the downtown district.
- A TLCI Meeting is scheduled for September 13th at Ellenwood at 6:00 p.m.
- This meeting is a key piece with NOACA for the TLCI Project and once completed the City will be eligible for construction dollars to connect the square and the bridge.
- The Recreation Department is working on putting together the Fall Program Guide, and once it is approved it will be mailed out to everyone
- The City was awarded the two-year cycle grant for senior and adult services
