## What is the South Fork Parkway?

The <u>South Fork Parkway</u> is envisioned as a four-lane divided connector street running north-south from Armstrong Ford Road to South Point Road. This street will also tie into Nixon Road and Tucker Road, helping to create a stronger, more integrated roadway network along the peninsula.

This roadway will be posted with a speed limit of 35 MPH, and will pass through primarily residential land uses. A 10' wide multi-use path will be installed on both sides of the street to allow for safe travel by cyclists and pedestrians. Street trees will be provided within the median and along both sides of the parkway.

#### WILL THIS BE A STATE ROAD OF CITY STREET?

While originally envisioned as a state road, the City recently learned that NCDOT desired a minimum design speed of 50 MPH for this corridor. This speed is inconsistent with our adopted plans. In December 2021, City Council agreed to accept the South Fork Parkway as a city street, with a 40 MPH design speed (posted 35 MPH), to maintain our vision and timeline for this much needed thoroughfare.

### WHO WILL BUILD THIS Parkway?

The South Fork Parkway will be constructed by private development through the conditional zoning process. City Council approved the <u>Del</u> Webb project in May 2021, requiring its construction as a condition of approval. The first phase of the parkway that connects Armstrong Ford Rd to Nixon Rd will begin construction in 2022. Any developer seeking a project that overlaps the southern portion of the alignment would also be required to continue the roadway within their site.

### UPDATES ON OUR TRAILS AND GREENWAYS

## ABBEY CREEK GREENWAY



The Abbey Creek Greenway will be a 1.2 mile trail destination running from one of the busiest intersections in Belmont (Park & Wilkinson) east to the Catawba River. This greenway is being designed to meet Forestry Service Trail Accessibility Guidelines (FSTAG) so the trail can be utilized by all residents/visitors. The design will include a boardwalk, bridge, water views, trailheads, and public art. A multi-use path will connect the greenway to the new recreation center, skate park, and <u>Kevin Loftin</u> <u>Riverfront Park</u>. Construction is anticipated to begin in Fall 2022.





## **ROCKY BRANCH PARK**

The Tarheel Trailblazers continue working to build out the trail network in <u>Rocky</u> <u>Branch Park</u>! The Boulder Trail- a challenging blue mountain bike trail- is now open. Construction has also begun on the next section, known as the Eagle Trail. Early planning efforts for the fifth phase of Rocky Branch Park, which will include the advanced trail zone, kicked off in December 2021.

### 2021 GRANTS: TRANSPORTATION NCDOT PEDESTRIAN PLAN UPDATE GRANT

This grant will allow the City to update our pedestrian master plan, which was originally adopted in 2009. For more information, please visit <u>www.cityofbelmont.org/ped-plan-</u> update.

Grant Value= \$36,000

### DUKE ENERGY PARK & PLUG NC PILOT PROGRAM

The City of Belmont was selected to receive two fast-charge stations for electric vehiclesincluding equipment, installation, electricity, and warranty from Duke Energy. The location of these stations is still being determined.

Grant Value= \$200,000

### GASTON COMMUNITY FOUNDATION GRANT

The City of Belmont was successfully awarded this unrestricted community grant to assist with the Abbey Creek Greenway.

Grant Value: \$10,000

### CAROLINA THREAD TRAIL GRANT- LAND ACQUISITION

The Abbey Creek Greenway project was selected to recieve a CTT grant to assist the City with land/easement acquisition costs. This is in addition to the \$10,000 recieved from the Carolina Thread Trail in 2020 for design services.

Grant Value= \$30,000
