CALL TO ORDER OF SPECIAL MEETING

The meeting was called to order at 1:30 p.m.

SCHEDULED ITEMS

- 1. The minutes of the August 10 meeting were unanimously approved.
- 2. The Taskforce received preliminary analysis of potential tax rates under an ad valorem/GO bond scenario and a real property transfer tax/lease financing scenario from the City's Municipal Financial Advisor (MFA), Jim Fabian of Fieldman Rolapp. The Taskforce discussed the scenarios and methodology with the MFA. No action was taken.
- 3. The Taskforce received information regarding the potential legal considerations of charter city formation from Jim Lynch, Councilmember and invited guest. City staff were directed to engage with a law firm that specializes in elections and charter city conversions to further advise on this subject.
- **4.** The Taskforce Chair Sally Wilkinson shared information about Prop 19 and it was agreed that there are no direct impacts of Prop 19 to this effort.
- 5. City Manager Craig Middleton informed the Taskforce that a polling consultant (Godbe Research) had been engaged by the City, and that the survey creation is underway. Due to Brown Act considerations, the survey would not be circulated amongst the Taskforce, but individual Taskforce members were given the opportunity to speak individually with the polling consultant regarding the process.
