RECOMMENDATION

That the City Council adopt a Resolution authorizing the continued use of remote meetings pursuant to Assembly Bill 361 and give direction to staff as necessary.

BACKGROUND

At its October 11, 2021, regular meeting, the City Council adopted Resolution 2021-41 authorizing the continuation of virtual public city meetings during the continuing state of emergency relating to the COVID1-19 pandemic for the 30-day period beginning October 11, 2021 and making the required findings pursuant to AB 361. Subsequently, at the November 8, 2021, November 29, 2021, January 10, 2022, February 14, 2022, March 14, 2022, April 4, 2022, and May 9, 2022, meetings, the City Council adopted Resolutions 2021-44, 2021-45, 2022-03, and 2022-06, 2022-12, 2022-20, and 2022-25 allowing meetings to be held via teleconference.

In order to continue to hold remote meetings, the City Council must continue to declare every 30 days that (i) the state of emergency continues to be in place; and (ii) State or local officials continue to impose or recommend measures to promote social distancing; or (iii) as a result of the declared emergency, meeting in-person would result in an imminent risk to the health or safety of attendees.

The attached resolution makes the findings to confirm the conditions still exist to allow the continuation of virtual public meetings pursuant to AB 361 for the City Council and on behalf all lower legislative bodies in the City.

The attached resolution anticipates and authorizes remote meetings including hybrid meetings held both via teleconference and in-person. This resolution will allow members of the public to safely observe and participate in local government teleconference meetings during the continued pandemic.

ENVIRONMENTAL DETERMINATION

A meeting format determination under AB 361 is not a "project" under the California Environmental Quality Act, because it does not involve an activity that has the potential to cause a direct or reasonably foreseeable indirect physical change in the environment. (Pub. Res. Code § 21065).

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELVEDERE AUTHORIZING THE CONTINUATION OF VIRTUAL PUBLIC CITY MEETINGS DURING THE CONTINUING STATE OF EMERGENCY RELATING TO THE COVID-19 PANDEMIC PURSUANT TO ASSEMBLY BILL 361

WHEREAS, on March 4, 2020 Governor Newsom declared a State of Emergency pursuant to Government Code section 8625 due to the COVID-19 pandemic, which State of Emergency remains in effect; and

WHEREAS, State Executive Orders N-25-20 and N-29-20, suspended certain provisions of the Brown Act (Gov. Code, §§ 54950 *et seq.*) to allow public meetings to be held virtually without opening a physical space to the public, which provisions expired September 30, 2021; and

WHEREAS, effective September 16, 2021, Assembly Bill 361 allows local agencies to continue to hold remote public meetings through December 31, 2023 when there is a State-declared emergency, and when state or local officials have imposed or recommended measures to promote social distancing or as a result of the declared emergency, meeting in-person would result in an imminent risk to the health or safety of attendees; and

WHEREAS, the Government Code section 8625 State of Emergency remains in effect; and

WHEREAS, state and local officials continue to impose and recommend measures to promote social distancing due to the continued rates of transmission of the COVID-19 virus and variants as follows:

- a. The Marin County Public Health Department continues to recommend the use of masking indoors.
- b. On September 22, 2021, the Marin County Director of Health and Human Services, Benita McLarin, issued a letter recommended continued social distancing for governmental meetings, including the use of video and teleconference meetings.

WHEREAS, public meetings involve many people in shared indoor spaces, in close proximity for hours, and City meetings rooms have limited mechanical and natural ventilation, creating a health risk for members of the public at this time; and

WHEREAS, as a result of the continuing declared emergency, public meetings in-person would result in an imminent risk to the health or safety of attendees.

WHEREAS, a meeting format determination under AB 361 is not a "project" under the California Environmental Quality Act, because it does not involve an activity that has the potential to cause

a direct or reasonably foreseeable indirect physical change in the environment. (Pub. Res. Code § 21065.)

Subject: Protect Belvedere Project update

Recommended Motion/Item Description

1. That Council evaluate an update on the Protect Belvedere project, and

2. That Council provide direction to staff regarding project implementation.

Background

For many years, the Council, City staff, contract engineers and several citizens' committees have studied the condition of the City's seawall and levees and have consistently identified the need to protect the City from catastrophic risk from earthquake and flooding. A project has been designed to provide this protection, and environmental review is now underway.

The project as currently envisioned would provide earthquake protection by installing 40'-50' steel sheet piles along vulnerable sections of San Rafael Avenue and along most of Beach Road. These sheet piles would reinforce the levees and would protect the utilities embedded within them from disabling damage during a sizeable earthquake.

The project would also address current and future flooding risk by adding height to the levees on Beach Road and San Rafael Avenue. The existing levees have sunk three feet since their construction 80 years ago. This project would correct that deficiency and enhance flood protection against current storm conditions. The project would also create improvements on private property along a small portion of West Shore Road needed to prevent water incursion into Belvedere. Based on guidance provided by the State of California, the project would protect against stillwater incursion and significant wave-induced overtopping from severe storms (1% storm) through to 2050 projected sea levels.

The effort would therefore accomplish two major objectives: 1) to protect Belvedere – its levees, seawall, and key utility trunk lines – from the potentially devastating effects of earthquake, and 2) to greatly reduce flooding risk that exists currently and into the future. It is important to

emphasize that Belvedere's levees are inadequate for protecting against severe storm events under today's conditions.

An additional project goal is to accomplish these objectives *before* an earthquake or significant flooding event impacts the community.

Seismic experts conclude that Belvedere faces significant risk of a major earthquake over the next two decades. Belvedere levees are not strong enough to withstand a major quake and would likely sustain significant damage. Because San Rafael Avenue and Beach Road provide the only access points to and from Belvedere Island and much of the Lagoon area, a sizeable earthquake could render these roads impassable, impacting efforts to evacuate residents and get emergency help in. Because water and fire suppression trunk lines, as well as gas and communication lines, are embedded in the levees, significant lateral movement caused by a quake could rupture utilities, including the very lines needed to put out a fire. Finally, because the seawall on Beach Road is unstable (the City has implemented two emergency repairs to the failing seawall in recent years), a large earthquake could cause the seawall to move or to collapse into the bay, making the City vulnerable to considerable flooding.

Earthquakes are unpredictable, but we know they are coming. Seismologists can predict with some degree of certainty the likelihood of a quake striking over an extended period, but they cannot predict their exact timing and magnitude. Seismologists believe that there is a 72% chance that a sizeable earthquake will occur near Belvedere within the next two decades. Given the high level of impact to Belvedere that would be expected to result, it is important that the City move with all deliberate speed to protect itself from an earthquake.

Flooding from severe storm events is also a present-day concern. As mentioned above, the City's levees, built 80 years ago of bay mud, have settled, sinking 3 feet since they were built. Although the pace of settling has slowed, some additional settling is expected to occur over the next few years. After significant storms caused flooding in the 1980s, the City installed rip rap along San Rafael Avenue. The rip rap helps to diffuse wave action, resulting in less severe overtopping. However, it does not remedy the problem of a sinking levee and the diminishing protection that occurs due to settlement. The vulnerability that Belvedere is living with now is expected to worsen with sea level rise.

A Phased Approach?

During public outreach about this project, a number of people in the community have asked whether the project could be phased. Staff has considered the question of phasing and offers these considerations:

• The City has examined levee stability and effectiveness for over a decade and understands well what needs to be done. Of particular urgency is the vulnerability to earthquake of the City's levees, seawall, and utilities.

- Stabilizing the levees and seawall to protect them from earthquake is a project that can be accomplished by Belvedere alone.
- By implementing the project as currently designed, Belvedere would provide real flood protection while discussions continue with Tiburon about its approach to flood control. According to survey data, Tiburon's Main Street is at a higher elevation than Belvedere's levees. Because of this, the risk of sea water overtopping on Main Street is much less significant when compared to lower elevations found on Beach Road and San Rafael Avenue. There is time to work out an approach to dealing with water from Tiburon.
- While Belvedere can do much to bolster flood protection, particularly against current risk, the most effective approach to building a comprehensive flood control system that will protect against expected sea level rise is to work with Tiburon. Belvedere has considered a workable plan to protect the City in the event that Tiburon does not act; however, the best approach is a coordinated effort between the City and Town.
- Adding necessary height to Belvedere's levees and seawall involves coordination with owners of property outboard of the seawall on Beach Road as well as with the San Francisco Yacht Club, and residents of the first six properties on West Shore Road. The City is working actively with these property owners.
- The City has applied for project funding from several state and federal sources. The requests describe the full extent of the project and outline its objectives of seismic protection, utility security, and flood control. It would be important, in any phasing plan, to ensure a continued commitment to all aspects of the project over time so as not to jeopardize opportunities for outside funding that would reduce the cost to Belvedere taxpayers.
- Construction costs tend to escalate over time. Therefore, any aspect of the project that is delayed would likely cost more in the future than it would cost today. While a phasing plan that delays implementation of some aspect of the project could result in some near-term cost reduction, the total project cost will likely increase with a phased approach.

Environmental

It is possible to intercede in the ongoing Environmental Impact Report preparation to accommodate a phased project. Consultants would need to adapt the working draft to clearly delineate impacts related to seismic retrofit and those related to flood protection. These changes would result in a delay of approximately two months in the release of the Draft EIR. The current projected release date for the Draft EIR is mid-August 2022. The exact cost for this added effort is unknown at this time but is anticipated to be approximately 10-15% of the total EIR preparation fees, currently budgeted at \$221K.

Fiscal Impact

The City hired a professional cost estimating firm to provide an independent evaluation of realistic costs within the niche industry of marine-related construction. The total project costs are estimated at just under \$28M (\$27.4M). This includes all aspects of the project—permits & mitigation, final design, project management & inspections, construction, and contingency.

With a phased project some duplication of effort will occur. This, coupled with potential labor and materials cost escalations, means that the total project is likely to become somewhat more expensive than the current proposal.

To complete only the seismic retrofit of the roadway levees, project costs would be approximately \$20M (\$19.95M) assuming 5% escalation in construction costs for 2.5 years. It is difficult to provide an accurate estimate of construction costs for the flood protection phase as a start date is uncertain. The City's cost estimator is working on estimates currently; however, it is safe to assume that the second phase (flood protection) would cost no less than \$7M-\$8M, based on the current estimate.

Conclusions

Staff has identified several deficiencies in the City's current levee/seawall system that should be corrected. A team of seismic and hydrologic engineers has worked with the community to design a project that will offer considerable protection to levees, roads, and utilities from earthquake, and will protect against current and future flood events. A comprehensive approach to building these protections is needed.

If the Council determines to phase the implementation and funding of a comprehensive project, staff would recommend an approach that prioritizes seismic protection, given the likelihood of a major earthquake affecting Belvedere in the near future. A seismic project could be accomplished at lower initial cost to the people of Belvedere and could be implemented by Belvedere alone.

Flooding risk should not be underestimated, particularly given the fact that the levees have sunk considerably since they were built 80 years ago and are providing less protection each year as they continue to sink. In staff's view, the principal reasons to delay the implementation of flood control measures would be to ensure integration of Belvedere's protections with those in Tiburon, and to coordinate the City's flood control project with the efforts of impacted private property owners on Beach Road and West Shore, and the Yacht Club. Additionally, a short delay in the implementation of the flood prevention portion of the project could provide time to ascertain whether outside funding – particularly funding specifically targeted to projects that offer resilience from rising seas – will become available to reduce the cost to Belvedere taxpayers.

If the Council were to undertake a phased approach, which would commence with seismic protection, staff would recommend that the duration of the delay in the flood protection components be limited, and that full designs be developed. For example, a delay of up to five years should provide enough time to complete consultations with Tiburon, the Yacht Club and private property owners. It should also limit the cost escalation risk that comes with delay. A brief delay would still expose Belvedere to risk; however, with earthquake protections in place, Belvedere would be making significant progress in its efforts to protect the community.

As to project duration, it is estimated that the seismic protection phase of the project would take 9-12 months to construct depending on the availability of steel. Staff has not studied how long a separate phase to construct flood barriers would take to build. This would be studied based on Council direction.

Finally, if the Council were to consider phasing the project, staff would recommend that the City continue with design and CEQA analysis of the entire project, to be well-positioned to move quickly if flood-related outside funding becomes available.
