RESOLUTION NO. 2024-21

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELVEDERE ORDERING AND CALLING A GENERAL MUNICIPAL ELECTION IN THE CITY OF BELVEDERE ON NOVEMBER 5, 2024 FOR THE PURPOSE OF ELECTING THREE COUNCILMEMBERS

WHEREAS, the City Council of the City of Belvedere determined at a regularly scheduled public meeting on June 10, 2024 that a General Municipal Election shall be held on November 5, 2024 for the purposes of electing three City Councilmembers.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Belvedere as follows:

Section 1. Date of Election - Offices to be Filled. A general municipal election is hereby called and ordered to be held in the City of Belvedere, State of California, on Tuesday, November 5, 2024, for the purpose of electing three City Councilmembers, the terms of the incumbents of which are about to expire; and

Section 2. Procuring and Filing Nomination Papers. Nomination papers may be procured from the City Clerk and shall be filed with the City Clerk no later than 5:00 p.m. on the eighty-eighth day before the election, or August 9, 2024.

Nomination papers may not be circulated prior to July 15, 2024 and must be filed no later than 5:00 P.M. on August 9, 2024. If any one of the incumbents does not file for re-election to office by August 9, 2024 at 5:00 p.m., the filing period for such office is extended until 5:00 p.m. on August 14, 2024 for non-incumbent candidates only.

Section 3. Time When Polls Are Kept Open. As determined by the Marin Department of Elections, the polls shall be opened at 7:00 A.M. on November 5, 2024 and shall be kept open until 8:00 P.M. in the evening of the same day, when the polls shall be closed.


Section 4. Certification of Vote by City Council. The City Council shall conduct a duly noticed public meeting on the first available date following the canvass of the vote by the County Registrar of Voters to certify the election and install the newly elected officers.


Section 5. Publishing Notice of Election. The City Clerk shall cause to be published in a newspaper of general circulation a Notice of Election which will include the date of election, hours the polls open and close and the offices to be filled.

Section 6. In all particulars not recited in this resolution, the election shall be held and conducted as provided by applicable law for holding municipal elections.
