NOVEMBER 16	THURSDAY	CITY ATTORNEY ANALYSIS OF FIRE APPROPRIATIONS MEASURE (DATE SET BY CITY CLERK)
NOVEMBER 17–27	FRIDAY – MONDAY	TEN (10) DAY PUBLIC EXAMINATION PERIOD OF MEASURE FILED WITH THE CITY ELECTIONS OFFICIAL. (EC § 9295)
NOVEMBER 27	MONDAY	LAST DAY TO FILE OR WITHDRAW ARGUMENTS (300 WORD LIMIT) WITH THE CITY ELECTIONS OFFICIAL. (EC § 9286, § 9601)
NOVEMBER 28– DECEMBER 7	TUESDAY – THURSDAY	TEN (10) DAY PUBLIC EXAMINATION PERIOD OF ARGUMENTS. (EC § 9295)
DECEMBER 7	THURSDAY	LAST DAY TO FILE REBUTTALS (250-WORD LIMIT) TO THE ARGUMENTS FOR OR AGAINST A MEASURE, SUBMITTED WITH ALL DOCUMENTS REQUIRED BY THE ELECTIONS DEPARTMENT. (EC § 9285, §9601)
DECEMBER 8–18	FRIDAY – MONDAY	TEN (10) DAY PUBLIC EXAMINATION PERIOD OF REBUTTAL ARGUMENTS. (EC § 9295)
MARCH 5	ELECTION DAY	MEASURE REQUIRES A SIMPLE MAJORITY OF THE VOTES CAST TO PASS.
MARCH 11	MONDAY	CITY COUNCIL ADOPTS RESOLUTION DECLARING THE ELECTION RESULTS.
