#### IT & Infrastructure

- NEC Blue Connect Phone System After a brief discussion it was agreed to have Borough Manager J. Walker to review their phone system and to research others. President C. Williams noted that this will be discussed at the February 1, 2021, work session.
- **New Website Developer Agreement** President C. Williams stated that this will also be moved to the February 1, 2021, regular meeting agenda.
- GoDaddy Subscription Councilmember P. Bucco moved to extend the GoDaddy subscription for three ((3) months to allow for the preservation of email and email migration. Councilmember S. Stewart-Keeler seconded. Motion carried unanimously.
- IT Person Councilmember A. Montanez moved to hire Ronald Smith as the Borough's IT professional at an hourly rate of ninety-five dollars (\$95.00). Councilmember S. Stewart-Keeler seconded. Councilmember A. Montanez asked if the Borough Manager can inquire about any additional fee for upgrading the Borough's internet. Motion carried unanimously.

## Tax Collector

- Accept Resignation Councilmember P. Bucco moved to accept JoAnn Misurca-Ficco's resignation as the Borough's Tax Collector. Councilmember T. Neville seconded. Motion carried unanimously.
- Advertise Tax Collector Ordinance Councilmember S. Stewart-Keeler moved advertise an Ordinance authorizing the Borough to enter into an agreement with Coolbaugh Township for a joint tax collection district by Coolbaugh Township's Tax Collector until the vacancy in the office of Mount Pocono Borough Tax Collector is filled. Councilmember P. Bucco seconded. Vice President F. O'Boyle questioned if the Ordinance should include compensation for duties rendered. Mayor M. Penn stated that once the Coolbaugh Township Tax Collector gets appointed then there will be a separate Resolution outlining the compensation. Motion carried unanimously.

# Right to Know Appeal

President C. Williams explained this that the Borough has been sued by Tom Ford however she explained that the information he requested was her from personal social media account. She noted that the Borough lost the case, and she is asking for a motion to have the Borough's Solicitor appeal the case.

Councilmember S. Stewart-Keeler moved to appeal the Common Please decision in Tim Ford and the Boro Newspaper vs. Borough of Mount Pocono and to allow Solicitor J. Fareri to represent the Borough per his budget in fee schedule outlined to Borough Council in a letter dated January 12, 2021. Councilmember R.

Emilie seconded. Mount Pocono Borough resident Mike Oser questioned the cost to the Borough. It was noted that it would be approximately \$3,000.00. However, it was also noted that there was no initial cost by the Solicitor. There was more discussion explaining why to appeal this case as it could affect everyone on Borough Council as this was a private page on social media and that this could happen again. Also, the right to know requests take up much of the time and payroll monies of the staff. Motion went to a roll call vote: Councilmember T. Neville, "Yes"; Councilmember R. Emilie, "Y"; Councilmember S. Stewart-Keeler, "Yes"; Councilmember A. Montanez initially was against appealing however as it was explained in more detail she voted, "Yes"; Councilmember P. Bucco, "Yes" Vice President F. O'Boyle, "Yes"; and President C. Williams, "Y". Motion carried unanimously.

Councilmember A. Montanez wanted on record that if the Borough wins this appeal that the Borough would be reimbursed of any legal fees.

#### **PSAB** Communication

President C. Williams stated that she and Borough Manager J. Walker will be the only people to communicate with PSAB with any questions, clarifications or concerns and will then in turn relay the information to Borough Council and if need be to the public.

Emilie stated that has known thirty (30) plus years and even though he is very knowledgeable with the Borough's budget and finances he feels that he needs to take a break. Councilmember R. Emilie felt that Councilmember P. Bucco has more time to give to the Borough and Vice President F. O'Boyle needs a little rest. Motion went to a roll call vote: Councilmember T. Neville, "Y"; Councilmember R. Emilie, "Y"; Councilmember S. Stewart-Keeler, "Y"; Councilmember A. Montanez noticed that Treasurer D. Hewitt had a comment to make. Treasurer D. Hewitt stated that she needs two (2) signatures on the checks one (1) being Vice President F. O'Boyle's and that we cannot get new signature cards until the November 19, 2020, minutes are approved and brought to the bank. Councilmember A. Montanez asked if Councilmember T. Neville can amend his motion to start the position on February 1, 2021. Councilmember T. Neville amended his motion to elect Councilmember P. Bucco as Vice President and replace current Vice President F. O'Boyle beginning on February 1, 2021. Councilmember R. Emilie seconded. Motion went to a roll call vote: Councilmember T. Neville, "Y"; Councilmember R. Emilie, "Y"; Councilmember S. Stewart-Keeler, "No"; Councilmember A. Montanez, "Y"; Councilmember P. Bucco, "Y"; President C. Williams, "N"; and, Vice President, "N". Motion carried 4 – 3.

President C. Williams thanked Vice President F. O'Boyle for his years of service as Vice President, but the motion carried.

Vice President F. O'Boyle accepted the decision of Borough Council and that he was not happy with it.
