**Quotes for Razing 32 Brunswick** – After reviewing two (2) quotes, Councilmember A. Montanez moved to accept the quote to raze the building at 32 Brunswick Drive from E.F. Possinger & Sons, Inc. in the amount of \$17,974.00 with the condition of receiving a monthly payment schedule to be voted on at the October 4<sup>th</sup> Borough Council meeting. Councilmember S. Stewart-Keeler seconded. Motion carried unanimously.

**County Waste Contract Renewal** – Sanitation Committee Chair, Councilmember A. Montanez reported that the letter requesting for an additional year was sent and that a meeting has been scheduled for Thursday, September 30<sup>th</sup> with a County Waste representative. Councilmember A. Montanez moved to approve bulk pick-up for the month of October on the first and third Thursday of the month with no reduction of bulk items allowed to be collected. Councilmember S. Stewart-Keeler seconded. Motion carried unanimously.

**County Emergency Declaration and Borough's Storm Damage** – Mayor M. Penn updated Borough Council that the County submitted \$880,000.00 in damages.

Hazard Mitigation Plan – Mayor M. Penn reported that the letter of intent is due October 14<sup>th</sup> and that Borough Council should vote on this at its October 4<sup>th</sup> meeting. He added that a letter of intent needs to be done at our next meeting. He noted that we need to designate an "Application Agent" for each project and we have until December to complete estimates for the following projects: #1 – Upgrade fire facility – category 4 shelter with the Fire Department taking the lead; #2 Pump Station – Mount Pocono Municipal Authority (MPMA); #3 – Expansion tank at Industrial Park – MPMA; #4 – Five Points traffic study – Borough Manager; #5 – Equip/ retrofit fire truck for hose to increase water flow; #6 – Fairview Lake – dam and lake clean up (private property); #7 – pump addition redundancy at main plant – MPMA; and, #8 – Stormwater management study, anticipation of the MS-4 Plan - Borough.

Approval of Barry St. Cyr as Permanent Employee – Councilmember A. Montanez moved to end Barry St. Cyr's probationary period and to make him a permanent full-time employee with a \$1.00 per hour increase as of September 26, 2021, with benefits. Councilmember P. **2022 Minimum Municipal Obligation (MMO) Pension Plan** – Councilmember A. Montanez moved to approve the 2022 MMO for pension plan in the amount of \$23,074.00. Councilmember S. Stewart-Keeler seconded. Motion carried unanimously.
