Councilmember T. Neville seconded. Vice President F. O'Boyle suggested that the motion should include the Liquid Fuels and the Road Improvement Funds. Councilmember P. Bucco amended her motion by adopting the 2021 Budget as presented and to include the Liquid Fuels is budgeted for \$102,785.00 and the Street Improvement Fund is \$121,134.00. Councilmember T. Neville seconded. Motion carried unanimously.

UNFINISHED BUSINESS

Technology Updates

President C. Williams noted that the Borough's GoDaddy Account will expire the end of this month. She also noted that after the approval from the Borough Council Borough Manager J. Walker has purchased the computers that were needed.

Borough Manager explained the G Suite cost would be \$6.00 per user totaling for the month \$78.00 and that comes to \$936.00 per year. He also commented that the comparison cost between GoDaddy and the G Suite is a savings of approximately \$250.00. He noted that price also includes some storage. He also noted that most of email accounts have been set up.

Mayor M. Penn noted the "archive" function when using the G Suite and asked Borough Manager J. Walker to follow-up with GoDaddy regarding the email migration.

Councilmember S. Stewart-Keeler moved to move forward with the G Suite from GoDaddy. Councilmember P. Bucco seconded. Motion carried unanimously.

HVAC System

Borough Manager explained that he has the original invoice from Metz with a total replacement cost of 24,000 to repair/replace the current HVAC system. He stated that he has received a second estimate from R.J.

Groaner which is higher. However, he has sent these estimates to the County. He noted that the County's deadline was yesterday and were received. Let it be noted that bids for County monies must be a member of Costars.

After some discussion, President C. Williams asked the Borough Manager to contact R.J. Groaner to see if the are part of the Costar program and we will wait to make any decision. Borough Manager J. Walker just received confirmation that R.J. Groaner is not part of the Costars program. The Borough Manager was also asked to find out from Metz if there would be an increase to the quote for any upgrades, i.e., thermostats.

Meeting Dates

President C. Williams reminded everyone that meeting dates were confirmed and advertised to meet the needs of Borough Council, to include actions that would need to be taken.

Snow Emergency

Vice President F. O'Boyle stated his concerns regarding cars parked on the roads that hinders the snow removal by the road crew.

Mayor M. Penn suggested that Borough Council declare some roads as snow emergency routes. He noted that this would allow the Borough to remove cars that get stuck without calling police intervention. He also noted that Emergency Services Coordinator R. Gannon is working on this and will be talking with Road Supervisor J. Trombetta which roads should be included in this plan.

President C. Williams stated that the Zoning Department can send a friendly letter informing people not to park in the street to discourage parking in the street.

Zoning/ Codes Enforcement Officer stated that there is no parking allowed in the streets especially overnight however in the Borough's Ordinance states the enforcement is by the Pocono Mountain Regional Police.

Councilmember T. Neville stated he has concerns with the snowplowing especially with shopping carts in the roadway. He noticed that one (1) on Knox Street was demolished and is not sure if it was a car or it was damaged by a snowplow. It was noted that there are shopping carts all over the Borough and it is a hazardous situation.

President C. Williams noted that this will be discussed more at the work session.

HVAC System Continued

Borough Manager J. Walker spoke to Metz noting that they are not with Costars. He also asked them if the upgrades including new thermostats are included in the original quote if not how much more would the upgrades be.

Solicitor J. Fareri reminded Borough Council that this cost exceeds the \$21,000.00 bid threshold and could possibly need to publicly ask for bids. He also asked to review the grant agreement. He stated that he will call the County grant department to confirm that if the Borough is in the process will the grant be available to the Borough.

Councilmember S. Stewart-Keeler moved accept the grant funds from the County subject to immediately putting out to bid regarding the HVAC system and act on when the bids are received. Commissioner P. Bucco seconded. Motion carried unanimously.
