



#### Mount Pocono, 1928 (Sanborn Map Co.)

In May, 1928, not quite one year after the incorporation of the Borough on July 12, 1927, Mount Pocono was home to 400 citizens. The blue-shaded building near the center (next to the Post Office) was the Pocono Mountain Volunteer Fire Company, which numbered 75 volunteers and boasted a Larrabee Triple Combination Pumper truck capable of putting out 350 gallons per minute .

#### 'The Forks Post' - What's in a Name?

Our newsletter's name hearkens back the to the 1830s when this area was known as "The Forks" - a reference to the intersection of several major roadways.

The railroad stop & post office here were also known as "Forks, Pa."

But by about 1880, local merchants adopted "Mount Pocono." That was thought to be a more attractive moniker to the growing New York & Philadelphia tourist trade.

So, that was the name selected for the new borough when it was officially incorporated in July, 1927

# **Mount Pocono Borough Ordinances**

#### **RECENTLY-PASSED ORDINANCES**

#### **QUALITY OF LIFE ORDINANCE**

A ticketing ordinance which permits certain borough employees to issue citations for violations of certain ordinances, such as noxious weed control ordinances, trash accumulation, fireworks, and more. The Quality of Life ticketing ordinance helps make enforcement of nuisance violations more expedient and impactful.

#### **KEEPING OF CHICKENS**

Allows residents to maintain small backyard chicken flocks for personal egg production, subject to size and placement restrictions, inspections, and fees.

#### SHOPPING CARTS ORDINANCE

Encourages retail stores to adopt measures to reduce or eliminate the proliferation of abandoned shopping carts on the streets of the borough.

#### PROHIBITING PARKING ON SR 196

This traffic and pedestrian safety measure expressly prohibits parking anywhere on State Route 196/Sterling Road within the borough.

#### SNOW REMOVAL Ordinance Amendments

This amendment to our snow removal regulations clarifies and expands the obligations of residents and businesses to clear snow and ice from sidewalks, hydrants, and catch basins abutting their property.

#### ELIMINATING COMPENSATION OF ELECTED OFFICIALS

This ordinance eliminates compensation for council members and the mayor. Under state law, it will be effective only for future council terms. All Mount Pocono ordinances are available on our website. Last year, the council retained a service to consolidate and electronically publish all of the borough Ordinances. Ordinances through June, 2020, are available in our online E-Code, found at *ecode360.com/MO2008* 

The E-Code is updated periodically. All newly-passed ordinances can be reviewed and downloaded from the Document library on our municipal website at *mountpocono-pa.gov/documents*





# Borough Council Statement on the 2023 Property Tax Rate

The Budget Committee had over 7 budget work ses- cantly reduced and in reality the amount was closer sions totaling 30 hours. As a result we found some glaring numbers that had to be addressed for the 2023 mately \$90,000.00. budget.

Our findings include:

• Our commitment to the PMRPD increased by 12.7%. Equaling about half of all real estate taxes collected by the borough.

• Walmart had a reassessment appeal awarded to them. Due to this reassessment the borough had to budget a refund to Walmart for roughly \$25,000 this coming budget year.

• We feel that based on the trends from last year and what economists are predicting, there is going to be an increase of at least 10% in heating oil and electricity costs.

• In the past council reallocated funds from the five points intersection in order to balance the budget in the amount of \$140,000.00. In order for us to be fiscally responsible this needed to be corrected. Due to the large amount, these funds will need to be repaid over the course of 4 years.

• Most of our maintenance equipment is old and wearing quickly. We have 10 pieces of equipment ranging from 1997 to 2015. The maintenance costs to keep these vehicles on the road is excessive but necessarv.

• Union Negotiations are still on-going in order to finalize a contract both parties can agree on. As a result we had to budget for the "worse case scenario".

• Real estate tax revenues decreased by 2% after the last property reassessment giving the borough yet another budget shortfall totaling close to \$100,000.00.

We (the council) feel the borough should be run as a business and that is what we intend to do moving forward. In the name of fiscal responsibility we eliminated compensation for all elected officials as well as having several council-members attend seminars that were solely based on running a borough effectively and financially. Previous councils worked on the issues at hand but failed to forecast for what may be needed in the future, we intend to change this practice. Every seminar that was attended stressed the importance of having an emergency fund set aside to cover the borough's expenses for at least six months. We all agreed that to be financially responsible this needed to happen. If we start putting money aside each year, we will have a fund established to handle capital expenditures in the future. Raising taxes was not something that this council took lightly. We are all homeowners and this decision affects our taxes as well. # **Council President's Letter**

From Council President Don Struckle

We on council are proud of our newsletter and hope you appreciate it too! It is one of the many accomplishments our new borough council has achieved over the first year in office for most of us. Please thank the advertisers who make it possible to bring it to

you at no cost whatsoever!

Among our other achievements is a new, robust, informative website (www.mountpocono-pa.gov), which reflects this council's goals of increased transparency and wide distribution of government documents. On the website you'll have access to meeting agenda, meeting packets, and minutes, as well as a searchable online collection of our ordinances and an interactive zoning map.

Behind the scenes, we have overhauled our borough building security with a new camera system to maximize coverage, a modern state of the art alarm system, and integrated our surveillance, fire, burglar, and security technology for easier access. We've installed much needed new carpeting downstairs and restored the historic original hardwood flooring upstairs. New energy efficient window coverings were installed in 2022 and the borough entered into a comprehensive HVAC contract with a local provider. Our new landscaping was partially paid for with grant monies.

We also improved our zoning and code enforcement by contracting with a professional, experienced local zoning and code enforcement company to handle those duties. This will make for more efficient enforcement of our new shopping cart ordinance, quality of life regulations, short-term rental changes, and our improved snow-removal rules, as well as all of other other borough ordinances.


Financially, we are dedicated to putting the borough back on the right path. We are instituting a capital reserve so that future emergency expenditures don't disrupt our budget. We also applied for \$3 million in grants in 2022, seeking to upgrade our park, for road work, and for safety and beautification.

In 2023, we are looking forward to a new maintenance garage which will be mostly paid for with a \$491,000 LSA grant received in 2022, another \$200,000 of street paving, and strengthening our improving relations with PennDot, which controls the major roadways in our town.

All of this and more were accomplished by the entire borough council finally rowing in the same direction and putting aside differences to focus on what is best for the borough. Borough Manager Joshua Walker worked tirelessly with us last year to initiate and help bring to fruition many of these accomplishments.

The entire council is justifiably proud of our accomplishments and are very hopeful about the future of Mount Pocono Borough as we head towards our centennial celebration in 2027.
