Mount Pocono LED Sign Content Guidelines

Effective Date:

The Mount Pocono LED sign, located in front of the Borough Building, serves as a valuable means of communication with the community. To ensure that the content displayed on this sign remains consistent with the objectives of the Borough and fosters a welcoming and non-partisan atmosphere, the following guidelines have been established.

Objective:

These content guidelines aim to maintain the focus of the Mount Pocono LED sign on information and events directly related to the Borough, its services, and its residents. The guidelines also prohibit any political or non-Borough-related content to ensure neutrality and inclusivity.

Borough Business:

- The primary purpose of the Mount Pocono LED sign is to convey information and updates related to the Borough's operations, services, and events.
- Borough business includes notices, announcements, and advertisements of official Borough meetings, community events organized or supported by the Borough, and other government-related information.

Exclusion of Political Signs:

- No political campaign signs, advertisements, or endorsements for any political candidate, party, or issue may be displayed.
- The sign must remain politically neutral and free from any bias or partisanship.

Events Hosted by the Borough:

- Information about events hosted, sponsored, or endorsed by the Borough may be displayed on the LED sign.
- These events must be directly related to the Borough's community-building, recreational, cultural, or educational activities.

Exclusivity of Content:

- Only content related to Borough business or Borough-endorsed events may be displayed on the LED sign.
- Advertising for private businesses or non-profit organizations that are not directly affiliated with or endorsed by the Borough is not permitted.

Frequency of Content Rotation:

- The LED sign should be regularly updated to ensure that the information remains current and relevant to the community.
- The Borough reserves the right to determine the frequency of content rotation.

Emergency Alerts:

- In the event of emergencies or urgent information affecting the Borough and its residents, the LED sign may be used to disseminate important updates and instructions.

Community Guidelines:

- The content displayed on the Mount Pocono LED sign should adhere to community standards and be suitable for all audiences.
- Any content deemed inappropriate, offensive, or contrary to the interests and values of the community will not be approved

Compliance and Enforcement:

The Borough reserves the right to enforce these guidelines to maintain the integrity and purpose of the LED sign. These content guidelines are designed to promote transparency, inclusivity, and a strong sense of community within Mount Pocono. The Borough appreciates the cooperation of its residents and stakeholders in adhering to these guidelines to ensure the effectiveness and appropriateness of the LED sign's content.

DOG PARK RULES

- **USE PARK AT YOUR OWN RISK**
- **OWNERS ARE LEGALLY RESPONSIBLE FOR THE BEHAVIOR OF THEIR DOG(S) AT ALL TIMES.**
- **DOGS MUST BE LEASHED WHILE ENTERING AND EXITING THE PARK.**
- **DOG WASTE MUST BE CLEANED UP BY THEIR OWNERS IMMEDIATELY.**
- **OWNERS MUST BE WITHIN THE DOG PARK AND SUPERVISING THEIR DOG WITH LEASH READILY AVAILABLE.**
- **DOG HANDLERS MUST BE AT LEAST 16 YEARS OF AGE.**
- **CHILDREN UNDER 13 MUST BE ACCOMPANIED BY AN ADULT AND SUPERVISED AT ALL TIMES**
- **AGGRESSIVE DOGS MUST BE REMOVED IMMEDIATELY.**
- **DOGS SHOULD BE UNDER VOICE CONTROL.**

- **HUMAN & DOG FOOD / TREATS**
- **GLASS CONTAINERS**
- **DOGS IN HEAT**
- **SICK DOGS**
- **AGGRESSIVE DOGS**
- **PUPPIES (UNDER 4 MONTHS)**
