What's new:

- Currently, 151 crews are working on debris removal. Each crew makes between 10 and 20 trips per day hauling debris. That means there are between 1,500 and 3,000 trips made in and out of Paradise by debris removal trucks for the state program every day!

- There are 171 businesses open on the ridge according to the Paradise Chamber of Commerce.

• In Case you Missed it: On June 25th, the Town Council voted unanimously to adopt the Long-Term Community Recovery Plan.

The presentation of community vision included the projects that were previously presented to the public for feedback. These projects are not all Town-led projects---some projects will be undertaken by other agencies, entities or non-profits (e.g. PID is the lead on repairing the water system.) The Town Council will have an opportunity to prioritize the town-led projects at its goal setting session in July). All projects will go before the council at future meetings—some projects will go before the council many times during different phases of the project (e.g. design, engineering, grant approvals, etc.) All projects have different priorities, cost estimates, and proposed funding sources--these are all estimates.

Q: What is the latest update on trees? Where should we report trees that need removal?

A: Trees remain a top priority for the Town of Paradise. For trees in the public right of way, the Town has hired an arborist to identify trees that need to be removed. So far about 3,900 have been identified by the arborist, and they will be removed over the next 4-8 months. For trees on private property, the Town is still working with our recovery partners, Cal OES and FEMA, on a program that would help with the cost of removal. Butte County Fire Safe Council is also applying for grants that will help property owners offset the cost to remove trees on private property. As soon as these programs are confirmed, the Town will make the information about how to apply available.

Q: What is the latest update on abatement?

A: All properties in the Town of Paradise with qualifying debris must have the debris removed for health and safety reasons. If a property owner has not turned in paperwork for either the state program or the alternative (private contractor) program, the property will go into the abatement process to remove the debris. After the property owner has been given a final opportunity to remove the debris, the debris will be removed by the Town, utilizing the state debris removal teams, at the expense of the property owner. The abatement process is generally more expensive than using either the state program or a private contractor, and we advise anyone who has not selected an option at this point to please contact Butte

County at (530) 552-3155 to avoid the abatement process and select an option now.

Q: What are the top 3 reasons a resident should attend Home Builder Expo?

A: If you are rebuilding, or even if you're just thinking about it, the Home Builder Expo is a great place to start, and it's free to attend! Here are three reasons to attend the expo:
