#### What's new:

- The July Paradise Community Information Meeting will once again take place at the Paradise Alliance Church. In following proper COVID-19 safety precautions, the first 100 attendees may join the meeting in person at 6491 Clark Road. Masks and social distancing are required to attend (Please bring your own masks). The meeting will be broadcast live on the Towns Facebook page and YouTube channel. - Reminder! "Safe and Sane" Fireworks are not allowed in Paradise or anywhere in Butte County, except within the limits of Oroville and Gridley. Help keep Paradise Fire Safe!
- **Great news!** Paradise Irrigation District's \$7.3 million backfill from the State of California has been restored in the budget signed by Governor Newsom.
- Important: As of January 1, 2021, the rules about living in RVs on private lots in town will change back to pre-fire rules. You will be required to be actively rebuilding a permanent home on your property (different than a temporary RV permit) to continue living on your property in an RV. - Hazardous Trees Town of Paradise needs your help! There are still over 2,000 properties in The Town of Paradise that have not completed their TROE form. In order to remove all dead and dying trees there is an urgent need for all residents who have not completed this form to do make it a priority. Ask your neighbors, family and friends both in town and those who have been relocated out of state but still own property --Have you completed your TROE?

- The Camp Fire Shed Project is now accepting applications for Round 2! The second build will take place August 30-September 18, 2020! If you applied for round 2 prior to COVID-19, there's no need to reapply. Applications found here. Recap: If you owned a home on 11/8/2018 and lost your home or had significant damage due to the Camp Fire, are located within the burn scar area, currently living in an RV/Trailer/Tent, intend to rebuild and your insurance did not cover shed replacement, this program might be for you! Visit the criteria form to learn more.
- Help keep Paradise fire safe! If you own a lot in Paradise, it is your
  responsibility to maintain it. If you need help clearing your lot of weeds and
  brush, you can contact a local company who can do the work for you. Find a list

- Missing Middle Grant Income Limits Extended for Larger Households. The
  grant helps reduce pre-construction costs for lower, middle -lower and middle
  class households who want to build/rebuild in the Camp Fire footprint. The grant
  reimburses up to \$5,000 pre-construction costs. Find more details at

- FREE masks are available at the Paradise Ridge Chamber of Commerce to Ridge businesses. This is a joint effort from the North Valley Community Foundation and Feather River Health Foundation.
