8. COUNCIL REPORTS AND REQUESTS

Councilmember Hawkins

- Attended the Snoqualmie Valley Mobility Coalition meeting.
 - The lack of regular transportation negatively impacts the area.
 - The City qualifies for funding based on land use and equity.
 - Asked King County Metro what they are doing to help economic vitality.
- The Safety Committee met to discuss implementing the City's own drug possession laws.
- Met with the Economic Development Committee CED Principal Ender will go over the updates during her report.
- The Washington State Department of Transportation Fish Passage Project is underway in Carnation and Fall City.
 - Travelers on SR 202 and SR 203 should prepare for closures May 15th – May 19^{th.}
 - Contractors will survey land for fish passages 9:00 P.M. 3:00 P.M.
- Washington State Department of Social and Human Services Mobile Community Services Offices will be at the following places:
 - Snoqualmie Valley Food Bank on May 24th from 10:00 A.M. 2:00 P.M.
 - Redmond King County Library May 31st from 1:00 P.M. 4:00 P.M.

Councilmember Burrell

- Thanked the City's Public Works Department for paving the Valley Memorial Park parking lot,
 - Fixed the potholes for pick-up and drop-off at Tolt Middle School.

- Attended the Chamber of Commerce all-member meeting. Mentioned he has been learning how much the group does and appreciates their hard work.
- The Remlinger Arcade is opening next week.
 - Joked about the "break-in": The door to the arcade was unlocked and visitors played games and purchased items prior to opening.
- Attended the Valley Radio fundraiser at Remlinger Brewing, volunteered to do set up with Jamie Burrell (his wife)
- Provided an update on the Tolt Middle School evacuation path.
 - Funding looks promising.
 - Will be paved from back side of track the North end of the property out to the trail.

Councilmember Green

- Attended the Chamber of Commerce hoedown event at Remlinger Brewing on May 13th. This was a benefit auction for the community radio station Valley 104.9.
 - In an emergency situation, they could be the only communication channel up and running due to their FM license.
 - His wife Debbie is the president of the Chamber of Commerce

Deputy Mayor Harris

- Attended the Chamber of Commerce hoedown and won a trip.
- A number of citizens commented on how nice the City looks.
 - Thanked City staff and the public works department for their work on the parks and alleys.
- Talked to the Municipal Research and Services Center (MRSC) on how to protect the tenants of mobile home park.
 - Our current zoning provides a significant amount of protection.
 - The State preempts cities and counties in enacting rent control efforts.
 - Could look into administrative steps to make eviction more difficult.
- Had coffee with King County Councilmember Sarah Perry and talked about the behavioral health levy that recently passed.
 - Didn't do well outside of Seattle, and east of the highway the levy didn't pass.
 - Discussed the tax burden felt on the citizens of Carnation.
 - Demographics are misleading a lot of affluence vs. people just scraping by living on fixed incomes.
 - Analyze the differences between County revenues from Carnation and expenditures in the Snoqualmie Valley. Was connected with the King County Budget Office.

- Regional Water Quality Committee (RWQC) King County executive has a proposed Ordinance to set sewer rates for next year:
 - Asking for \$9 million to add 73 additional employees to the Water Treatment Division
 - Want to raise rates to \$55.11 in 2024. Projections are set to double to \$97.63 by 2033.
- The Finance and Operations Committee is trying a new method for reviewing claims using the accounting system itself to save staff time and streamline the process.

Mayor Ribail

- Attended the Eastside Mayors meeting on May 10th.
 - Mayors from Redmond, Issaquah, Snoqualmie, and North Bend were in attendance.
 - Talked about the Blake Decision, however legislation was passed at the state level.
 - Redmond and Issaquah are struggling with growth.
 - Microsoft is moving out of Issaquah.
 - Requested sign code from other cities for the Economic Development Committee.
- Attended the Chamber of Commerce all-member meeting.
 - Chamber has many events lined up through the Fall excited about the Chili Cook-Off
- Had a meeting with Susan Leach, the Superintendent of River School District.
 - District is having budget issues.
 - Hired a new high school principal, middle school principal and Director of Student Services
- Attended the Valley 104.9 Auction.
 - There was a donut bidding war with Councilmember Green and Mayor Ribail's friend.

9. STAFF REPORTS:

- a) Community Economic Development Department Report CED Principal Rhonda Ender
 - Gave an update on development projects:
 - Pulte's Building A broke ground and is set to be completed in mid to late July.
 - Mainvue is working on their model home submittal.
 - John Day's Tolt Place working through civil plans and revisions.
 - The Senior Center's affordable housing project will break ground in July, and a Public Hearing is scheduled for May 31st.

- Tolt Legal's building permits were issued last Friday, and they have a right of way permit starting May 26th to pour concrete.
- The Stossel Court project, which is two duplexes that Fortney Construction is developing on Stossel Avenue, is back to an active status.
- Permits are going smoothly and efficiently.
- A Planning and Parks Board meeting is set for May 23rd good feedback has been received about the level of collaboration happening.
- Members of the Port of Seattle had a tour of Carnation to discuss ways partner together.
- Has a Meeting on Monday with Seattle Uncorked about bringing the wine and beer walk to Carnation.
- Attended the Chamber of Commerce All-member Meeting.
- Attended the Snoqualmie Valley Outdoor Recreation group meeting.
- Has a meeting on Thursday with a company to discuss retail strategy.
- Met with a resident who wants to open a boutique with housewares, reached out to Jason Ziegler about the confluence building =, but he is not quite ready.
- Had a 4-hour Community Rating System (CRS) site visit, will conduct additional education on flood management in order to get flood insurance discount for residents.
- Provided Code Enforcement Updates:
 - Reminded residents and HOAs to keep common areas and bioswales and yards maintained.
 - \circ Grass on 334th will be mowed by Friday.
 - Vehicle abandoned being addressed.
- Economic Development Committee meeting scheduled this Friday.
- b) Capital Improvement Projects / Administrative Services Department Report -Administrative Services Manager Lora Wilmes
 - The Emergency Operations Center/ multiuse center sent out to bid today on Builders Exchange
 - Bid opening day is June 20th, will have the assumed lowest bidder that day at the Council Meeting.
 - Transportation Improvement Board gave the City funding for the citywide crack seal.
 - A Six Year Transportation Improvement Plan (STIP) update will occur at the next Council meeting in June.
 - Funding works two years ahead we have funding for design and construction for the next two years.
 - Provided an update on Tolt Avenue

- Yearlong landscaping contract, fixed dozens of broken irrigation heads and maintained storm drains (the City of Carnation is 100% infiltration for stormwater)
- Phase 2 bid documents getting ready to go out.
- Washington State Department of Transportation committed funding.
- East Bird, McKinley, and Entwistle have finished the surveying stage and starting the formal design process.
 - $\circ~$ East Bird was graded, and gravel was added.
 - Had a meeting with CED Principal Ender, KPG and Pulte Homes to discuss the two projects on McKinley.
- Has a meeting set up with CED Utility Manager Schell and landscapers on May 24th to focus on trouble spots on Tolt Avenue.
- c) City Manager's Office Report City Manager Ana Cortez
 - Thanked the Council for recognizing staff for the work done on alleys and parking lots. Highlighted other work like utility billing and making sure vendors were getting paid.
 - The City is focusing on doing more with less.
 - Public Works department used to have 6 crewmembers, now there are 3, accompanied by an army of contractors. The City is still looking for candidates to join the team.
 - City has high standards, more of a start-up rather than a traditional government agency.
 - Collectives Bargaining Agreement with Teamsters made us more competitive with salaries and benefits.
 - Building new relationships with the community Tolt United Congregational Church reached out.
 - Had a meeting with a representative from Harvold family, moving forward slowly.
 - Thoroughly review documents, The City Manager is the first line of defense.
 - Had a good meeting with Drake Remlinger group.
 - Elections have begun, the filing period started yesterday and ends on Friday.
 - Will be on vacation from May 26th June 7th. Will be out of the country leaving phone in Carnation. Will miss the meeting on June 6th.
 - Took a moment to recognize staff:
 - CED Manager Schell and his team for all their work and being available round the clock to respond to issues. Current staff is salaried, meaning no overtime,

- Administrative Services Manager Wilmes –continues to deliver on many fronts: capital improvement projects, utility billing, customer service, capacity building software transition etc.
- CED Principal Ender reports most interesting, only been here for 5 months: flood management, permitting, economic development code enforcement)
- PIO Farnworth has a gift for aesthetics and is spread in lots of directions.
- Bibi, Heather, Mike, and Erik make incredible team.
- When City Manager Cortez first arrived, payroll was over \$100,000, now it is less than \$25,000.
