APPLICATION FOR STREET USE PERMIT

12.08.010 Permit Required. No person shall use any public right-of-way, street, sidewalk or other public place without a street use permit. The term "use" shall mean to construct, erect or maintain in, on, over or under, any public place, any building, structure, scaffolding, etc., or to otherwise use or to occupy or in any way obstruct any public parking strip, sidewalk or roadway within the City. (Ord. 435 § 2, 1990)

APPROVAL OF THIS PERMIT IS SUBJECT TO THE FOLLOWING CONDITIONS:

1. That the applicant hold the City harmless as per attached agreement (page 2);
2. Applicant to provide proof of Liability Insurance Coverage;
3. That in the event of sale or transfer of the business known as _____, this permit shall terminate and be subject to "renewal" only upon re-application of the new owner or owners;
4. Permit Application fee of \$25.00 for retail sidewalk use or \$200.00 for other use must be paid at the time of application;
5. No less than four feet of unobstructed sidewalk, or other walkway, must be maintained at all times, unless otherwise specified.
