PLEASE TAKE NOTICE that the Zoning Board of Appeals of the Charter Township of Kalamazoo will conduct a public hearing concerning the following matter(s) on Wednesday, October 17, 2018 commencing at 7:00 p.m. at the Township Hall, 1720 Riverview Drive.

PLEASE TAKE FURTHER NOTICE that the item(s) to be considered include, in brief, the following:

- 1. Consideration of the request of Clarence and Candice Ewert, 2206 Woodward Avenue appealing the zoning administrator's denial of an application to rebuild a nonconforming garage 31' x 32' (992 square feet) in size on an existing foundation or, in the alternative, for variances to permit the reconstruction of said nonconforming garage on the existing foundation on the northeast section of the property. Specifically, the applicants wish a 1-building variance from the 2 detached accessory building limitation contained in Section 3.02 of the Zoning Ordinance in order to allow a third accessory building on the parcel and a 224 square foot variance from the 768 square foot detached accessory building size limitation contained in Section 3.02 of the Zoning Ordinance for the proposed 992 square foot accessory building. The property is located in the R-2 Single and Two-family residential district zoning classification. Standards for Zoning Board of Appeals review are contained in §7.04.E of the Township Zoning Ordinance.
- 2. Consideration of the request of RWL Signs Company on behalf of Borgess Hospital/Ascension Health for variances from the General Sign provisions contained in Section 7.05 of the Zoning Ordinance in order to place 40 directional signs ranging in size from 6 square feet to 64 square feet (most of which are 20 to 48 square feet in size) and variances from the 48 square foot/6 foot height limitation for freestanding signs contained in Section 7.08D of the Zoning Ordinance in order to permit the construction of two principal freestanding signs, one of 170 square feet in size proposed at 18'11" in height and the second proposed to be 90 square feet in size and 15 feet in height on the Borgess Hospital/Ascension Health Campus located at 1521 Gull Road within the Township.
- 3. Such other matters as may properly come before the Zoning Board of Appeals.
