## CHERRY TOWNSHIP REORGANIZATION MEETING JANUARY 3, 2023

The annual reorganizational meeting of the Cherry Township Board of Supervisors was held on January 3, 2023 at 7:00 p.m. at the Township Municipal Building. Those present were Mr. Frank Fritz, Mr. David Mishler, Mr. William Smith, and Mrs. Carolyn Yeager.

- Mr. Mishler made a motion to appoint Frank Fritz as temporary chairman and Carolyn Yeager as temporary secretary. Mr. Smith seconded the motion. The motion carried.
- Mr. Mishler made a motion to appoint Mr. Fritz as permanent Chairman of the Board. Mr. Smith seconded the motion. The motion carried.
- Mr. Smith made a motion to appoint Mr. Mishler as Vice Chairman of the Board. Mr. Fritz seconded the motion. The motion carried.
- Mr. Mishler made a motion to appoint Mrs. Yeager as permanent Secretary/Treasurer for 2023, with wages set at \$19.50 an hour. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to appoint Mr. Smith as Road Master. Mr. Fritz seconded the motion. The motion carried. Mr. Mishler made a motion to recommend, to the auditors, that Mr. Smith's wages be set at \$24.80 per hour. Mr. Fritz seconded the motion. The motion carried. Mr. Mishler made a motion to appoint Gary Blauser as Co-Road Master for the 2023 calendar year at a pay rate of \$23.60 an hour. Mr. Fritz seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to appoint Duane Anderson as Equipment and Maintenance Manager for the 2023 calendar year, and to set his wages for 2023 at \$23.60 per hour. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to appoint Collin Fanataskey as primary SEO for Cherry Township for 2023 and Patrick West as backup SEO for 2023. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to appoint Treva Simmons and Becky Bremiller as auditors, to work with our elected auditor, when auditing the 2022 Township financial records. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to maintain the treasurer's bond at \$200,000. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to appoint Gallagher Law Group as legal counsel for 2023. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried.

- Mr. Mishler made a motion to appoint Gateway Engineers as the Township Engineer for 2023. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to appoint Lee Yeager as the Vacancy Board Chairman. Mr. Fritz seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to appoint MDIA, Keith Reiser, as the building code official and inspection services for the Township for 2023. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to appoint Mrs. Yeager as the Open Records Officer for 2023. Mr. Fritz seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to maintain First National Bank as the financial institution for the Township's General Fund monies and PLGIT as the financial institution for the Liquid Fuels Fund monies for 2023. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to set the meeting dates as presented and advertised for 2023. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to adopt the holidays and vacation for the road crew as presented. Mr. Fritz seconded the motion. The motion carried.
- Mr. Mishler made a motion to adopt the fee schedule for 2023, as presented. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to maintain the current tax rates for 2023. Mr. Fritz seconded the motion. All three supervisors voted yes. The motion carried.
- Mr. Mishler made a motion to adopt Resolution 23-01, accepting the budget, tax rates, and fee schedules for 2023. Mr. Smith seconded the motion. All three supervisors voted yes. The motion carried. The Resolution was signed and sealed.
- Mr. Mishler made a motion to set the 2023 mileage rate at \$.585 per mile. Mr. Fritz seconded the motion. All three supervisors voted yes. The motion carried.
