Site inspection of the installed erosion control/silt fencing, tree protection and construction entrance/tire cleaner has been performed and approved by the Borough. If applicable, a fence installed around the perimeter of the existing or proposed on-site sewer system to protect the drain field, tank and underground piping from equipment and vehicles.
