Town of Colma – Recreation Services Department Colma Resident Cards

In order to participate in Town of Colma Recreation programs, or rent recreation facilities residents must first obtain a Town of Colma Resident Card.

Town of Colma Resident Cards are free to residents and can be obtained at the Colma Community. Residents must show proof of residency prior to obtaining a Colma Resident Card. Please see below for acceptable forms of proof of residency.

Acceptable forms of residency for adults 18 years and older:

Proof of Identification (must have one of the following):

- Previous Colma ID card, issued after August 22, 2007
- U.S. passport which is not mutilated, altered, or damaged
- Naturalization Certificate
- Current, valid state driver's license
- Current, valid government ID (city, state or federal)
- Current, valid military ID for service personnel or dependents
- U.S. Visa.

Proof of Residency (must have two or more of the following documents with your name, Colma address, and is dated not more than 30 days old):

- Current Utility Bill, Credit Card Bill, Bank Statement, Pay Stub, Phone Bill, Water Bill, Checking Account Statement, or Home Owners Association Bill
- Property Tax Bill, Mortgage Statement, Current Homeowners Insurance Statement
- Current Car Registration or Auto Insurance Bill
- Health Insurance Bill/Statement
- Current College Tuition/Statements or Report Card
- Voter Registration Information

Proof of Residency – Spouse - A spouse or domestic partner living with a Colma resident who has established residency by providing the above documentation, but who cannot independently prove Colma residency by providing documentation proving residency, may establish residency by showing proof of identification and by showing:

- Marriage Certificate to a Colma resident
- Court order establishing marriage to a adult Colma resident

Acceptable forms of residency for youth ages 5-17:

Rule:

A child must apply in person for a Colma Identification Card and must be accompanied by at least one parent or guardian. The child's parent or guardian must execute an affidavit or declaration of the child's residency and must present satisfactory proof of identification, relationship of the child to his or her parent or guardian, and Colma Identification Card of the child's parent or guardian.

Proof of Identification - A parent or guardian may prove the identity of his or her child or ward with any one of these documents:

- Previous Colma ID card, issued after August 22, 2007
- Certified U.S. birth certificate
- Valid U.S. passport
- Report or Certification of Birth Abroad from the U.S. State Department; or
- Certificate of Citizenship or Naturalization from U.S. Customs and Immigration Service.

Proof of Relationship to Parent or Guardian - The parent or guardian of the child must submit one of the following:

- Certified U.S. birth certificate of child (with parents' names)
- Certified foreign birth certificate of child (with parents' names and translation, if necessary)
- Report or Certification of Birth Abroad of child (with parents' names) issued by the U.S. State Department
- Adoption Decree (with adopting parents' names)
- Court Order establishing custody
- Court order establishing guardianship.
