### **State Laws Regarding Recycling**

### **AB 341: Mandatory Commercial Recycling**

AB 341 requires businesses, public entities and residential dwellings with 5+ units that generate four (4) or more cubic yards of garbage per week to recycle. Businesses are required to have a recycling program at your business and separate recyclable materials from waste. Contact Colma's franchised hauler Republic Services to start or increase your recycling program. 650-756-1130

### **AB 1826 Mandatory Commercial Organics (Compost) Recycling**

AB 1826 requires businesses and residential dwellings with 5+ units that generate organic waste (compost) to have an organics recycling collection service (includes schools, hospitals, stores, restaurants, for-profit or nonprofit organizations) Gardening or landscaping services offered to businesses are also subject to AB 1826. Contact Colma's franchised hauler Republic Services at 650-756-1130 to start or increase your recycling program.

#### What can I put in my organics recycling bin?

- Food scraps
- Green waste & yard trimmings
- Non-hazardous, non-treated wood waste
- Food-soiled paper like napkins/paper towels and cardboard like pizza boxes

#### Why are Compost Recycling Programs Required?

About 30 million tons of waste are landfill every year in California and 30% of this waste is organic/compostable material. When organics decompose in landfills it creates methane, a very potent greenhouse gas. By composting this material instead of landfilling it, less methane is produced. Also, compost builds soil health, helps soils retain water and reduces weed growth.

### **Construction & Demolition Recycling/CalGreen Requirements**

Construction projects that generate Construction and Demolition (C&D) debris are required to recycle 65% of the materials generated. C&D includes lumber, cardboard, metals, masonry (brick, concrete, etc.), carpet, plastic, pipe (plastic, metal, and clay), drywall, rocks, dirt, and plant materials. These mandatory requirements help California reach its goal of 75% recycling/waste diversion by 2020.
