Smoking Restrictions in Public Places

Effective September 22, 2018, the Town of Colma passed a Smoking Control Ordinance to assure that residents, visitors, employees and patrons can enjoy publicly accessible spaces without exposure to second hand smoke.

Smoking Prohibitions:

Smoking includes the use of cigarettes, cigars, e-cigarettes (vaping) and cannabis.

California state law prohibits smoking in all enclosed places of employment, restaurants and public buildings.

Colma's local ordinance include the following additional prohibitions:

- **Entrances:** No smoking within 20' of any entrance or exit to any enclosed public place such as a store, restaurant or public building.
- **Outdoor Dining Areas:** No smoking in or within 20' of an outdoor dining area.
- **Service Areas:** No smoking within 20' of a location where individuals are waiting for a service. Examples of service areas include bus stops and ATM's.
- **Special Events:** No smoking within the area used for a special event or within 20' of the special event area.
- **Public Parks:** No smoking within any Town of Colma park or within 20' of the park or facility.



Enforcement

The Town seeks and relies on our business community to post stickers or signage at entrances, exits and in any outdoor eating areas and to educate customers on non-smoking areas. In the event that a smoker continues to violate the regulations after being given a warning, the Town has the ability to cite the individual.
