Colma Community,

As you are aware, COVID-19 cases and hospitalizations surge and ICU capacity continues to decline. Therefore, San Mateo and 10 other Bay Area counties are now under a mandatory 'Regional Stay at Home Order' for the next three weeks.

I know this is going to be difficult due to the Holidays and New Year's, but the order prohibits private gatherings of any size, except for outdoor church services and political demonstrations. Please remain vigilant and refrain from gatherings and continue to Social Distance and wear a mask.

San Mateo County Health Director Scott Morrow has informed us if people continue to gather, the spread of COVID-19 could increase to even greater numbers than what we are seeing now during the months of January and February 2021.

With this new Stay at Home Order many businesses and activities must close, including salons and barbershops. Retail stores can remain open at 20 percent capacity. Nonessential travel and the use of hotels or short-term rentals for leisure is banned. Restaurants must stop offering inperson dining and can offer only take-out and delivery.

The state of California announced the order last week as regional ICU bed capacity fell below 15 percent, a trigger threshold. The order is meant to prevent crowding and mingling among non-household members and overwhelming the health care system.

The order is less sweeping than the lockdowns ordered in the spring. People can continue with essential activities like going to the doctor, buying groceries and picking up takeout food.

Outdoor activities like walking, hiking, cycling and outdoor religious ceremonies are permitted. All retail operations and shopping centers are limited to 20 percent capacity (35 percent for stand-alone grocery stores) with entrance metering and no eating or drinking in the stores.

Once again, we know this is a big inconvenience, but necessary to slow the spread of COVID-19 and keep the health care system from being overrun. Please remember the Town of Colma is here for you. ## Bay Area Region - Stay at Home Orders - Effective December 17, 2020.

The new order prohibits private gatherings of any size, closes sector operations except for critical infrastructure and retail, and requires 100% masking and physical distancing in all others. The following sectors must close:

- 1. Indoor playgrounds and Indoor recreational facilities
- 2. Hair salons and barbershops
- 3. Personal care services
- 4. Museums, zoos, and aquariums
- 5. Movie theaters
- 6. Wineries, Bars, breweries, and distilleries
- 7. Family entertainment centers
- 8. Cardrooms and satellite wagering
- 9. Limited services
- 10. Live audience sports and Amusement parks

The following sectors will have additional modifications in addition to 100% masking and physical distancing:

- 1. **Outdoor recreational facilities:** Allow outdoor operation only without any food, drink or alcohol sales. Additionally, overnight stays at campgrounds will not be permitted.
- 2. **Retail:** Allow indoor operation at 20% capacity with entrance metering and no eating or drinking in the stores. Additionally, special hours should be instituted for seniors and others with chronic conditions or compromised immune systems.
- 3. **Shopping centers**: Allow indoor operation at 20% capacity with entrance metering and no eating or drinking in the stores. Additionally, special hours should be instituted for seniors and others with chronic conditions or compromised immune systems.
- 4. Hotels and lodging: Allow to open for critical infrastructure support only.
- 5. **Restaurants:** Allow only for take-out, pick-up, or delivery.
- 6. **Offices:** Allow remote only except for critical infrastructure sectors where remote working is not possible.
- 7. Places of worship and political expression: Allow outdoor services only.
- 8. **Entertainment production including professional sports:** Allow operation without live audiences. Additionally, testing protocol and "bubbles" are highly encouraged.
- Outdoor playgrounds: Use allowed per revision to original stay at home order.

The following sectors are allowed **to remain open** when a remote option is not possible with appropriate infectious disease preventative measures including 100% masking and physical distancing:

- 1. Critical infrastructure
- 2. Schools that are already open for in-person learning
- 3. Non-urgent medical and dental care
- 4. Childcare and pre-K
