RECOMMENDATION

Staff recommends that the City Council:

- a. Conduct interviews with interested persons who have submitted an application for the vacant City Council seat; and
- b. *Consider*: Motion to appoint one candidate to the vacated City Council seat to serve the remaining term through 2024.

EXECUTIVE SUMMARY

At the August 10, 2022, Special City Council meeting, Council directed staff to prepare a recruitment and appointment process for the vacated City Council seat.

Staff opened the recruitment on August 12 and advertised the vacated City Council seat to the residents of Colma.

Six Colma residents submitted the required Willing to Serve Form, Letter of Intent and Resume by the deadline of August 29, 2022.

At the City Council meeting on September 7, City Council will interview the candidates for the vacated City Council seat, and will have the option of appointing one candidate, by motion, to the vacated City Council seat to serve the remaining term through 2024.

FISCAL IMPACT

None

BACKGROUND

On July 28, 2022, Vice Mayor Raquel "Rae" Gonzalez retired from the City Council, creating a vacancy on the City Council for the remainder of her term. Vice Mayor Gonzalez's term is set to expire in November 2024.

The City Council held a Special City Council Meeting on August 10, 2022 to decide whether to appoint a Colma resident to the vacated seat for the remainder of the Vice Mayor's term or to call for and hold a special election to elect a resident for the remainder of the Vice Mayor's term. Upon conclusion of the meeting the City Council directed staff to prepare a recruitment and appointment process for the vacated City Council seat.

Staff opened the recruitment on August 12 and advertised the vacated City Council seat to the residents of Colma. Staff advertised the vacated seat through direct mail to the community, the Town's website and social media outlets.

Six Colma residents submitted the required Willing to Serve Form, Letter of Intent and Resume by the deadline of August 29, 2022.

ANALYSIS

The City Council will interview the following candidates for the vacated City Council seat at the September 7, 2022, Special City Council Meeting.

- Claudia Mendoza
- Laura Walsh
- Carrie Slaughter
- Charito Casanas
- Erzsebet Taylor
- Ken Gonzalez

Upon conclusion of the interviews staff recommends the City Council appoint one of the abovementioned candidates to the City Council. Once approved by motion, the Mayor will swear in the newly appointed City Council member.

Alternatives

The City Council could choose not to appoint one of the candidates to the City Council and direct staff to prepare a staff report and resolution calling a special election for the vacated City Council seat before September 28, 2022. However, that is not the recommended action.

Council Adopted Values

The City Council is acting *responsibly* by filling the vacated City Council seat as soon as possible through the appointment process and conducting Town business with all five City Council seats filled.

CONCLUSION

Staff recommends that the City Council interview resident candidates and appoint one candidate by motion for the vacated City Council seat.



And the Town has resolved to "proactively work to ensure the rights and privileges of everyone, regardless of religion, ancestry, country of birth, immigration status, disability, gender, sexual orientation, or gender identity."
