#### **EXECUTIVE SUMMARY**

In the third quarter of 2023, a total of 3,031 participants attended 64 programs. This represents an increase of 615 participants from the third quarter of 2022. Staff attribute the increase in participants for Summer Day Camp, Early/Afternoon Care and increase in participation of senior trips and events like the BBQ at Creekside.

Staff estimates that 32 percent of the population had a current Colma I.D. during the third quarter of 2023.

There was a total of 56 rentals, which is an increase of 9 rental from the third quarter of 2022.

#### BACKGROUND

#### Participation

The Recreation Services Department offered programs, activities, events, and trips for all age groups during the past quarter. Below is a summary of participation levels by demographic:

• A total of 133 adults and seniors participated in enrichment programs. This represents an increase of 31 participants from the third quarter of 2022. Staff attributes the increase in participation to increase of interest of Friday Films and Armchair program, and Zumba fitness class.

- A total of 214 adults and seniors participated in trips and events. This represents a increase of 61 participants from the third quarter of 2022. Staff attributes the increase in participation due to the increase in Senior Luncheon and senior trips like Filoli Gardens.
- A total of 1,302 youth and teens participated in Enrichment Programs. This represents an increase of 488 participants from the third quarter of 2022. Staff attributes the increase due to the participation of in-person Summer Camp Early and Afternoon Care and interest in Lego Camp.
- A total of 114 youths and teens participated in events and trips. This represents an decrease of 10 participants from the third quarter of 2022. Staff attributes the decrease due to the decrease of number of day camp field trips in July and August.
- A total of 1,268 youth, adults and seniors participated in Community Programs. This represents an increase of 45 participants from the third quarter of 2022. Staff attributes the increase to the participation of family programs such as Parol Lantern Workshop, Grandparents Day Celebration and the Monterey Bay Aquarium trip.

The attachment contains a detailed breakdown of participation by program.

The Colma Community Center was rented for 46 different events:

- Resident Rental (18 social, 1 meeting)
- Colma Non-Profit (1 fundraiser)
- Non-Resident Rental (2 social, 1 funeral)
- Non-Resident Nonprofit (4 meeting)
- Non-Resident Nonprofit, kitchen only (19 reservations)
- In House Reservations (1 blood drive)

The Sterling Park Recreation Center was rented for 10 different events:

• Sterling Park Resident Rental Reservations (10 social events)
