**Notify emergency services** if you are in danger. You can also ask for help by putting a message in the chat function of this meeting.




Follow COVID-19 safety precautions including wearing a mask in public, practicing social distancing and washing your hands to prevent the spread.




## What's New in 2021


We are continuing to harden our electric grid to reduce wildfire risks, working nonstop to lessen the impact of Public Safety Power Shutoffs (PSPS) and providing more resources to customers and communities before, during and after PSPS events.

## What is a Public Safety Power Shutoff?

Safety is our most important responsibility. That is why we may need to turn off power as a last resort to prevent wildfires during severe weather conditions.

High winds and dangerous conditions can cause branches and debris to contact energized power lines.

This could damage our equipment and cause a wildfire.



To prevent such fires, we may need to turn off power.

This is called a Public Safety Power Shutoff (PSPS).



Once severe weather has passed, we will inspect the system and repair any damage.



Once inspections and any repairs are complete, power is restored.

## What Conditions Could Lead to a PSPS Event?

We carefully review a combination of factors when deciding if power must be turned off for safety. These factors include:



Low humidity levels generally 30% and below



Forecasted high winds above 20 mph and gusts above 30-40 mph



A Red Flag Warning issued by the National Weather Service



Condition of Dry Material on the ground and vegetation near lines



On-the-ground, real-time observations


## Tree Overstrike Exposure and Potential PSPS Decision-Making

The safety of our customers and communities is our most important responsibility. After last year's wildfire season and the drier than average weather we are experiencing, we have developed proposed additional criteria for our PSPS program, consistent with the proposed conditions of the federal court.

To reduce the risk of major wildfires, PG&E may turn off power on distribution lines\* where there are large amounts of trees tall enough to fall into electric lines during severe weather.

- Customers who live in areas of the highest wildfire risk may experience more frequent PSPS events compared to last year's weather conditions.
- We are in conversations with the court and CPUC regarding this additional criteria and we will share additional information as soon as possible.

<sup>\*</sup>Does not include transmission lines (which are considered to be ≥ 60 kV)





## **How Will Customers be Notified?**

When severe weather is forecast, we provide advance notice prior to turning off power and updates until power is restored.



## **Portable Battery Program**

PG&E is also conducting PSPS emergency preparedness outreach and energy needs assessments to support low-income Medical Baseline customers in high fire-threat areas with critical medical equipment and delivering fully subsidized portable battery solutions to eligible customers.

## **Generator Rebate Program**

Launched in late 2020, this program provides customers who depend on a well water pump and live in high fire-threat areas with a single rebate for purchasing a qualified portable power generator.



\$ 300 rebate for eligible customers.

> \$500 rebate for eligible customers who are also participants in the CARE or FERA program.



Rebates are offered through PG&E's backup power marketplace located at pge.com/backuppower.

> Over 100 customers have already taken advantage of the rebate.



## **Medical Baseline Program**

PG&E's Medical Baseline Program is an assistance program for residential customers who rely on power for certain medical conditions.

#### Assistance offered:

- Extra notifications in advance of a PSPS event, including inperson door knocks by a PG&E representative if positive contact has not been made
- A lower rate on monthly energy bills

#### **Examples of Qualifying Medical Conditions and Qualifications:**

- Asthma/Sleep Apnea
- Respirators
- **Multiple Sclerosis**
- Special Heating/Cooling Needs
- **IPPB/CPAP Machines**
- Hemodialysis Machine

#### **SUMMARY:**

Authorization is being requested from the City Council to record a lien on 1 individual property in Corning to secure payment of delinquent water and/or sewer fees. To date the total unpaid balance on this property is \$1,172.14. This property is scheduled for Public Internet Auction by the Tehama County Tax Collector on May 14 – 17, 2021.

#### **BACKGROUND:**

The Corning Municipal Code provides in Section 13, Section 13.04.430 (Sewer), and Section 13.08.150 (Water) that:

Section 13.04.430 (Sewer): Nonpayment of charges and fees shall result in disconnection of service. Any charge or rental levied by the City pursuant to this Chapter on any premises within the corporate limits of the City having a connection to the City sewerage System is made a lien upon the premises. The Director is authorized, and it shall be his duty, to disconnect any industrial sewer connection or domestic sewer connection on premises located either within the corporate limits of the City or outside the corporate limits of the City, upon failure of the person to whom such charge or rental is billed to pay such charge or rental prior to delinquency. (Ord. 541 (part), 1993); and

Section 13.08.150 (Water): Charges as lien-Nonpayment-disconnection. Any charge levied by the City by or pursuant to this Chapter or the Resolutions made pursuant to the authority hereof on any premises within the corporate limits of the City having a connection to the City Water Distribution System is made a lien upon premises. The water superintendent is authorized, and it shall be his duty to disconnect the water upon failure of the person to whom such charge or rental is billed to pay the charges as set forth in this Chapter. (Ord. 111 §20, 1953).

To avoid the additional loss of revenues through fees from Collection Agencies, Staff is seeking Council authority to lien this property in addition to the disconnection of service.

The grant program requires an equivalent funding match from the City (50/50 split) that will enable us to equip our people at a reduced cost to the City.

#### **BACKGROUND:**

In 2020 the Department received a VFA Grant in the amount of \$5,340 and including matching City funds, a total of \$10,680 which was used to purchase 3 fire shelters, 2 handheld radios, 2 Antennas, 4 Batteries, 5 Wildland gear, 2 dual position battery chargers, and 2 triangular radio harnesses.

#### **FUNDING:**

Staff proposes to use \$2,495 from the Safety Item/Fire Fund (001-6552-2300) as the City's 50% grant fund match. If approved, matching funds will be included in the 2021/2022 Budget.

#### **RECOMMENDATION:**
